The SY 2020-21 Bilingual Education Program Delivery Report has been available for completion in IWAS since May 17. Districts that received \$5,000 or more of state English Learners - Evidence-Based Funding for EL services and/or federal Title III Language Instruction Educational Program funds in FY 2021 MUST submit this report in IWAS no later than July 31. As a reminder, districts that are required to have a Bilingual Parent Advisory Committee (BPAC) must have the committee help review the EBF Spending Plan. # ACCESS TESTING - EARLY RESULTS FOR SPRING TESTING

Early ACCESS and Alternate ACCESS test results will be posted in the Student Information System (SIS) on August 2 for SY 2022 planning. These provisional results will include scores for ELs who completed all domains of the assessment by June 30. Paper test booklets that were not submitted to Data Recognition Corp. (DRC) by June 30 will not be included. Partial administrations or scores separated into multiple records will not be part of this early release. The ACCESS Preliminary Data Review, scheduled for November 8 to November 19, will include all results for SY 2021. ISBE will send ACCESS data corrections to DRC after the November review closes. Results, including corrections that require rescoring or merging records, will be available digitally December 15 in the WIDA Assessment Management System. They will be posted in SIS by January 19, 2022. Click here to see an FAQ concerning the release of scores and the effect on EL placement.

# ACCESS SCORE REPORTING INTERPRETATION RESOURCES

Now that the spring assessment window has passed and data is becoming available to those who have already tested, WIDA would like to remind districts of the many resources for practitioners and parents to understand what the results mean regarding a student's progress in English.

- Parent Communication: <u>ACCESS for ELLs Parent Letters</u>, now available in the same 47 languages as the ACCESS Individual Student Report (ISR), provide general information about the ACCESS assessment and are meant to be provided to parents or guardians alongside the ISR. The letters are available in Word format so that they can be customized at the local level as desired with local test administration information and state or district policy.
- Parent Communication: <u>ACCESS for ELLs:</u> <u>Understanding Your Child's Scores,</u> available in 13 languages, helps explain ACCESS scores and the ISR to families.
- Educators: ACCESS for ELLs Interpretive
  Guide for Score Reports and the Alternate
  ACCESS for ELLs Interpretive Guide for
  Score Reports provide an overview of the
  various types of score reports. These
  documents explain how scores are
  calculated, and how you can use proficiency
  level and scale scores to support your
  students' language growth.
