NEW! School districts who wish to administer the ACCESS for ELLs on paper in school year 2020 must submit a waiver request. This form is not required for paper test administrations for Kindergarten, to provide accommodations that require a paper mode administration to student with IEPs, to allow handwriting on paper for the Writing domain, or to administer the Alternate ACCESS. You may submit the ACCESS Waiver Application for Paper Mode Testing here.
