ACCESS for ELLs – New Report

WIDA has developed a new *Individual Student Report* for ACCESS for ELLs 2.0, Kindergarten ACCESS for ELLs, and Alternate ACCESS for ELLs. It's intended for both families and educators, folding the Student Report, Teacher Report, and Parent Report into a single document. One copy will be included in the report package sent to districts and schools on August 1st. Additional copies may be acquired as PDF files in WIDA-AMS. The reports to be sent out for 2016 are the

- Individual Student Report for Kindergarten
- Individual Student Report for Grades 1-12
- Parent-Guardian Report (Kindergarten only)
- Student Roster
- School Frequency Report
- District Frequency Report
