Please be advised that the deadline for submitting the FY16 Title III LIPLEPS and Immigrant Education Program budget amendments on IWAS is **July 31, 2016.** 

Districts that submit the amendment after the deadline will be rejected. The amendment has to be submitted to ISBE, and not just "Submitted for Review" to your district superintendent, so please check the status of your application on IWAS to make sure the submission has been completed.
