### FY20 CONSOLIDATED DISTRICT PLAN

As the first phase of the IL ePlan, the FY20 Consolidated District Plan (CDP) will be opening in eGMS (IWAS) on February 19, 2019. The CDP allows grantees to answer one set of planning questions and one set of GATA Program Risk Assessment questions to meet those requirements for 12 federal formula grants. The Title III LIEP and Immigrant Education grants will both be included in the CDP. Districts applying for Title III funds must complete both the Title III Intend to Apply and the CDP. To ensure that districts are properly supported in completing the CDP, ISBE will be hosting a live webinar for district administrators (details below). Please mark your calendars and join us!

# APPLICATIONS FOR THE EL - TITLE III INTENT TO APPLY ARE NOW AVAILABLE THROUGH IWAS!

Applications for the **EL - Title III Intent to Apply** system are now available for school year 2019-2020 (FY20). **The due date for the Intent to Apply application is March 1, 2019.** Only districts that plan to apply for FY20 federal Title III funding must submit the EL - Title III Intent to Apply. These districts will also be required to submit the Consolidated District Plan and the Title III Consolidated Application, available by May 2019, to complete the application for FY20 funds.

# PURPOSES FOR TITLE III FUNDS [20 U.S.C. 6825]:

- (1) Developing and implementing new language instruction educational programs and academic content instructional programs for English learners and immigrant children and youth.
- (2) Carrying out highly focused, innovative, locally designed activities to expand or enhance existing language instruction educational programs and academic content instructional programs for English learners and immigrant children and youth.
- (3) Implementing, within an individual school, school-wide programs for restructuring, reforming, and upgrading all language instruction educational programs and academic content instruction for English learners and immigrant children and youth.
- (4) Implementing agency-wide programs for restructuring, reforming, and upgrading all relevant programs, activities, and operations relating to language instruction educational programs and academic content instruction for English learners and immigrant children and youth.
- (5) Providing effective professional development to classroom teachers, principals, school leaders, administrators and other school or community-based organizational personnel including parent, family, and community engagement activities.

#### **REMINDERS FOR FY20:**

- 1. If the district wishes to apply for any Title III funds for which they are eligible in FY20, the Title III Intent to Apply **MUST** be created, completed and submitted by March 1, 2019.
- 2. Enrollment information is **NOT** included within the application. Districts should review their EL student enrollment data in SIS and add or correct enrollment data as necessary to accurately reflect their EL student enrollment totals and periods of service. Comparing the existing school year data to the enrollment data in SIS for school year 2017-2018 should provide a general indication of any discrepancies. Districts should also review the students marked eligible for the Immigrant Education Program in school year 2018-2019 on SIS. Immigrant education program funding will be based on the immigrant student count in the 2019-2020 school year.
- 3. Student enrollment information will be extracted from SIS on or about April 1, 2019, to calculate projected allocations for federal Title III LIPLEPS grants. All information should be accurate as of **March 29, 2019**.
- 4. The Intent to Apply application will collect information on program contact person, private school consultations and private school EL students.

Please make sure that your approval groups are properly assigned through IWAS in order to access and transmit your application. Technical assistance on items not covered by the instructions may be obtained from the Division of English Learners at (312) 814-3850.
