#### DELL New Leadership Workshop for EL Program Directors—August 3-4, 2015

#### Stay Tuned for upcoming invitation to participate in a Literacy Squared Professional Development Cohort.

Literacy Squared<sup>®</sup> is a comprehensive biliteracy program that has been designed to accelerate the development of biliteracy in Spanish-English speaking children attending schools in the U.S. The framework is based on three research-based concepts suggesting that the improvement of schooling for emerging bilingual children can be accomplished via programs that develop biliteracy through conducting literacy instruction in Spanish as well as English, attending to the quality of instruction, and planning instruction to include direct and explicit attention to cross-language connections. This means that the language of instruction for literacy includes both Spanish and English, and that instruction in these two languages is planned in purposeful and intentional ways to create trajectories toward biliteracy. The Literacy Squared model includes authentic instructional approaches in Spanish and English that respect and focus on the internal structures of each of the languages, emphasizing direct, explicit, and collaborative instruction is planned to include direct and explicit attention to cross-language connections, which enables children to learn how to use both of their languages in strategic ways to enhance their biliteracy development.

The Division of English Language Learning (DELL) at the Illinois State Board of Education (ISBE) is happy to offer an opportunity for districts to participate in an in-depth 10-session Literacy Squared Professional Development Cohort during the 2015-2016 school year. The purpose of the Literacy Squared Cohort is to use the train-the-trainer model (up to 2 participants from each district) to build local capacity to use and implement this program as a way to strengthen bilingual programs and promote biliteracy development among English learners.

After completing all 10 sessions (8 days face-to-face and 2 webinars), participants will be equipped with the knowledge and skills reflective of the Literacy Squared program components including: Research, Assessment, Professional Development, and Integration and Coordination of Fundamental Instruction.

## **Grants and Funding**

#### Title III (LIPLEPS and Immigrant Education Program) Amendment Deadline

Please remember that the deadline for submitting grant amendments for the federal Title III (LIPLEPS and Immigrant Education Program) funding is July 31, 2015.

Please remember that a district is only required to submit a budget amendment to the Division of English Language Learning if a new expenditure is added to the budget, if there is a significant change in a budget item's description, or any of the line items in those budgets change by either twenty percent (20%) or \$1,000, whichever is greater.

#### Fiscal—Expenditure Reports Deadlines

The final expenditure report for state TBE/TPI funding is July 20, 2015. All the obligated funds must be included in this expenditure report. There is no carryover for state TBE/TPI funds.

The final expenditure report for federal Title III (LIPLEPS and Immigrant Education Program) is due September 20, 2015. All the obligated funds must be included in this expenditure report.

### **Accountability and Monitoring**

#### 2015 Bilingual Education Program Delivery Report (PDR) Submission

The Bilingual Education Program Delivery Report (PDR) for the 2014-2015 school year was due on June 30, 2015. This report was required for all districts (304 districts in 2014-2015 school year) that received TBE/TPI funding in the 2014-2015 school year. Our records show that 26 districts still haven't submitted the report on IWAS as of today (July 16, 2015). These districts must submit their report as soon as possible or no later than July 31, 2015. The system will close at 11:59 PM on July 31, 2015.

ISBE will notify the 26 districts that didn't submit their 2014 Bilingual Education Program Delivery Report yet via e-mail.

#### Assessment

#### 2015 ACCESS for ELLs follow up

Illinois school districts are required to annually administer ACCESS for ELLs for all ELs, whether or not enrolled in English language education programs.

ISBE notified districts that have EL student(s) who didn't participate in 2015 ACCESS for ELLs or Alternate ACCESS for ELLs, and for whom there is no reason recorded in SIS explaining why the student didn't take the assessment. These districts are required to report a reason for not administering the assessment using Not Tested Reason (NTR) codes posted at <a href="http://www.isbe.net/sis/pdf/not\_testing.pdf">http://www.isbe.net/sis/pdf/not\_testing.pdf</a> in SIS by July 31, 2015.

ISBE has opened the Assessment Correction window for ACCESS for the districts. District that fail to do so during this time period will be contacted by ISBE. Specific instructions for the NTR submission have been provided in the notification via IWAS.

# U.S. Department of Education Releases Fourth Chapter of English Learner Tool Kit for State and Local Agencies

Tools and Resources for Providing English Learners Equal Access to Core Curricular and Extracurricular Programs, the fourth chapter of the English Learner (EL) Tool Kit, has been published online by the Office of English Language Acquisition (OELA), U.S. Department of Education (the Department). The Tool Kit is intended to help state and local education agencies (SEAs and LEAs) in meeting their obligations to ELs. It should be read in conjunction with the joint Dear Colleague Letter (DCL) on "English Learner Students and Limited English Proficient Parents" from the Department's Office for Civil Rights (OCR) and the Department of Justice (DOJ), published in January 2015, which outlines SEAs' and LEAs' legal obligations to ELs under civil rights laws and other federal requirements.
