The **ELL**- **TBE/TPI/Title III Intent to Apply** is now available through IWAS for school year 2016-2017 (FY17) since December 1, 2015. The due date for the Intent to Apply application is **January 29**, 2016.

Only districts that plan to apply for FY17 state TBE/TPI and federal Title III funding need to submit The **ELL** – **TBE/TPI/Title III Intent to Apply**. These districts will also be required to submit the ELL Consolidated application, available by May 2016, to complete the application for FY17 funds.

ACCESS for ELLs 2.0 Test Setup Window Opening: 12/17/2015- 2/12/2016

The WIDA Assessment Management System (WIDA AMS) Test Setup window for ACCESS for ELLs 2.0 will take place **Monday, December 7, 2015 – Friday, February 12, 2016**. District test coordinators will have the ability to view students in the system as well as to view and modify test sessions. If districts are testing using ACCESS for ELLs 2.0 online, they must make sure that students are entered in appropriate test sessions.

Students, for whom Pre-ID data was submitted, will automatically be placed into generic test sessions based on grade cluster and domain. From the Test Sessions window, districts can show all the test sessions for a specific district or school. The window displays the status of the test session – Not Started, In Progress, or Completed.

Accommodations/Support Options for ACCESS for ELLs 2.0

There are a number of ACCESS 2.0 accommodations available to English Learners who have IEPs. The following five accommodations need to be arranged prior to testing. Those accommodations for paper should be ordered in WIDA-AMS during the test materials ordering window. The online accommodations can be turned on in WIDA-AMS any time prior to the test administration after ISBE has uploaded the Pre-ID file to DRC (November 13, 2015). Note that test tickets for the online format should be created *after* selecting these accommodations in WIDA-AMS.

ACCESS for ELLs	Retraining requirements for test administrators who previously certified	Training requirements for new test administrators
ACCESS for ELLs 2.0 Paper (Grade 1-12)	Retraining is not required for listening, reading and writing, but must complete the training and quiz for Speaking.	
ACCESS for ELLs 2.0 Online (Grade 1-12)	Retraining is required for all four domains. There is no quiz for the online test training.	Anyone training to administer test for the first time must complete all required trainings.
Kindergarten ACCESS for ELLs	Retraining is not required.	
Alternate ACCESS (Grade 1-12)	Retraining is not required.
