Please be advised that the deadline for submitting the FY17 TBE/TPI LIPLEPS grant to ISBE via IWAS is **June 30, 2016.**

Districts that submit the application after the deadline may not be eligible for Title III LIPLEPS or Immigrant Education Program funding. The application has to be submitted to ISBE, and not just

"Submitted for Review" to your district superintendent, so please check the status of your application on IWAS to make sure the submission has been completed.

We anticipate that districts will have to complete additional information after submittal of the grant application to fulfill the new GATA requirements. We will notify you of these requirements once they become available.
