We seek information related to only three racial/ethnic subgroups: "Hispanic or Latino" (Code 11), "Black or African American" (Code: 14) and "White" (Code: 16). This ensures that no one will be able to indirectly access FERPA-protected information by engaging in recovery techniques to discern suppressed data values. By asking for data only at the state and district level, supplying the requested public records will not expose any personally identifiable information protected under 20 U.S.C. 1232g(b)(4)(A) ("Family Educational and Privacy Rights"). If the cell size for any one of the three racial/ethnic subgroups requested is between 1 and 9, we understand that the information for that subgroup will be redacted but the information for the other two subgroups should still be provided.
