Dear Ms. Koriakin and Ms. Chafouleas:

This letter is in response to your request for information under the Illinois Freedom of Information Act. Your request was received on Nov. 29, 2016.

You have requested the following *for the 2011-2012, 2012-2013, and the 2015-2016 school years*:

*1. Least Restrictive Environment: the percent of children with individualized education programs (IEPs) aged 6 through 21 served:*

- a. Inside the regular class 80% or more of the day;*
- b. Inside the regular class less than 40% of the day; and*
- c. In separate schools, residential facilities, or homebound/hospital placements*

*2. Emotional/Behavioral Disturbance/Disorder (EBD):*

- d. Total number of students receiving special education programs and services with a diagnosis of Emotional/Behavioral Disturbance/Disability*
- e. The total number of students with receiving special education services*
- f. The total number of students enrolled in the district*
