Report of the Superintendent's Student Advisory Council (SSAC)

Report of the Superintendent

Superintendent Culver reported that the \$19 million appeal was granted by the judge. However, the U.S Department of Education has filed an appeal, extending the date for the release of funds. The Department of Funding and Disbursements has been contacted for correct disbursement dates. Meetings with the bonds counsel has been scheduled to discuss funding for the capital projects which are already in progress. An extension may be necessary to ensure all projects are completed by the anticipated dates.

District Buildings & Grounds (B&G) Report

Director Joseph Haskell reported that B&G is focused on the closing of work tickets and getting buildings ready for the opening of the upcoming school year. Flooring will be installed in buildings that will not host summer school. One of the main focuses is to make sure that the HVAC units are all functioning by the first week of August to prevent interruption of instructional time. The ongoing CTE project, cafeteria remodel and auditorium project are in progress. Designs have been reworked to keep cost low. A bid is out to have parking lots restriped and black topped for general maintenance. The softball and baseball fields are in the designing phase.

- Panel member asked about the sewer issue on Northside of the building. There was a break in the water main during the CTE renovation but was covered under the contractor's insurance policy. Damages have been repaired at no cost to the district.

District Finance Report

CSBO Delfaye Jason provided a brief update on the Comparative Analysis Finance Report

- Revenue was \$121 million vs \$129 million last year.
- Expenditures \$ 120 million vs \$107 million last year.

CSBO Jason reported that 93% of the revenue has been received and used 84% of expenses has been used. Teacher salaries will reflect in the remaining balance of expenses.

Responses to Panel Questions

Chief of Schools Keisa Garrett reported that approximately 800 students participated in the summer school program. Other than a few absences due to extreme temperatures, summer enrollments at the high school level reached an all-time high. Other summer programs offered within the district include The PAWS Academy and the Thundercat Academy. An additional 100+ students were in participation. Both Title and District Funds have been instrumental in sustaining the summer programs. KHW, AO, MCMS, ESLHS, and GB Alternative are all in the process of receiving HVAC renovations. To make up for lost instructional time, several 6th, 7th and 8th grade students from WYSOE were able to attend the summer camp at the high school. Students also attended for enrichment, earn Algebra credit and prepare for Geometry.

- Panel member asked if the lunch programs were available throughout the summer.
Yes, but community participation is low.
- Panel member asked what measures are being taken to improve enrollment and participation with the summer programs. Enrollment is good at most facilities. There has been a significant increase of enrollments at James Avant of second language families. Multiple project homes have been eliminated and families who remain enrolled in section 8 housing are now spread over the metro east community. Various programs and activities are on the table to encourage participation in the summer activities.
- Panel member asked if SIUE Charter receives state-aid for enrollment
State aid pays up to 104 enrollments. SIUE Charter typically remains under the cap of 120
