#### 1. CALL TO ORDER / ROLL CALL

Dora King, Chairman called the meeting to order at 6:30 p.m. Members present: Ms. Dora King, Ms. Evelyn Alexander, Mr. Graham Cook, Ms. Shajuana Goshton, Mr. Jerry Hieb, and Chief Frankie Garrett Member absent: Master Chief Walter Evans

## 3. Motion to Convene a Public Hearing as Advertised to Discuss Reductions in Force

At 6:35 p.m. Ms. King called for a motion to open the Public Hearing to discuss Reductions in Force. Mr. Hieb motioned and Mr. Graham seconded the motion. **Motion passed 5 – 0.** 

#### **Public Comments:**

Alderman Bonny Mayfield – Asked Dr. Martindale to comment on how the reduction of teachers would affect class sizes.

Mr. Keith Turner - How do the class sizes after the reduction compare to the pre-reduction class sizes? Have there been any reductions ahead of this proposed action this year? What is the catalyst for making the decision to reduce force? Regarding school closures- what will be the approximate savings in costs? When are the proposed cuts going into effect?

Ms. Natasha Pierce – Asked for an explanation of how the reduction process was determined as one of the targeted teachers being dismissed. Martha Gutierrez offered to meet privately with Ms. Pierce to further clarify her concerns.

#### 4. Motion to Adjourn Public Hearing

At 6:45 p.m. a motion was called for to adjourn the Public Hearing on Reductions in Force. Mr. Hieb motioned and Ms. Alexander seconded. **Motion passed 5 – 0**.

#### 5. Audience Participation

Ms. Betty Harris – Concerned citizen and substitute teacher who is advocating for the children of this district. She is opposed to what is going on with the closing of schools and reduction in force. Mr. Keith Turner – Where did the money go that created the deficit?

# 6. Chief Education Officer Report – Dr. Ben Martindale

- Dr. Martindale met with the Dept. of Education in Washington, DC earlier this week and also representative from Senator Kirk's office; was joined by State Superintendent
- District 187 will be able to utilize the Receipt of Elevated Impact 8 funds for at least another 3 years
- Insurance costs for HMOs will decrease this year; PPO costs will slightly increase by .20%
- The girls and boys basketball teams will be recognized at the April Board meeting
- The Board needs to settle on a date to meet with Barb Toney as soon as possible

**C. Discussion/Action** – Approval of Transportation Bids

There were seven (7) bids and the lowest bid came in from Lakeside Bus Company at \$1.5M average annual which is \$340,000 savings over the current costs. District 187 will enter into a three (3) year contract with two (2) annual renewals.

A motion to approve the Transportation Bids was motioned by Mr. Hieb and seconded by Mr. Cook. **Motion passed 5 – 0.** 

#### D. Discussion/Action – Operational Services Accounting and Audits Policy 4.80

A motion to approve the Operational Services Accounting and Audits Policy 4.80 was motioned by Mr. Hieb and seconded by Mr. Cook. **Motion passed 5 – 0.** 

This policy will allow more efficiency in the disposal of school material and equipment.

## A. Discussion/Action – Center for Educational Leadership Agreement

A motion to approve the Center for Educational Leadership Agreement was motioned by Ms. Alexander and seconded by Ms. Goshton. **Motion passed 5 – 0.** 

This group comes very highly recommended for the leadership development work they do all over the country. All principals will take this training and evaluations will be done to show the effectiveness.

#### B. Action - Approve Summer Youth Employment Program Agreement

A motion to approve the Summer Youth Employment Program Agreement was motioned by Ms. Goshton and seconded by Mr. Hieb. **Motion passed 5 – 0.** 

Financial support comes from Lake County Workforce Development and students come from disadvantaged high school students. Jobs include maintenance, office/clerical training and other opportunities.
