#### Call to Order

# Else Hamayan

Following introductions, chair Else Hamayan welcomed the council and called the meeting to order at 9:45 a.m. David Barker moved that the minutes from the June 9, 2005 BAC meeting be approved. Maria Korkatsch seconded the motion and the minutes were unanimously approved 15-0 without abstensions.

#### Robin M. Lisboa

Division administrator, Robin M. Lisboa briefed the council on a number of items including: the <u>Student Identification System (SIS)</u>, <u>ACCESS for ELLs</u> Screener, ACCESS for ELLs special education accommodations, planned meetings with IHE on ACCESS for ELLs Standards, ISBE's <u>Comprehensive Strategic Plan for Elementary and Secondary Education</u>, the <u>Visiting Teacher Exchange Program with Spain</u>, <u>Title III Accountability</u>, ISBE's <u>rules concerning bilingual education</u>, and the Illinois Continuum on early childhood education for ELLs. Following ISBE's presentation, the council members volunteered to the actions listed below.

Ngoc Diep, Nguyen, Maritza Guilamo, Carmen Acevedo, and Raj Balu agreed to volunteer to provide ISBE DELL with feedback on Title III accountability.

Alonzo Rivas and Melissa Wolf agreed to provide ISBE DELL with feedback on the rules and proposed changes.

Robin M. Lisboa agreed to develop a timeline for reviewing rules that would allow the BAC ample time to consider proposed changes prior to public comment.

Harriette Herrera agreed to provide talking points to ISBE DELL on early childhood issues by the close of business on 9/29/05.

# Membership and Committees Chair and Council

In council business, Else Hamayan resigned as chair of the advisory council. Kim Zinman moved to accept the resignation. Pat Chamberlain seconded the motion and the council voted 15-0 to accept the chairs' resignation.

David Barker accepted the nomination and the council voted 15-0 to make David Barker BAC chair effective immediately. No action was taken on vice chair of BAC. MT Garreton will stay on as vice chair of the BAC.
