ISBE Assessment Update

Becky Mc Cabe

Becky Mc Cabe briefed the council on the challenges presented by the implementation of recent assessments: ISAT, IMAGE, and ACCESS. She indicated that:

- ISBE was aggressively holding high level meetings
- ISBE was hiring a team to check scoring
- ISBE was addressing the delivery of tests
- ISBE was addressing questions of validity
- ISBE Assessment was responding to more than 7000 emails
- developing side studies for IMAGE
- piloting an IMAGE science test
- executing an alignment through ILEAC
- beginning a period of review for ACCESS
- surveying educators to review ACCESS test window
- meeting with executive committee of WIDA
- working on an alternative assessment for special education group
- bidding writing contract out

ISBE DELL Update

Robin M. Lisboa

Robin acknowledged Becky Mc Cabe's hard work and then briefed the council on ISBE DELL personnel changes listed below.

Robin indicated that Joyce Pate had retired. Michael Lugo would now serve as her support person. Cathy Jackson Huntley has been transferred to ROE Services with Jeff Aranowski. Carolina Mata Woodruff will be out until June 2006.

Districts not meeting AMAOs will have an opportunity to attend a 1/2 workshop on April 20 or 21, 2006. Approximately 45 districts did not make AMAOs for two consecutive years.

250 of 275 districts have signed up for FY07 Consolidated Workshops to Serve ELLs. The workshops will cover the application and an assortment of other relevant topics. No major changes in the application are expected.

The issue of AMAOs connected to funding cooperatives will be addressed at the June 8, 2006 meeting.

ISBE Staffer Lilibeth Gumia indicated that Gail Lieberman of ISBE was still taking AMAO appeals.

Robin encouraged members to register parents for the BAC Parent Summit on May 20, 2006. ISBE will reimburse districts for up to 5 parents. Payment for additional parents shall be the responsibility of local districts. Dual language parents are invited to attend. Superintendent Randy Dunn, ISBE Board Chair Jesse Ruiz, and Wong Fillmore will highlight the event. The deadline to register parents is May 5, 2006.

ISBE Administrative Rules, 228

Irma Snopek & Sally Vogl

Irma Snopek and Sally Vogl reviewed a draft of Administrative Rules, Part 228 as a result of input from BAC on March 14 & 23, 2006. Following a review of more than 125 individual changes, Sally discussed the next steps along with the BAC's ex parte communication responsibility. Vogl outlined a period of public comment and suggested rules could be adopted by November 2006. Vogl elaborated on the three types of ex parte communication:

1. Email: To be forwarded to Sally Vogl at rules@isbe.net
2. Letters: To be mailed to Vogl.
3. Oral stories. Use ex parte form.

Sally indicated that the purpose of the ex parte forms was to capture information for the public record.
