The position for a permanent Agriculture Consultant Position is still posted and will be open until filled. Ideas were shared about how to get more applicants to apply. Marci explained the ED360 project as a resource portal provided to school districts and teachers. 552 districts have opted to enroll in ED360. Marci and Dan will be looking at how many teachers have logged in. They will also be looking at how the myCAERT lesson plans and resources could be added. Perkins 5 has been reauthorized.
