SLDS Status

Project

- Status calls and reporting with U.S. Dept of Education bimonthly
- Data Advisory Committee
 - Quarterly meetings scheduled as needed
- Enterprise-wide Data Architecture
 - Completed final review of the project deliverables will publish links for public access
 - Architecture provides guidance for building of data warehouse, and the processing needed to populate database
 - Investigating a metadata management tool will assist in making the information publicly accessible
- Data Stewardship
 - Analysis and data quality improvement activities ongoing
 - Data stewards are providing additional updates as needed

SLDS Status

Education Enterprise Data Warehouse

- PCG will be building warehouse, based on State Core Model
- Data profiling and design is underway
- Targeting Summer 2012 for go-live
- Includes reporting portal, 14 existing reports
- Linking of ISBE data with Postsecondary and Employment Data, and use this data for Research and Analysis
 - Higher Ed adding SID to support data linking
 - High School Feedback Report made public
 - Higher Education Consortium (IHEC)
 - Establishing a research agenda
- Overall
 - Schedule targeting for data warehouse construction for one year
 - Under original spend plan


SLDS Expansion Grant (ARRA) Status

- Establish a Statewide Transcript System for Middle and High School Students
 - Statewide Course Classification System in production for High Schools, implementation for middle schools 2011-2012 school year
 - Course collection processes in production for High Schools, implementation for middle schools 2011-2012 school year
 - IGA with ISAC for transcript tool Docufide
 - To be available for all high schools and colleges
 - Intent is to transmit ISBE Student ID, statewide course codes
- Integrate Student-level Data with Teacher and Administrator Data
 - Vendor selected for the rewrite of teacher systems, targeted for one year implementation
 - SIS vendor adding capability to collect data that will link students and teachers, will be in production for the 2011-2012 school year

SLDS Expansion Grant (ARRA) Status

- Continued Expansion and Development of Postsecondary Education Data Systems
 - Working with Postsecondary partners (ICCB, IBHE)
 - Intergovernmental agreement in place for IBHE and ICCB
- Expansion of Early Childhood Data Collection Systems
 - Expansion of data collection to be implemented 8/1/2011 for 2011 2012 school year
- Overall
 - All components are underway, course data collection is earlier than planned, teacher rewrite, higher education work behind original schedule
 - Under original spend plan
