CALL TO ORDER

The meeting was called to order at 1:02 p.m. by Chair Boyd Fergurson and roll was taken.

Satu Allen presented an appeal from Jewish Child and Family Services based on Sections 900.342 (a)(1), (2), (3) and (5) of the IPCRB Rules. Chris Dirks moved to approve the appeal; Tracy Morgan seconded. The motion passed and the appeal rates of \$261.79 for program #079 and \$397.52 for program #227 were approved.

Satu Allen presented an appeal from Northern Illinois Academy based on Section 900.342 (a)(5) of the IPCRB Rules. Northern Illinois Academy wished to add an intensive one-on-one capability to the room

and board program #557 and #568. Intensive one-on-one program personnel would also be removed from program #561. Chris Dirks moved to approve the appeal; Tracy Morgan seconded. The motion passed and the following appeal rates were approved:

Roger Thompson moved to approve the appeal; Rhonda Davis seconded. The motion passed and the appeal rate of \$171.02 for program #235 was approved.
