## **NEW BUSINESS**:

## Introduction of Mike Slife – Tim Imler/Mike Slife

### FY15 Transportation Appropriations – Tim Imler

Transportation transfer to Regional Vocational Transportation was approved by Board. Truant/Regional Safe School – level funded Special Ed Personnel Orphanage – 100% Special Ed Transportation – 97% Regular Vocational Transportation – level-funded 205.8 million Anticipated proration 72% - Claims filed by August 15<sup>th</sup>-1<sup>st</sup> payment in September Revenue projections increase from 15% to 17.9 million.

### Legislation – Tim Imler

SB16 – An all-in formula, weighted amount.
SB 928 – K-8 curriculum trips; Private Special Ed facilities requested.
HB 4612 – Study to see if a co op of transportation service saves money for the districts and also the state and carry that savings back to the districts.

### Part 456 – Cathy Allen

Cathy discussed a few updates for the Non-Scheduled Bus Inspections, which became effective 6-4-14. MFSAB changes are highlighted on page 2. Out of service penalty updates can be found on page 10 (j). Everyone received a copy of the law.

### ROE procedures for school bus driver training – Mike Slife

Discussed giving dvds to ROE areas and they can share within their area.

Training dates/locations: June 16<sup>th</sup> in Peoria with 58 registered. June 23<sup>rd</sup> in Peotone with 30 registered, and June 30<sup>th</sup> in Effingham with 25 registered. Mike has also revised the evaluation form. There will be four presenters discussing the following topics; How to Train Aggressive Driving; Special Needs; School Bus Evacuation.

# School Bus Driver Training Curriculum Updated –Mike Slife

Mike is currently working on the updates and will send a draft to the board members for feedback/suggestions.

#### **Other Business – Tim Imler**

Kevin Duesterhaus stated that 97% of CDL medical card code corrections have been submitted. Kevin also re-stated that drivers that are going to drive division 1 vehicles must take the driving test in the Division 1 vehicle they will be driving for the company. Fingerprint documentation will need to be turned in within 90 days. It will become the expense of the district to have them redone if after the 90 days. Kevin also stated that the Illinois State Police were helpful to work with.
