IDEA Part B Application and Award Packet for FFY21 SFY21

On January 24th, we received notice of the FFY20 IDEA Part B Application and Award. The application is due to OSEP on May 15th. It will be posted on our website for the required 60 days beginning on March 1. The required 30 days comments can be submitted from April 1st through May 1st.

The FFY 20 award is \$549,779,217. This is an increase of \$15,678,399 from FFY19.

\$469,661,567 will go directly to school districts as flow-through grants, for an increase of \$14,512,646 going directly to school districts from FFY 19 to FFY 20.

\$11,329,836 is allocated for state agency administration and \$54,275,168 is allocated for other state set-aside activities.

Half of the state agency administration and other state set-aside activities go toward Room and Board cost as directed by Illinois School Code. That amount is \$32,802,502.

The remaining other state set-aside funds totaling \$27,137,584 will be used for the following activities.

- For monitoring, enforcement, and complaint investigations, including Due Process Hearing Officers
- To implement the mediation process
- For support and direct services, technical assistance, and professional development, including IEP data collection and other data reporting supports
- To assist LEAs in providing positive behavioral interventions
- To assist LEAs in meeting personnel shortages
- To support for paperwork reduction activities, including IEP data collection and other data reporting
- To support the use of assistive technology
- For development and implementation of transition programs
- To support alternative programming and services for students in correctional facilities
- To support the provision of alternate assessments
