III. Illinois State Board of Education Update

Update on Various Topics – Dave Andel, Division Administrator, Special Education Services Division

Integrated Monitoring

Staff is gathering information from the 49 states and territories regarding this monitoring process which is being promoted by OSEP. The integration of the 17 Performance Indicators and compliance by means of the IEP development are being worked on.

- File Review Project expanding the review of IEPs to be inclusive of the entire process and document
- Process for integrated monitoring creating a framework for integrated monitoring which would include several preliminary activities and events which would determine whether an onsite visit is necessary
- Professional Support based on the review (desk audit and/or onsite visit) a
 process to support the district or school in 299 with professional support related
 to the area established through the integrated monitoring process that we could
 support through professional learning
- Review of the Evaluation Process (Initial and Three Year) developing a
 document to evaluate through a desk audit if these processes at the local level
 are in compliance with federal and state regulations

RDA/LRE Data Cohort

- LRE Data Cohort VI will finish in December. There are 10 districts throughout the state that have participating, and they have shown a cumulative improvement of 2.5% of students being place in EE01.
- RDA/LRE Cohort VII The Cohort process is being realigned to incorporate the Result-drive Accountability (RDA) process being promoted by OSEP.
 - Districts forming Cohort 7 in December 2016 will follow this paradigm as a foundation for the yearlong study and long range planning
 - There are a total of nine districts that have committed to Cohort VII. Training sites will be held North at the Crowne Plaza located in Glen Ellyn the first week in December for seven districts and for South/Central at the Crowne Plaza Springfield the second week in December for two districts.

Special Education Profiles

FY 2014-2015 and FY 2015-2016 Special Education Profiles are completed. The profile will be sent out to districts for a verification period on IWAS. They will then be posted in a PDF format on the School Report Card site. Northern Illinois University is working to incorporate the necessary components of the Special Education District Profiles into the school report card for the FY 2017-18 school year.

Indicator 13 – Secondary Transition

12 districts reporting 100% compliance for Indicator 13 were randomly selected. These randomly selected districts were then required to submit up to 20 IEPs: 15 IEPs of district students whose ages are 16 and above (to meet federal requirements) and 5 IEPs of students whose ages are 14 $\frac{1}{2}$ - 16 (to meet state requirements). Official letters to the randomly selected districts was sent out Aug. 26, 2016. ISBE principal consultants then reviewed the IEPs/transition plans and issued letters of findings to all 12 districts on Oct.28, 2016.

There were also 16 districts that only had noncompliance for rubric questions 8r - 8t (outside agency representation). These districts received a reprieve letter for this year.

The LEA's who did not report 100% compliance were also issued letters of findings on Oct. 28, 2016. Currently, there are 9 districts for the 14.5 age group that are non-compliant and 4 districts for the 16 and up age group districts, including Chicago 299. They will then follow the same procedures as the districts who had reported 100% compliance, until the non-compliance has been rectified.

FY17 IDEA Excess Cost

 We encourage districts to complete and submit the IDEA excess cost worksheets. The excess cost worksheets can be emailed to the IDEA grant coordinators as early as December 1, 2016 and no later than January 31, 2017.

- Cooperatives and Member Districts The IDEA excess cost expenditure
 detail report form has been eliminated. The IDEA excess cost excel
 worksheet collects district expenditure data from the district AFR. Expenditures
 made by the cooperatives and reported in the cooperative AFRs are not needed
 in the IDEA excess cost worksheet. While previous excess cost worksheets
 collected IDEA expenditures made by cooperatives, 100% of those costs were
 later subtracted as part of the calculation. The excess cost expenditure detail
 report form was eliminated to avoid unnecessary work for the cooperatives and
 member districts.
- Changes were made to the Excess Cost Check (Section H) to ensure that
 districts receive credit for their state/local special education expenditures. Do not
 be alarmed if the positive comparison is larger than in previous years, that is
 expected (not an error) when the excel worksheet includes the state/local special
 education expenditures in the final calculation.

Assessment Updates:

General Information:

- The Pre-IDs for all assessments is currently available for districts to access.
- Information pertaining to the specific assessment can be found on the ISBE website with up to date information.
- Districts also need to identify the students in the correct testing school location to ensure that the testing schools are/will be receiving the material for assessments.

PARCC

- The accommodation form for both computer-based and paper are in the final edits.
- Those forms will be posted to the special education page under IEP forms.
- Students in grades 3-8 will be assessed via PARCC.
- All 3rd graders are defaulted to PARCC. If there is a 3rd grader incorrectly identified for this assessment, then the home district is responsible for correcting that error.

DLM-AA

- Student uploads have begun into Educator Portal.
- Testing schools should begin to roster the students for ELA and Math (3-8 and 11) and Science (5, 8, 11) for the upcoming spring assessment.
- Districts are able to complete instructionally embedded assessments now till December 16.
- DLM has provided videos on how to begin the process of making an Instructional
 Tool Plan to assess students through Instructionally Embedded. Those videos
 can be found on the DLM Illinois webpage under Educator Resources.

SAT

- Districts should be receiving their AI codes.
- Districts need to identify a Supervisor of Students with Disabilities coordinator (SSD coordinator).
- SSD coordinator should be working on completing accommodations requests for students with a disability.
- The accommodations for SAT will be posted to the special education page on the ISBE website.
- The SAT accommodations document is just an informational document to help drive discussion at the IEP table it is not one that needs to be attached to the IEP. It will provide information with regards to what accommodations are considered college reportable (will receive a score for accountability and a score for college reporting) or state allowed (will receive a score for accountability, but not for college reporting)

Safe & Supportive Schools (Trauma-informed Practices) Workshop dates

Staff has been working with the ROE Association and scheduled a few Trauma trainings in the Northern, Central and Southern Regions of the state. The attached Plan has the dates for each training. Flyers are being developed now by IARSS with registration information. When they are finalized, they will be posted to the Special Education list-serv.

We wanted to get these dates on everyone's radar since we've had so many individuals requesting Trauma-informed practice info. Due to capacity, we will only offer the Overview and Systems Planning sessions in the three (3) identified locations. A Northern and Southern location will be added soon for the book study Trainer of Trainers session.
