## Nutrition at the Capitol

### Lt. Gov. and ISBE Staff Talk Summer Meals and Breakfast

**I**SBE Nutrition and Wellness Program Division staff joined Lt. Gov. Evelyn Sanguinetti on Thursday, March 9, for a Breakfast Briefing at the Illinois State Capitol Building to speak about the importance of [Child Nutrition Programs](#). The Illinois Commission to End Hunger, [IL No Kid Hungry](#), and other partners from around the state were also on hand to promote the fight to end childhood hunger.

Amy Bianco, coordinator of [ISBE's Summer Food Service Program](#) (SFSP), spoke to lawmakers and others in attendance about the need for additional SFSP feeding sites across the state in order to provide healthy meals to children when school is not in session. Many children rely on free and reduced-priced meals during the school year but do not have access to healthy meals when school is out for the summer. SFSP steps in to help fight hunger during the summer months.

# Summer Around the Corner

## SFSP Plans Trainings for New and Current Sponsors, Seeks Sites

**S**pring is in the air and that means summer break is just around the corner for Illinois schoolchildren. Many children rely on free and reduced priced meals during the school year but do not have access to healthy meals when school is out for the summer. The Summer Food Service Program (SFSP), also known as Summer Meals, steps in to help fight hunger during the summer months.

ISBE's SFSP staff is busy preparing new sponsors and is always on the search for new feeding sites. School districts, local governments, and nonprofits can sponsor SFSP sites, housing the summer food programs at schools, parks, recreation centers, housing projects, migrant centers, churches, summer camps, and other locations.

ISBE, which administers SFSP in Illinois, will hold three more **new sponsor training options** this month.

- **April 12** – Peoria
- **April 19** – Schaumburg
- **April 26** – Fairview Heights


This training is for new sponsors and meets requirements

as annual current sponsor training. Attendance is mandatory for sponsors in their first or second year of SFSP and is recommended for current sponsors. See our [2017 New Sponsor Workshop Information document](#) and the [registration page](#) online for more information.

The **"2017 Current Sponsor Webinar"** is scheduled for 1-4 p.m. April 5. This webinar is for the experienced sponsor who has been participating in the program for two or more years. New policy changes along with key application and claiming issues will be covered. Insight into preparing the budget and menu selection are also on the agenda of this workshop. On April 27, an **SFSP training for current sponsors** will be held in Fairview Heights. This training is also for current sponsors with more than 2 years in SFSP. This half-day training meets the requirement for annual training. (Sponsors who were new in 2016 must attend a full-day training.)

## Don't Forget to Place Your Annual USDA Foods Order

**T**his message is for schools that have not placed their School Year 2018 annual USDA Foods order.

To verify if you have placed your order, login to ICS, click on "Annual Order Forms," then "Annual USDA Foods Order Form." If there are any dollar values in the PAL Processing Deduction, DoD, or Value of USDA Foods Requested fields, you have placed an order.



If you have not placed your annual USDA Foods order for SY18, please do so at your earliest convenience. The annual order period took place from Jan. 5 through Feb. 20. You can still designate money for the Department of Defense Fresh Fruits and Vegetables Program through June 15, 2017. We would appreciate if you would place your USDA Foods order as soon as possible. The Division to Processor form is no longer an

option. You must be approved in NSLP to be eligible for this program.

## Make Sure Everyone on Your Staff is Getting Our Monthly Newsletter



The authorized representative must be the individual that is legally and financially responsible for the administration of the entire school district and is used by all divisions of the Illinois State Board of Education.

If you have an update to the individual that is legally and financially responsible for the district you will want to change that information through the [Entity Profile System](#).

The other contacts can be edited in WINS by clicking the edit icon above the current names listed.

## Reminder for Those Who Signed Up for Mosaic Back of the House Software

## FFVP Application Now Online

**T**he [Fresh Fruit and Vegetable Program \(FFVP\) application for School Year 2017-18](#) is available. **Carefully review the application for all of the FFVP program requirements.** All elementary schools (grades 8 and below) that participate in the National School Lunch Program and have 100 percent of their students eligible for free and reduced price meals are eligible to apply. The USDA requires highest priority be given to schools with the highest percentage of low-income students. Due to the number of elementary schools in Illinois at 100 percent free and reduced price eligibility and that there was not enough funding the prior year to cover all schools that applied at that level, this application is being released only to elementary schools with 100 percent free and reduced price eligibility based upon October 2016 eligibility data.

If unable to fund all schools that apply with 100 percent free and reduced price eligibility, the enrollment based on October 2016 eligibility data will be the deciding factor, with the smaller enrollment number being awarded. If funds remain after awarding under this application release, an additional application will be released for additional schools to apply. **The deadline to apply is April 14.**

The purpose of FFVP is to increase fresh fruit and vegetable consumption in elementary schools participating in NSLP. FFVP funds are used to provide fresh fruits and vegetables to children at no cost, during the school day outside of the reimbursable meal(s) periods. **This program is different from the Department of Defense Fresh Fruit and Vegetable Program**, which allocates USDA Foods planned assistance level (pal) monies so that schools may acquire fresh fruits and vegetable to use during the service of reimbursable meals to students (breakfast and lunch). ## CEP Applications Available

**C**ommunity Eligibility Provision (CEP) provides schools that participate in the National School Lunch Program (NSLP) and participate in or are initiating a School Breakfast Program (SBP) for the 2017-18 school year with an alternative method for counting and claiming student meals in high poverty local educational agencies (LEAs).

LEAs electing to participate in CEP agree to serve all students lunches AND breakfasts and no charge for four successive school years. **Those that wish to participate in CEP for SY 2017-18 must have the CEP Agreement, CEP Participation Listing, and supporting documentation to the Illinois State Board of Education (ISBE), Nutrition and Wellness Programs Division no later than June 30, 2017.**

Enrollment and identified student data must be as of April 3, 2017 (As April 1, 2017 is on a weekend). Evaluation worksheets are also available so that you can determine if CEP is the right choice for your schools. Complete information is available [online](#). ## ‘Unpaid Meal Charges: Local Charge Policy Requirement’ Webinar April 4

The U.S. Department of Agriculture Food and Nutrition Service (FNS) will hold a webinar on **“Unpaid Meal Charges: Local Charge Policy Requirement”** 1:30-2:30 p.m. Tuesday, April 4.

**No later than July 1, 2017, all school food authorities (SFAs) operating the National School Lunch Program and/or School Breakfast Program must have a written local charge policy in place** to address situations where children participating at the reduced price or paid rate do not have money to cover the cost of a meal at the time of the meal service. SFAs have discretion in developing the specifics of their policies, and FNS expects charge policies will vary based on local circumstances and available resources.

This webinar will provide an overview of the local charge policy requirement and share best practices for successful policy

development. Participants will have the opportunity to submit questions during the Q&A portion of the webinar. [Click here to register](#).

## Fuel Up to Play 60 School Nutrition Equipment Grant Deadline April 28

**C**alling all School Nutrition Directors! Midwest Dairy Council is happy to announce that the 2017 Fuel Up to Play 60 School Nutrition Equipment Grant application is now available on [FuelUpToPlay60.com](http://FuelUpToPlay60.com).

School nutrition directors can apply for up to \$5,000 per school to purchase equipment that will enhance the long-term implementation of their school meal programs.

Preference will be given to applicants addressing the increase of school breakfast participation by expanding breakfast service outside the cafeteria and Breakfast After the Bell program.



Applicants are encouraged to request large or small scale items, such as breakfast in the classroom equipment (i.e. insulated bags, transport carts, wagons, etc.) or grab and go/second chance breakfast equipment (i.e. carts, POSs, portable milk coolers, etc.).

School nutrition directors can apply for up to three schools per district. Applications are due by April 28, 2017.

## SFAs Must Submit Procurement Procedures and Code of Conduct Documents by May 31

**T**he Illinois State Board of Education is required to monitor School Food Authorities (SFAs) to ensure purchases meet federal procurement statutes/executive orders, and ensure federal regulations are followed as outline in 7 CFR 210.21(c) and 2 CFR part 200.

As a pre-review step, SFAs are required to update their Code of Conduct for financial procurement and develop detailed Procurement Procedures as required in 2 CFR part 200.

The [Illinois Association of School Boards](#) have provided examples of acceptable Code of Conduct and detailed Procurement Procedures in the March issue of PRESS. Please contact IASB to inquire about a copy.

A letter will be sent to all School Food Authorities in early April with a financial questionnaire to be completed and requesting updated copies of the Code of Conduct and detailed Procurement Procedures be submitted to ISBE by May 31, 2017.

## Deadline Reminder: Comment Period for Donated Foods Proposal

**T**he U.S. Department of Agriculture's Food and Nutrition Service (FNS) published a proposed rule in the Federal Register, "**Revisions and Clarifications in Requirements for the Processing of Donated Foods**," on Jan. 5. The deadline for public comments was originally set for March 6. The comment period for this proposed rule has been extended (Federal Register 82 FR 11854). The revised deadline for public comments on this rule is **April 5, 2017**.
