## **Comments Sought on New Rule for Meal Flexibilities**

he U.S. Department of Agriculture recently announced an interim final rule on flexibilities for milk, whole grains, and sodium requirements that will become effective on July 1 for the 2018-19 school year. Through Jan. 29, the USDA is accepting comments on the rule online and via mail to: School Programs Branch, Policy

and Program Development Division, Food and Nutrition Service, P.O. Box 2885, Fairfax, VA 22031-0885. The comments from the public on the long-term availability of these flexibilities will help develop a final rule, which is expected to be published in the fall of 2018 and implemented in school year 2019-20.

## **USDA Seeking Public Input on Child Nutrition Food Crediting**

he USDA's Food and Nutrition Service announced an invitation to submit ideas on food crediting, the system that defines how each food item fits into a meal for the National School Lunch Program and other federal child nutrition programs. The information collected will help them better understand its stakeholders' perspectives.

In order to claim federal reimbursement, Child Nutrition Program operators must serve meals and snacks that meet the minimum meal pattern requirements of the respective program. Crediting is the process designed by the USDA to specify how individual food items contribute to the Child Nutrition Programs' meal patterns. Several factors impact how food products can credit toward reimbursable meals, such as volume, weight, and overall nutrient profile.

Electronic comments are preferred and may be submitted at the <u>Federal Register</u> through Feb. 12, 2018.

## DID YOU KNOW?

FAQs Answered by Nutrition and Wellness Programs Division Staff

#### **Verification Summary Report**

Q: We did not complete and submit the ISBE Verification Summary Report (VSR) by Dec. 15. What are the possible issues that could result from failure to complete and submit an accurate VSR by the deadline?

**A:** The Verification Summary Report is due annually on or before Dec. 15, although the deadline has been extended to Jan. 10 this year.

Any NSLP/SBP sponsor (district) that does not submit the VSR by the deadline is subject to withholding of payment of any meal claims filed after deadline. NSLP/SBP sponsors will be able to continue filing claims, but payment of those claims will not be completed until a complete and accurate VSR is submitted to ISBE.

#### **Direct Certification**

#### Q: When will Direct Certification be available?

**A:** The Electronic Direct Certification System remains offline. We are working to update guidance and system matching processes as it relates to the new computer system used by the state of Illinois to provide recipient benefits for SNAP, TANF, and Medicaid.

Case identification numbers (agency identifiers) for the these programs have changed during this transition time and guidance will be forthcoming. The number is now nine digits in length.

While we do not have an exact date for the Electronic Direct Certification System to be back online, we are working to have it up as soon as possible. Once this guidance is available, all sponsors will be notified and the system will be available. Thank you for your patience during this time.

Please continue to process new Household Eligibility Applications to insure qualification for free and reduced meals.

#### **On-Site Reviews**

Q: Who is required to do the On-Site Review? When is it due? Where is the form I need to use? What staff person should complete it? What if we find problems? What do I do with it when I have completed it?

A: Each school food authority (SFA) with more than one site where reimbursable meals are served must annually conduct their own review of each site's meal count and claiming procedures. ISBE recommends even districts with one site perform an annual on-site review of meal counting and claiming procedures. SFA's must conduct their own review of each site approved to participate in the NSLP and at 50 percent of the sites approved to participate in the SBP. Each site in the SBP must be reviewed at least once every two years.

The on-site reviews must be conducted before Feb. 1. <u>The required form is available on ISBE's website.</u>

The individual that should conduct the onsite review should be familiar with program rules and should be outside the daily operations to provide an objective look at the operations. The review must be conducted by SFA personnel and may not be conducted by contracted parties who are providing the meal service.

If the review finds problems, the SFA must correct problems immediately and conduct a follow-up review within 45 calendar days of the initial review. The same on-site form can be used for the follow-up review, you would just mark "follow-up" on the form to indicate that this is a follow-up review.

You do NOT need to send a copy of the completed form to our office, just maintain a copy of your completed form at the SFA and our monitoring staff will ask for it when they conduct Administrative Reviews.



## Deadline is Feb. 2 for NSLP Equipment Assistance Grant Request for Proposals

ore than \$1.365 million will be awarded to School Food Authorities (SFAs) in fiscal year 2018 for the replacement, renovation, or purchase of kitchen equipment that will allow SFAs to serve healthier meals that meet the updated meal patterns, with emphasis on more fruits and vegetables in school meals, improve food safety, and expand access.

ISBE is required to competitively award the NSLP Equip-

ment Assistance Grants to eligible SFAs participating in the National School Lunch Program. Higher priority must be given to high-need schools where 50 percent or more of the enrolled students are eligible for free or reduced price meals.

## ICS Orders Begin Jan. 5

he Illinois Commodity System (ICS) will be ready for you to place your SY19 Annual USDA Foods Order from Jan. 5 to Feb. 18.

#### PLEASE NOTE FOR SCHOOLS THAT DIVERT TO PROCES-

**SORS:** All diversions must be placed by Feb. 4. The Diversion to Processor form will be locked from Feb. 5 through Feb. 11 while we compile the list of eligible processors for SY19. The diversion screen will then be unlocked from Feb. 12 through Feb. 16 for final adjustments if needed.

After Feb 16 you will not be able to change any processing diversions.

Now would be a great time to take a look at your current balances on K12 Foodservice and ProcessorLink to start preparing.

## Verification Summary Report Due by Jan. 10

he deadline for the <u>Verification Summary Report</u>, which was originally Dec. 15, has been extended to Jan. 10. Here are links to the VSR instructions:

- Standard Verification Summary Report Instructions:
   Schools/sites in the National School Lunch Program with students qualifying for free, reduced, and paid meals as determined by Household Eligibility Applications and Direct Certification.
- <u>VSR Instructions for Community Eligibility Provision Only</u>: For those with all site(s) in CEP.
- VSR Instructions for CEP and Non-CEP Schools/Sites: For those with some in CEP and some sites not.
- VSR Instructions for Residential Child Care Institution
   With No Day Students: All sites and schools are RCCI
   with no day students.

## IDPH Shares Updates on Certification, Allergen Training

he Illinois Department of Public Health submitted the following updates. (The <u>Food Handling Regulation Enforcement Act</u> was developed and implemented by the Illinois Department of Public Health (IDPH). IDPH is also responsible for the regulation and enforcement.)

#### **Ilinois Food Service Sanitation Manager Certification (FSSMC)**

- Illinois FSSMC is being eliminated Jan. 1, 2018.
- No longer need additional FSSMC certificate or to submit application and \$35 to IDPH.
- Training course and exam still required.
- Must be ANSI accredited Certified Food Protection Manager
   (CFPM) certification (ServSafe, NRFSP, Prometric, 360training, StateFoodSafety)
- CFPM certification still required per FDA Food Code.
- If a food manager does not have a national CFPM certificate, only has the IL FSSMC, they will need to work towards obtaining the national certificate to be in compliance.
- Course listing and approved instructor list will no longer be posted on the IDPH website.
- IDPH will no longer approve courses or certify/approve instructors.

- City of Chicago will still maintain their certificate program and approve instructors.
- Local Health Department inspectors will be responsible for validating CFPM certificates during inspections.

#### **Allergen Awareness Training**

- Begins Jan. 1, 2018 (limited to notification and education) and enforcement beginning July 1, 2018.
- ONLY for Certified Food Protection Managers (CFPMs) working in Category I (high risk) restaurants (same definition as for food handler training).
- This does NOT include non-restaurants such as schools, daycares, hospitals, nursing homes, retail grocery stores, or convenience stores.
- Only ANSI accredited allergen training can be used where required, unless the food establishment has an approved internal training program as described in the act.
- Local Health Department inspectors will be responsible for checking allergen training records during inspections

## Statewide Physical Fitness Assessment Data Released

s of School Year 2016-17, schools are to annually assess the physical fitness level of students in grades 3-12 per Public Act 98-0859 and subsequent Rules Part 1, Section 1.425. This requirement is an effort to assess whether or not schools are meeting State Goal 20, where students achieve and maintain a health-enhancing level of physical fitness. Based upon continual self-assessment, fitness testing can help students identify their fitness levels and set goals for improvement. Gathering this data also enables parents and schools to better understand the health trends within their region and encourage enhancements in a school's physical educa-

tion program.


