NSLP EQUIPMENT ASSISTANCE GRANTS

APPLY TODAY!

he U.S. Department of Agriculture (USDA) the Illinois State Board of Education (ISBE) to provide equipment assistance through competitive grants to School Food Authorities (SFAs) participating in the federally funded National School Lunch Program

(NSLP). Funds allocated for this program are intended to assist schools in purchasing equipment to serve healthier meals; support scratch cooking; improve food safety; store fresh food; upgrade equipment; and to help support the establishment, maintenance, or expansion of the School Breakfast Program (SBP). Funds can be used for NSLP and/or SBP.

ISBE was allocated \$864,538 (provided by the Consolidated Appropriations Act of 2022) and an additional \$1,433,117 (provided by the American Rescue Plan Act), for a total of \$2,297,655 available to competitively award NSLP Equipment Assistance Grants to SFAs in this round of funding.

ISBE has issued a Request for Proposals (RFP) for SFAs to apply on behalf of their NSLP schools for grant funding. SFAs can request funds to replace, renovate, or purchase new kitchen equipment that meets the intended purposes of this grant.

Regarding eligibility, all Illinois SFAs participating in the Food and Nutrition Service provides funding to federally funded National School Lunch Program are eligible to apply for participating schools under their jurisdiction. An SFA is defined as a governing body that is responsible for the administration of one or more schools and has the legal authority to operate NSLP

therein.

All SFAs with schools in NSLP are eligible to apply, but priority will be given in the following areas: schools where 50 percent or more of the enrolled students are eligible for free or reduced-price meals; schools that have not previously received a NSLP Equipment Assistance Grant within the last five award cycles; schools that also participate in the School Breakfast Program; and schools

that prepare meals on site using district-owned equipment or, through this grant, will be able to start preparing meals on site without a school-to-school agreement or vended or food service management contract.

SY 24 Annual Order Period Opens Jan. 9

he School Year 2023-24 annual order period for the **Food Distribution Program** opens Jan. 9. The three spending options include, USDA Foods, DOD Fresh, and diversion to processors.

The diversion to processors option will close in in the Illinois Commodity System from Feb. 20 to Feb. 24, so that ISBE Nutrition Department staff can compile truck loads. It will reopen Feb. 27 for final changes. All diversion to processor requests are

due by March 6.
