## Make Sure Your **Annual Application** is Complete in WINS

The deadline for the School Nutrition Programs application for School Year 2024-25 was June 30, 2024. Please do not delay completing the required Illinois Breakfast. Please note that if application any longer. Failure to complete the application before the program operation start date can jeopardize a sponsor's claims.

To get started sponsors should first view the "Program Year 2025 SNP Application Instructions" on the ISBE website. We ask sponsors to follow the instructions carefully to minimize wait times for assistance.

The application is an annual requirement for all sponsors to participate in such programs as the National School Lunch Program (NSLP), School Breakfast Program (SBP), After School Snack Program, Special Milk Program, and Illinois Free Lunch and you are participating in the Community Eligibility Provision (CEP), this annual application is still necessary to finalize participation plans in the meal programs for the upcoming school year.



Your application is complete.

If you are unsure if your application is complete, log into the Web-Based Illinois Nutrition System (WINS) and look for the green checkmark on your School Nutrition Programs Program Year 2025 dashboard.
