The U.S. Department of Agriculture recently released updates to the School Nutrition Standards. The ISBE Nutrition Department will be reviewing and developing trainings. The USDA presented a webinar on the final rule on May 9. CEP Application Deadline June 30

The application period for the Community Eligibility Provision (CEP) ends June 30, 2024.

If you are looking for basics on the program, we encourage you to watch the <u>U.S. Department of Agriculture's</u> <u>CEP 101 webinar</u>.

In case you missed it, a recording of our March 28 webinar is also available online. This webinar is specific to Illinois and operating CEP for School Year 2024-25. It is an overview of the CEP requirements as well as our online CEP Evaluation and Application Module.

The U.S. Department of Agriculture has lowered the minimum identified student percentage eligibility percentage to 25%, down from 40%. This means more schools will qualify to operate CEP but districts will still need to carefully consider the economic feasibility of the program since reimbursements for a district

operating CEP vary based on the identified student percentage. Just because you qualify now does not mean it may be the best choice for your district.

CEP is an alternative to collecting, approving, and verifying Household Eligibility Applications for free and reduced price eligible students in high poverty local educational agencies (LEAs) for schools participating in the National School Lunch and School Breakfast Programs. Students at CEP schools are offered reimbursable breakfast and lunch for no charge. Districts are reimbursed based on their identified student percentage.

FOOD DISTRIBUTION PROGRAM

DOD Fresh Free for All Open

FFAVORS are open for all DOD participants to place orders against the state balance. The Department of Defense (DOD) Fresh program is one spending option for Food Distribution Program

FFAVORS will remain open for orders until all School Year 2023-24 funds are expended or until June 30, 2024, whichever comes first.

If you operate SFSP or SSO at your school, you may continue to order DOD, for service in these programs.

The Department of Defense (DOD) Fresh program is one spending option for Food Distribution Program funds. School districts that chose to allot school year 2023-24 FDP funds to DOD Fresh have had the opportunity to spend those funds since July 1, 2023.

June 30 Deadline Reminder

The School Nutrition Programs (SNP) application for School Year 2024-25 is available in the Web-Based Illinois Nutrition System (WINS). Sponsors should complete the application by June 30, 2024.

The application is an annual requirement for all sponsors to participate in such programs as the National School Lunch Program (NSLP), School Breakfast Program (SBP), After School Snack Program, Special Milk Program, and Illinois Free Lunch and Illinois Breakfast. Please note that if you are participating in the Community Eligibility Provision (CEP), this annual application is still necessary to finalize participation plans in the meal programs for the upcoming school year.

All sponsors should first view the recorded training, as there are some new steps in the application and some of the information has changed for Program Year 2025. We ask sponsors to follow the instructions carefully to

UPDATING CONTACTS: As part of the annual application, you will be asked to update contact information in WINS. It is not a best practice to make one district personnel the contact for all areas of the School Nutrition Programs. Most contacts can be edited by the district in WINS without assistance or approvals. Look for the pencil icon to edit. Please note that the Food Ser-

vice Director should be a district employee responsible for the day-to-day operations of the meal program. It cannot be a food service management company employee.

We also want to remind you that a change to the Authorized Representative/District Superintendent must be made in the Entity Profile System (EPS) so all agency systems can reflect the change.

Use LFS Funds for SSO

If your School Food Authorities is signed up for Local Food for Schools (LFS) and will be participating in the Seamless Summer Option (SSO), did you know that you can use your LFS funds to purchase local unprocessed or minimally processed foods for your SSO meals? Summer-time is the perfect time to source fresh local ingredients for your summer meals!

It is important to note only SSO is eligible to use LFS funds; the Summer Food Service Program (SFSP) is NOT eligible to use LFS funds.

All SFAs that participate in the National School Lunch and/or School Breakfast Program were eligible to receive LFS funding to purchase local unprocessed or minimally processed foods to serve as part of the NSLP and/or SBP reimbursable meals. The open enrollment period for Local Foods for Schools Funding ended Feb. 29, but funds may still be available. For more information, email localfoods@isbe.net.
