IMPORTANT PROPOSED RULES: All Foods Sold in Schools

On February 8th, the USDA published proposed nutrition standards for all foods and beverages sold to children at school during the school day. The proposed standards, entitled "Smart Snacks in Schools" and required by the Healthy, Hunger- Free Kids Act of 2010, are available for review at <u>http://www.gpo.gov/fdsys/pkg/FR-2013-02-08/pdf/2013-02584.pdf</u>. The <u>FFVP grant application</u> is available online. The deadline to apply for FFVP (School Year 2013-2014) is March 15, 2013.

What is the Community Eligibility Option (CEO)?

CEO is an alternative to collecting, approving, and verifying household eligibility applications for free and reduced price eligible students in high poverty local educational agencies (LEAs) for schools participating in the National School Lunch and School Breakfast Programs. Illinois was one of the first states that were selected to participate in the CEO.

For a LEA to be eligible to use the CEO for next school year, the LEA must have one or more schools that have an identified student percentage of 40% or greater in the current school year as of April 1 (SY2012-2013). Just to be clear, Identified Students are different from your free and reduced eligibility numbers.



Identified students include the following:

- Directly certified students (including SNAP, TANF, Medicaid, & Foster Children)
 - Extension of benefits through direct certified students
 - Homeless, migrant, runaway and headstart students

*the Identified Student numbers must be from April 1, 2013.

The LEA and school must also agree to offer all students in the school breakfasts and lunches at no cost and to cover any cost above the federal reimbursement received with non-Federal funds for four successive school years. Reimbursement for schools participating in CEO will be based on claiming percentages derived from the percentages of identified students.

Summer Food Service Program

Don't miss out!! The workshops for the Summer Food Service Program (SFSP) are HERE!! The Summer Food Service Program is designed to bridge the "nutrition gap" when school is not in session. Children up to age 18 can eat free nutritious breakfasts, lunches or snacks at summer feeding sites operated by approved sponsors. Sponsors receive federal reimbursement for serving meals that meet USDA nutrition guidelines. The SFSP is targeted to low-income areas where at least 50% of the children qualify for free or reduced price school meals. Many sponsors also offer educational, enrichment, or physical activities or partner with others to do

Grant Application to Expand Participation in School Breakfast!

Grants will support schools with the purchase of approved equipment, materials and initiatives facilitating alternative breakfast delivery models (such as in-classroom breakfast, grab-n-go, or second chance breakfast) in an effort to increase student participation in universal school breakfast. Applying schools must either be implementing or be prepared to implement an alternative breakfast delivery model. Grants will be awarded up to \$5,000 on a rolling basis. School Breakfast Challenge 2012-2013

All Illinois schools participating in the School Breakfast Program (SBP) are eligible and are automatically entered to participate in the Illinois Breakfast Challenge. Winners will be announced in April of 2013. Participation increase will be calculated by comparing the SBP participation rates from January - May of 2012 to August - December of 2012. Awards will be given to schools with the largest percentage increases in average daily participation rates. There will be four tiers for the Challenge with each tier awarding three prizes: \$5,000, \$3,000 and \$1,000. For more information, please visit il.nokidhungry.org/.

Grant Opportunities to Fight Childhood Obesity

The Robert Wood Johnson Foundation is making \$1.6 million in healthy eating research grants available to improve health through nutrition and physical activity. These funds are available for largescale changes (such as at state and federal levels) and smaller,



organization-level changes (such as in in schools, recreational programs, child-care settings and hospitals).

Extending the Life of Your Farm to School Produce

More and more schools in Illinois and all over the United States are participating in various forms of Farm to School activities. A couple of the most popular forms of farm to school include school gardens and purchasing local products to serve as a part of their lunch and/or breakfast meals. One of the barriers that we have here in Illinois is the short growing season of some of our fruits and vegetables. One way to extend the time period in which schools can serve local products would be to freeze fresh fruits and vegetables that they can serve throughout the school year. A recent study by the Institute for Agriculture and Trade Policy looks into freezing local produce specifically for the k-12 schools. A few things to keep in mind if you would like to look into freezing local produce, is to ensure that you are following any and all food safety requirements, contact your local

county health department with any questions you may have regarding food safety. Another thing to keep in mind is that some products freeze better than others or the specific freezing method can vary for different fruits and vegetables, so you may want to do some research for the specific product you are working with. Additionally, don't forget that there are local products that can be available all year around like meat products, dairy/milk products, eggs, and even locally made bread products that use local grains.

USDA Announces Farm to School Grants!

Looking for funding for Farm to School (F2S) activities? The Healthy Hunger Free Kids Act (HHFKA) provided for \$5 million annually to for grants, technical assistance and the federal administrative costs related to F2S Programs. This year the USDA will be awarding up to \$5 billion in grants. There will be three different types of grants available:

- Planning Grants intended for schools just getting started on F2S activities.
- Implementation Grants intended for schools that would like to expand on current F2S activities that they are doing.
- Support Service Grants intended for non-profit entities, Indian tribal organizations, state & local agencies and agricultural producers or groups of producers for activities such as conducting trainings, creating F2S curriculum, developing supply chains and more!

In order to assist those thinking about applying for one of the three grants listed above, the USDA will be hosting a series of webinars related to the application process:

- March 5, 2013, 1:00 Eastern Standard Time (EST) Planning Grants
- March 6, 2013, 1:00 EST Implementation Grants
- March 7, 2013, 1:00 EST Support Service Grants

The proposals for all grants are due April 24, 2013 (no later than midnight EST) and the awards will be announced in October 2013. Through USDA's 2012 Team Nutrition and Training Grant, the Division of Nutrition and Wellness Programs will be awarding over 40 schools with mini grants of \$940.00 to help them prepare to meet the HealthierUS School Challenge criteria. The Illinois Action for Healthy Kids will assist those grant recipients to prepare to meet the new HUSSC criteria. The grant period begins May 1, 2013 through December 31, 2013.

HealthierUS School Challenge Certified Schools Eligible to Apply for Grants and Other Recognition Programs

Attention all HealthierUS School Challenge Certified Schools in Illinois: The Healthy Weight Commitment Foundation and Discovery Education will be providing rewards and incentives for schools that are trying to reach higher levels of certification.

Schools with the Gold award level can vie for a \$10,000 grand prize to enhance wellness programs. Schools with the Silver level certification can apply for a \$2,000 grant for physical education or the foodservice program. Bronze award level schools have the opportunity to win a \$1,000 grant for professional development from the National Food Service Management Institute.
