Do you have multiple sites? Do you want to speed up the process of submitting site claims? Check out the 'Upload Batch Files' option on the Child Nutrition ACES main menu. You can save all of your site claim data in a delimited file and submit all the site claims at one time by uploading that file. After successfully uploading the site claim batch file, you must still go into ACES and submit the sponsor claim.

What is a delimited batch file? A delimited batch file contains rows of information that could be displayed in a spreadsheet or table format. However, since it is a text-only file, no special formatting can break up the information into columns. Therefore, a delimited text file consistently uses characters throughout the document to indicate a column break. These characters are known as the delimiters. Nearly any character can be a delimiter, but the most common delimiter is a comma.

The following is a shortened example of using delimiters.

Data: 65432187654,54321,2003,7

Definition: AgreementNumber,SiteNumber,

ClaimYear, ClaimMonth

Batch files contain many records and can take up to five minutes to process. Please do not close or refresh your browser window during this time period to prevent transmission and processing errors. If errors are detected when trying to upload the batch file, you will receive an error messages back. You must fix the problem(s) in the batch file and resubmit the file until it goes through with no errors. A response page will appear after the batch file has been successfully processed.

A sample comma delimited spreadsheet can be down-loaded from within the 'Upload Batch Files' option on the ACES main menu. Additionally, there is a table that describes the fields required in the batch file and the format for those fields.

Excess Inventory at Processors

Pursuant to the new procedures relating to excess inventory at processors we have implemented a new module on the Illinois Commodity System (ICS). The new module is located under the *Annual Order Forms* main menu option on ICS and is called *Excess Processing*. We currently have chicken, cheese, and peanut butter available.

Any excess inventory is listed by the processor and can be claimed by any school that does not have excess inventory at processors. The inventory will be offered on a first come first served basis. Those schools claiming pounds should be familiar with commodity processing procedures and end product distribution.

Excess inventory from processors could come at any time so we advise checking the list on a weekly if not daily basis as we anticipate any inventory that comes along will be claimed quickly.

The excess inventory procedures can be found on the food distribution website by selecting *Inventory Level Procedures at Further Processors Letter*.

Commodity Values for Auditors

All schools are audited each year by their own independent auditors. Part of this audit includes the value of USDA commodities allocated to your school. It is the responsibility of each school to provide the needed information for the auditors, including the information regarding USDA commodities.

The needed information is very easy to locate, and we suggest this be given to the school bookkeeper by the end of each school year. The information is available on the Monthly Commodity Bulletin for April, which is located on the ICS website http://webapps.isbe.net/ics under *Reports*, then select *Bulletin Report*.

In the *Contract Summary for School Year 2009* section, the value of commodities allocated for that year will be the total of the amounts shown as *A PAL Allocated, B PAL Allocated, Processing Deductions*, and *Total Bonus Deductions*. For your convenience, this total is on the bulletin as well; *Total PAL Deductions + Total Bonus Deductions*. If you received DoD fresh fruits and vegetables, you will need to include that value as well. You will need to access this information from the DoD ordering system.

We ask that schools provide this information to auditors when requested.

Grants, Awards, and Honors

Fresh Fruit and Vegetable Program Grant Opportunity

We are happy to announce that the Illinois State Board of Education (ISBE) will be accepting applications for the Fresh Fruit and Vegetable Program (FFVP) Grant for the 2009–2010 school year! The FFVP Grant is a competitive grant to be used to provide fresh fruits and vegetables at no cost to students during the school day at times other than during the meal periods in elementary schools, with priority given to schools with 50 percent or greater free and reduced-price eligibility.



To be selected as a school to participate in the FFVP, the school site must:

- ✓ Participate in the National School Lunch Program
- ✓ Be an elementary school
- ✓ Be at least 50 percent free and reduced-price eligible (highest priority must be given to schools with the highest percentage of low-income students). ISBE can only select schools with less than 50 percent eligibility once all interested and eligible schools at or above 50 percent have been selected.
- ✓ Agree to make and advertise to enrolled students the availability of fresh fruits and vegetables without charge at times other than meal periods
- ✓ Comply with all federal and state guidelines for the FFVP as outlined in these materials
- ✓ Submit the FFVP application no later than April 15, 2009.

The FFVP Grant is different from the Department of Defense (DoD) Fresh Fruit and Vegetable Program. The DoD Fresh Fruit and Vegetable Program is available to all sponsors in the NSLP for fresh fruits and vegetables to be provided as part of the reimbursable meal. The FFVP Grant application must be completed and submitted to our office no later than April 15, 2009, in order to be considered for this exciting program for the 2009–2010 school year!

School Food Service Equipment Grant Application Coming Soon!

The American Recovery and Reinvestment Act of 2009 (ARRA) was signed into law by President Obama on February 17, 2009. The ARRA provides a one-time

appropriation of approximately \$3.6 million for school food service equipment in the State of Illinois.

Information provided from the United States Department of Agriculture (USDA) requires the funds be distributed to sponsors participating in the National School Lunch Program via a competitive grant process with priority given



to sponsors for equipment for schools in which at least 50 percent of the students are eligible for free or reduced-priced meals. Such funds are expected to be spent as soon as possible; therefore, schools can begin gathering information about equipment needs within their districts.

ISBE will announce the grant applications and the deadlines as soon as they are available. Please watch our website (<u>www.isbe.net/nutrition</u>) for more information.

School Breakfast Program Grant Opportunity

Action for Healthy Kids in coordination with Kellogg's® Corporate Citizenship Fund, is offering grants to schools that currently participate in the School Breakfast Program (SBP) that have at least 50 percent free and reduced-price eligibility. Priority will be given to schools in states with the lowest average daily student participation in school breakfast. According to the Food Research and Action Center's (FRAC) 2007–2008 School Breakfast Scorecard, Illinois is among one of the states with the lowest average daily student participation.

The grants are intended to fund implementation of alternative breakfast programs, innovative marketing and promotions, and/or enhancement of the school breakfast experience through educational enrichment activities. The goal is to increase their average daily student participation by 25 percent.



Funding awards will range between \$500 and \$2,000. The amount of the grant award will be based on building enrollment, type of project, potential increases in participation, and desired use of funds. All school buildings meeting the grant requirements will be eligible for funding; however, priority will be given to school buildings in states with low average daily student participation in school breakfast as a percentage of school lunch participation.

Time Frame

- **April 10, 2009**—Proposals must be received by Action for Healthy Kids
- May 4, 2009—Funded school buildings will be notified
- September 1, 2009, and May 30, 2010—Project activities must be completed
- December 18, 2009—Mid-project report due
- June 15, 2010—Final evaluation and report due

Hats Off to You and All That You Do! is the theme of the Illinois School Nutrition Association's 59th Annual Conference to be held at the Drury Lane in Oak Brook Terrace, Illinois on June 16, 17, and 18, 2009.

School nutrition professionals wear many different hats in the course of their day. They are managers of time, resources, and people. They handle procurement, food safety regulations, staffing, program marketing, food production, and carry out federal, state, and local nutrition regulations.

This year's conference is designed to further develop the talents of school nutrition professionals who have devoted their careers to serving nutritious meals to students. It features *Child Nutrition U*, a series of educational sessions that will build core skills. This tract begins with a 3½ hour preconference session on fiscal management followed by classes on program regulations, marketing, commodity management, and basic nutrition. Prairie Oak School's Wellness Policy Success Story

Prairie Oak School in Berwyn has started an After-School Wellness Club with fourteen members, all of whom are in the fourth grade. They meet once a week and have promoted exercise as their main focus.

In October, they endorsed a Walk-to-School Day. In November, they conducted a fundraiser for the Thumbuddy Special charitable organization that provides services to disabled children in the community. In December, they prepared for the holiday season by making homemade Christmas cards for the residence of the Pershing Nursing Home in Stickney. In January, they made pledges to be better people and live healthier lives. They have started to exercises using several different techniques including dancing. They also did an experiment about washing their hands. One group of students washed their hands like normal, another group used a hand sanitizer, and the final group did nothing. Then they used exposing ultraviolet lotion and saw how germs accumulate

on their hands. They now know how to wash their hands properly.

The After-School Wellness Club members live by the Prairie Oak School Wellness Pledge: Here at Prairie Oak School we care about the health of our students, teachers, families, and community. We pledge to make a commitment to well-

ness by living and encouraging healthy daily living habits. We pledge to watch our diet, eat healthy foods, listen to our heart, and to love our neighbor.


