#### IMPORTANT PROPOSED RULES: All Foods Sold in Schools

On February 8<sup>th</sup>, the USDA published proposed nutrition standards for all foods and beverages sold to children at school during the school day. # National School Lunch Program SY2013-14 Paid Lunch Equity Requirement

The Healthy, Hunger-Free Kids Act of 2010 requires school food authorities to ensure there are sufficient funds provided to the nonprofit school food service account for lunches served to students not eligible for free or reduced priced meals. There are two ways to meet this requirement: either through the prices charged for paid lunches or through other non-Federal sources provided to the nonprofit school food service account. ## "Sharing Tables" at Schools

Are "sharing tables" at schools allowed? The United States Department of Agriculture (USDA) defines sharing tables as carts and/or tables where children can place unconsumed food and beverages items (pre-packaged food and beverages, unopened wrapped food and beverages, or food items with a peel) that they choose not to eat/drink. These tables provide an opportunity for other children to take additional helpings of food or beverages at no cost to them for their consumption at school during meal period.

The use of sharing tables is permitted by the Illinois Food Service Sanitation Code (77 III. Adm. Code 750) only if all of the following conditions are met:

- 1. No potentially hazardous food or beverage or any unpackaged food may ever be returned to the food preparation, food service, or food storage areas for use by the food service operation. (Section 750.320)
- 2. Potentially hazardous foods or beverages on the sharing tables are consumed or discarded within four hours of the food or beverage entering the temperature danger zone of 41° F to 135° F. (Section 750.153)
- 3. The sharing table is supervised by a member of the food service staff to ensure that no food, beverage, or condiment has been contaminated (opened, partially consumed etc.), and the original packaging is maintained in sound condition.

We recommend that any school wishing to start up a "sharing table" contact their local health department for any further guidelines.

The USDA has offered a new smaller beef patty! Now available for SY14 - 110322 - Beef Patty w/spp fully cooked homestyle 2.2oz patty. Each 40# case will provide approximately 290 - 2.2 oz patties. One 2.2 oz patty provides 2.0 oz equivalent meat/meat alternate. The commodity value is \$88.67 per case. If you are interested in receiving this commodity, please place your request as soon as possible on the SY14 Annual Order Form, under PAL - Meats/Alternates so that we know how many trucks we need to order from the USDA. If you request this product, remember to make adjustments to other requests to stay within the ordering guidelines. ### **NFSMI's Midwest Regional Training**

National Food Service Management Institute is offering training in Illinois on the following topics:

#### Meal Pattern – May 14, 2013

This six-hour session focuses on Food-Based Menu Planning (FBMP) required for the National School Lunch Program (NSLP). It provides an overview of the Meal Pattern. 8:00 am – 3:30 pm

#### Food Safety Basics – May 15, 2013

This four-hour training is designed to provide a basic understanding of food safety. Lesson content focuses on food safety and why it is important, methods for training school nutrition staff on food safety, how to prevent foodborne illness, and checklists to monitor food safety. 8:00 am – 12:00 pm

#### Food Defense Tabletop Exercise – May 15, 2013

This four-hour training explains how school food supplies may be at risk for bioterrorism, how to assess the risk in school nutrition operations, and how to take action to successfully prevent or reduce the likelihood of intentional attacks on food and during receiving, preparation, and service. 1:30 pm - 5:30 pm

#### **Inventory Management and Tracking** – May 16, 2013

The ability to track food products across the supply chain is at the center of modern inventory management in school nutrition programs. The goals of this four-hour session are to incorporate food product tracking into standard inventory management practices addressing cost efficiencies, food safety, and effective responses to recalls, foodborne illness, and bioterrorism. 8:00 am – 12:00 pm

This two-hour session discusses implementing and monitoring basic food safety practices in order to provide safe meals to students. 1:30 pm – 3:30 pm

Training materials will be provided. Training sessions will be held at Western Illinois University, Knoblauch Hall, West Murray Street, Macomb, IL 61455. Participants are responsible for arranging and paying for their own travel, lodging, and meals each day of the training.
