School Year 2015-16 Household Eligibility Application Coming Soon!

The Household Eligibility Application for free and reduced-price meals for the school year 2015-2016 will be posted on our website (www.isbe.net/nutrition) no later than July 1, 2015. All forms used in prior years to create copies for distribution should be discarded. The new application form must be used. Program regulations require schools to distribute free and reduced-price Household Eligibility Applications each school year, at or near the beginning of the school year. Schools cannot send letters home at the end of the current school year for the next school year nor can the schools begin accepting and processing applications before July 1 annually.

SY2015-2016 Training Opportunities for School Nutrition Program Sponsors

ISBE Food Handler Training

On Aug. 27, 2013, the Food Handler Training Enforcement Act was signed into law. This law requires all food service area employees or food handlers that work with open/unpackaged foods, food service equipment or utensils, or any food contact surfaces to receive an approved food handler training.

This training requirement includes school food service staff. School food services and other child nutrition programs are classified as being "non-restaurant" facilities. Food handlers working in non-restaurant facilities must complete an approved training program by July 1, 2016. The Illinois State Board of Education (ISBE) Nutrition and Wellness Programs Division has been approved by the IDPH to provide the training to school food service staff. Staff that complete the training and receive a passing grade on the required assessment will receive a certificate that is valid for 3 years. All trainings provided by the ISBE Nutrition and Wellness Programs Division will be free of charge to all school food service and other child nutrition program employees.

School Meals Menu Planning 101 (Held in Conjunction with Direct Certification, Certification, and Verification Workshops)

This ½ day workshop will be a beginners level hands-on workshop with menu planning activities geared to the school nutrition personnel that plan the National School Lunch and School Breakfast Program menus. This workshop provides basic information about the breakfast and lunch meal patterns, nutritional requirements, as well as offer versus serve. Each workshop location is limited to 50 attendees, so we request that each school register no more than 2 staff to attend this training.

Direct Certification, Certification, and Verification (Held in Conjunction with School Meals Menu Planning 101 Workshops)

Overview of the Administrative Review Process

This ½ day training will provide sponsors an overview of the Administrative Review (AR) including all USDA checklists and resources. The Administrative Review is an assessment conducted by the Illinois State Board of Education (ISBE) of the School Food Authority's (SFA) administration of the National School Lunch Program (NSLP), School Breakfast Program (SBP) and other school nutrition programs. The objectives of the AR are to determine whether the SFA meets program requirements, provide technical assistance, secure any needed corrective action, and assess fiscal action, if applicable. ISBE must conduct ARs of all SFAs participating in the NSLP and/or SBP at least once during each three-year review cycle period. The first three-year review cycle began SY2013-2014.

Grants, Grants, Grants for School Year 2015-16!

NSLP Equipment Assistance Grants – Deadline June, 2015 (TBA)

In response to a USDA award of \$950,534, the IL State Board of Education will be issuing a Request for Proposals (RFP) to assist school food authorities in School Year 2015-16 purchasing equipment needed to serve healthier meals that meet the updated meal patterns, with emphasis on serving more fruits and vegetables in school meals, improving food safety, and expanding access. ISBE will issue subgrants, not to exceed \$50,000, on a competitive basis and all sponsors participating in the National School Lunch Program (NSLP) are eligible to apply. The RFP will be released in May with a deadline in June. When available, the RFP will be posted at http://www.isbe.net/nutrition/htmls/nslp_grant.htm, an article will be in the Superintendent's Weekly Message, and an email will be sent to all Authorized Representatives in the NSLP.

Claim Common Cent\$--Year End Claims

As you prepare to end the school year and file your final claims before summer break, take a moment now to ensure that you have the correct serving days approved for each site. If you had to add a few days to your school year due to snow days, you need to update your operating days and participation detail before you file your May or June claim for reimbursement. Instructions on how to add serving days are available inside WINS by clicking on the occurrence icon. They are titled "School Nutrition Programs (SNP) - Adding Serving Days.pptx."

If you have serving days approved on which you will no longer be serving meals, you may leave those days blank or enter zeroes in those individual days. If you are currently approved to serve for an entire month of the entire summer and will not be serving for one or more of those months, we ask that you remove those months from your participation. Instructions for removing summer months are also available at the icon. They are titled "School Nutrition Programs (SNP) - Removing Summer Break.pptx."

New! Tool Kit for Managing Food Allergies in Schools

<u>Food allergies</u> affect approximately 4% - 6% of children in the United States. Helping school staff to be prepared to <u>prevent and manage a child's severe allergic reaction</u> can create a healthy environment where all school children can reach their full potential.

The <u>Tool Kit for Managing Food Allergies in Schools</u> was developed by CDC to help schools in implementing the <u>Voluntary Guidelines for Managing</u> Food Allergies in School and Early Care and Education Programs.

Enhanced Physical Education – New Requirements for Physical Fitness Assessments in Schools

Public Act 098-0859 requires all public schools, starting with the 2016-17 school year, to administer scientifically-based, health-related physical fitness assessments for grades 3-12 for select fitness components and to periodically report that information to the Illinois State Board of Education (ISBE).

It also created and charged the *Stakeholder and Expert Task Force on Physical Education* with the following:

- make recommendations (from which ISBE will adopt rules for implementation, data collection and reporting) on the following: 1) which components of fitness should be assessed; 2) which fitness component scores should be reported to ISBE; 3) the demographic information that should accompany the scores; 4) the grade levels for which fitness assessment scores should be reported; and 5) the frequency of reporting.
- make recommendations on methods for ensuring validity and uniformity of fitness scores, including assessment administration protocols and professional development approaches for physical education teachers, and protocols regarding the protection of student confidentiality and individual information and identifiers.
- make recommendations on how physical fitness assessment data should be reported by ISBE to the public, including potential correlations with student academic achievement, attendance, and discipline data and other recommended uses of the reported data.

The fifteen member Stakeholder and Expert Task Force on Physical Education was appointed by Illinois State Superintendent of Education Christopher Koch in October 2014 and met regularly from November, 2014 through March, 2015.
