Click <u>here</u> for instructions for completing your 2017 annual application. Instructions are also available in the WINS system under the blue and yellow question mark.

When you are in the WINS system you may notice a button that says "*Renew Application*", clicking this button will start the 2017 Annual Application renewal. If you are not yet ready to complete your 2017 application, we recommend waiting to click that *Renew Application* button. If you clicked the *Renew Application* button in error, you can always come

back and complete the application when you are ready using the <u>instructions</u>. A recorded walk-through of the application is also available on our <u>website</u>.

If you contract with a Food Service Management Company (FSMC), vendor or another school for your food service, ensure that you have submitted a copy of your contract to our office for approval. Preapproval of your contract will provide for a more streamlined annual application process. If you have not yet submitted your contract to our office, please do so as soon as possible. You can submit your contract via email to <u>kshelton@isbe.net</u> or you can attach your contract to the paper clip icon at the top of the screen in the WINS system. You can still complete your annual application without your contract approved, however the application will be in a pending status. Once your contract is received, reviewed and approved we will enter it into the system and your annual application will be approved. Currently contract reviews are taking approximately 30 days.

*Please note that once you have clicked the Renew Application button in WINS, the system will always default to program year 2017. If you are going into WINS to complete a May or June claim you will need to change the program year at the top of your screen to 2016 in order to access those claims.

Year End Claims

A s you prepare to end the school year and file your final claims before summer break, take a moment now to ensure that you have the correct serving days approved for each site. If you had to add a few days to your school year due to snow days, you need to update your operating days and participation detail before you file your May or June claim for reimbursement. Instructions on how to add serving days are available inside WINS by clicking on the @ icon. They are titled "School Nutrition Programs (SNP) - Adding Serving Days.pptx."

If you have serving days approved on which you will no longer be serving meals, you may leave those days blank or enter zeroes in those individual days. If you are currently approved to serve for the entire month of June and will not be serving any days in June, we ask that you remove June from your participation. Instructions for removing days of operation are available at the Sicon. They are titled "School Nutrition Programs - removing days of operation."

NOW AVAILABLE! – The CN Label Verification Report

The Nutrition, Education, Training, and Technical Assistance (NETTA) Division in FNS' Child Nutrition Programs has taken great strides to address concerns expressed by state officials, school program operators, and the industry regarding acceptable documentation during an administrative review. As a result, NETTA created the CN Label Verification Reporting System.

The CN Label Verification Reporting System was developed to assist State agency reviewers, CN program operators, and the food industry to verify the status of a CN Label and the validity of a CN Label copied with a watermark. The new system produces two comprehensive monthly reports:

- CN Label Verification Report -<u>http://www.fns.usda.gov/sites/default/files/c</u> <u>n/cnl_verificationreport.pdf</u>; and
- CN Label Manufacturers Report

The CN Label Verification Report includes all information pertaining to the valid CN Label which includes the crediting information (meal pattern contribution statement); label expiration date; and the manufacturer's establishment number. This new online report replaced the previous authorized list published on the CN Labeling Web site (http://www.fns.usda.gov/cnlabeling/childnutrition-cn-labeling-program).

The CN Label Manufacturers Report includes the contact information for all manufacturers that are authorized to produce CN Labeled products. The users will be able to link the manufacturer's list from the CN Label Verification Report.

To make everything go as smooth as possible, all changes need to be made on the Illinois Commodity System (ICS) prior to July 5th for the August delivery. The ICS Delivery Site Change form is available on the FDP website at <u>www.isbe.net/business.htm</u>. If you need to make a change, please complete the form and fax it to our office no later than July 5th to be effective for the August delivery.
