IMPORTANT! Annual Sponsor/Site Applications Due Sept. 15

Sponsor/Site Applications to participate in the National School Lunch Program, School Breakfast Program, Special Milk Program, After-School Care Program, and/or IL Free Program during the 2011-12 school year are now available. These online applications, which are due no later than Sept. 15, 2011, are accessible by logging into IWAS (ISBE Web Application Security) and selecting Application and Claim Entry System (ACES). It is highly recommended that you print off the instructions available at http://www.isbe.net/nutrition/htmls/instructions.htm.

Settling into a new school year, you may realize that you have changes to make to your contact information in the National School Lunch Program (NSLP). Having the correct contact and site information in your NSLP Sponsor and Site

Applications is extremely important to ISBE as we rely on it to convey program information to you quickly and efficiently, most often via e-mail. Notice of School Breakfast Availability



School Food Authorities (SFAs)
participating in the School Breakfast
Program (SBP) must inform eligible
families of the availability of reimbursable
breakfasts served under the SBP. This
must be done just prior to or at the

beginning of the school year in the informational packets that are sent to each household with free and reduced price meal applications for the new school year, as well as through reminders sent multiple times throughout the school year. Schools can provide reminders to children through their public address systems in schools or through means normally used to communicate with the households of enrolled children. Other acceptable outreach activities may include developing or disseminating printed or electronic material to families and school children. For example, information about the SBP should be posted

Verification Process Requirements

Verification is the confirmation of eligibility for free and reduced-price meals under the National School Lunch Program (NSLP) and School Breakfast Program (SBP). By Nov. 15 each year, each local educational agency (LEA) must have select and verified a sample of applications from all approved household applications on file as of Oct. 1. The verification process is a requirement for LEAs participating in the NSLP and/or SBP programs.

Verification Timeline

- Oct. 1 Count number of approved household applications on file.
- Last Operating of October Count number of eligible students by category (Categorically eligible, Free SNAP/TANF, Free Income, and Reduced Income).
- **Nov. 15** LEA must have completed verification process.
- Dec. 15 Submit Verification Summary Report.

Calculating the Average Dairy Charge

If you have sites that participate in the Free Milk Program, you are required to report the 'Average dairy cost per ½ pint of all milk purchased this month' on the site claim. To calculate this figure, add together the dairy charge for all ½ pints of milk purchased for the month and divide by the number of ½ pints purchased. Often flavored milk and white milk have different prices of costs. See example below:

Purchased 500 $\frac{1}{2}$ pints of white milk at \$0.20 each = \$100.00

Purchased 1200 $\frac{1}{2}$ pints of chocolate milk at \$0.25 each = \$300.00

Total cost of milk = \$400.00 (\$100 + \$300)

Total $\frac{1}{2}$ pints purchased = 1700 (500 + 1200)

Average Dairy Charge = \$.2352 (\$400/1700)

In the above example, on the monthly site claim, report \$.2352 for the Average Dairy cost. Be sure to keypunch .2352. You must type the decimal point and up to four decimal places. You will be reimbursed for the number of free milks multiplied by the dairy charge that you enter. The system will not allow charges over \$.9999.

Reminder-Federal Fiscal Year October through September (Claims)

As you start submitting claims for the 2011-12 school year remember that the programs and claims run on a Federal Fiscal Year of October through September. This means that September and prior claims are **FY 2011** and October and after claims are **FY 2012**. Be sure you select the correct Program Year when filing your claims online.

Warehouse/Delivery Rates

For School Year 2011-12 the base delivery rates will remain unchanged. In Zone 1, which consists of Jo Davies, Stephenson, Winnebago, Boone, Lake, Carroll, Ogle,



DeKalb, Kane, Cook, Whiteside, Lee, LaSalle, Kendall, DuPage, Will and Grundy counties, the delivery rate per 100 pounds is as follows: dry=\$9.41, refrigerated = \$11.73, and frozen = \$12.52. In Zone 2, which is all other counties, the delivery rate per 100 pounds is as follows: dry=\$10.18, refrigerated = \$11.42, and frozen = \$13.51. As in previous years, depending on the price of diesel fuel, you may be subject to a surcharge. The surcharge is based on the average price of diesel fuel as reported by the U.S. Energy Information Administration. The surcharge is 1 percent of the delivery charge for every \$.10 increase in diesel fuel over the base rate of \$2.41 per gallon. Currently (as of August 2011) the fuel surcharge is 16 percent.

Reprocessed Commodity Product Exhibit

The annual reprocessed commodity product exhibit is right around the corner. If you have never diverted commodities to a processor before or divert every year, this event is a must to learn about all that is available to you in processing commodities. The Illinois School Nutrition Association (ISNA) is sponsoring the event planned for Oct. 12, 2011, at the Peoria Civic Center. Information for this event is posted on the ISNA's Website, www.ilsna.net.

This exhibit is a great place to try different commodities that will be offered for the 2013 school year. There is no cost if you are an ISNA member (\$25 for non-members) and you do not have to divert commodities to a processor to attend. ISBE will give a brief presentation before the taste tests begin explaining the commodity divert process. Please plan on attending this informative and product filled event.

Spotlight on Schools

Schools Play their Part in Fighting Hunger for Children through the Seamless Summer Option and the Summer Food Service Program

During the summer of 2011, the Seamless Summer Option saw an increase in the number of sites participating in the program. There were 105 sponsors that participated this summer, which remains consistent with last year. However, those districts opened the doors to 585 sites which was a 4.5 percent increase over the 560 sites in 2010.

In addition, 36 school districts participated as sponsors in the Summer Food Service Program, a slight decrease from 2010. However, the number of sites increased over 70 sites; a 21.1 percent increase over the prior year.

Together, a total of 141 school districts throughout Illinois served breakfast, lunch or snacks to children at over 1,033 school or community sites; which is a 10 percent increase over the previous year.

HealthierUS School Challenge News

The HealthierUS School Challenge is U.S. Department of Agriculture's voluntary school nutrition and wellness initiative to improve student health and well-being. HUSSC rewards schools for excellence in promoting nutrition and physical activity. USDA's national goal to certify 1,250 schools by June 30, 2011, has been exceeded by 23 schools; 1,273 achieved this recognition.

Kudos to Illinois' 60 HUSSC certified schools representing five school districts. Schools participating in the challenge are recognized with Gold of Distinction, Gold, Silver or Bronze-level certification. Illinois boasts three Gold of Distinction, 14 gold, four silver, and 39 bronze certified schools. These schools are certified for four years. Challenge certification also includes monetary incentives for schools --\$2,000 for Gold Award of Distinction, \$1,500 for Gold, \$1,000 for Silver and \$500 for Bronze, a plague and national recognition and prestige. A special celebration to honor the HUSSC certified schools, effective June 30, 2011, will be held at the White House, South Lawn in October.

What's Cooking

Temperature, Not Color, Important **Determinate of Ground Beef Safety**

What You Need to Know About Safely Preparing Hamburgers

Tere is an annual reminder of the importance of taking Lemperatures and not relying on the internal color of hamburger patties.

The Food Safety and Inspection Service (FSIS) continues to advise consumers to use a meat thermometer when cooking hamburger and not rely on the internal color of the meat to be sure it is safe to eat. Visual testing for clear juices is no longer sufficient.

Research indicates some ground meat may prematurely brown before a safe internal temperature of 160°F has been reached. Also, some lean ground beef, or ground beef that contains approved seasonings or flavorings such as spices and spice extractives, may remain pink at temperatures well above the 160°F final cooking temperature recommended for consumers.

To accurately measure the internal temperature of a ground beef patty, a food preparer must insert the thermometer through the side of the patty to the center. For more information about this subject or other food safety articles, visit the FSIS Website at www.fsis.usda.gov.
