## **Claim Common Cent\$ - Claim Reminder Notices**

Starting with Fiscal Year 2016/October 2015 claims, Funding & Disbursements will no longer be mailing claim reminder letters in the US Mail. We have started emailing the claim reminder notices to the email addresses that we have on file for the Authorized Sponsor Representative, the Sponsor Contact and the Sponsor Claim Contact. Please check the email addresses that are showing in WINS as that is the email address that the notice will be sent to. If that email is not correct please contact our office to update it.

Two reminders will be sent for each month to Sponsors who are approved to participate and have not submitted their sponsor claim for the month. Reminder notices will be emailed on the 25<sup>th</sup> of the month for the previous month and on the 15<sup>th</sup> of the month for the second previous month. For example: on January 25 the first reminder notices for December will be sent and on February 15 the second reminder notices for December will be sent.

Claims are due no later than 60 calendar days after the end of the claiming month. We recommend submitting claims 10 days after the claiming month to ensure prompt payment of the claim. Claim due dates are as follows:

December March 1 (Feb 29 if leap year)

January April 1 (March 31 if leap year)

February April 29 March May 30 April June 29 July 30 May June August 29 September 29 July August October 30 September November 29

## **Summer Food Service Program**

The Summer Food Service Program (SFSP) is designed to provide nutritious meals during the summer months to children from areas where at least 50 percent are eligible for free or reduced-priced meals during the school year through the National School Lunch and School Breakfast Programs. **Does your area meet this criterion?** If so, consider becoming a sponsor to help bridge the gap for the children in your community. All sponsors will be required to submit the program application and monthly claims for reimbursement via the internet.



SFSP is a much underutilized program throughout the United States; so we hope your school will participate and serve up to two meals a day for all children (including community children) during the summer months. Statistics show that out of 100 children who eat lunch during the school year in NSLP; only 16.2 receive a meal in SFSP or Seamless Summer Option (SSO); FRAC's Summer Nutrition Status Report 2015, Hunger Doesn't Take a Vacation

If the responsibilities of sponsorship of the SFSP are not possible, you can still participate in the program by operating a site, being a vendor, or volunteering your time. # School Breakfast Program Mandate: Plan Ahead!

Public Act 96-0158 requires each school district in this State to implement and operate a School Breakfast Program by the first day of each school year in each school building within its district in which as of October if previous school year had 40 percent or more of the students eligible for free or reduced-price lunches in the prior school year. ISBE administers the federally-funded School Breakfast Program and the state-funded IL Free Breakfast Program to assist you in implementing a successful program and to supplement the cost of providing the program. Global Compliance Network (GCN) is now offering an online training option that meets the Illinois Department of Public Health's (IDPH) Non-Restaurant Food Handler Training Requirement.

Illinois school districts that already utilize GCN trainings can log-on to <a href="www.gcntraining.com">www.gcntraining.com</a> and search for the Food Safety/Food Handler training. The training is approximately 1 hour long, and covers all of the required IDPH topics. Users are required to answer questions throughout the training to satisfy IDPH's assessment requirement.

# Sangamon County Excellence in School Wellness Award



The Sangamon County Excellence in School Wellness Award recognizes public schools in Sangamon County that have taken steps to create a healthy environment for their students and staff in the areas of school meals, nutrition & health education, physical activity & PE, health promotion and obesity prevention. A healthy school environment is positively associated with academic achievement and improved behavior in students, helps prevent childhood obesity, supports family wellness, and decreases the risk of future chronic diseases by promoting ideal health practices among youth.

Over the years, Sangamon County schools have created new student and staff wellness programs, improved the quality and taste of healthy school meals, and worked with community partners to install community gardens, give in-class nutrition education and provide health education assemblies. Schools have also made changes to their school environment and policies so that nutrition and physical activity become second nature to current and future students. Because of their efforts, we will see a new generation of healthy, thriving youth and a healthier future for Illinois.

Beginning with the 2014-2015 school year, University of Illinois Extension created the Sangamon County Excellence in School Wellness Award to honor Sangamon County schools' commitment to school health. The award is open to all public schools in Sangamon County that participate in the National School Lunch Program and/or School Breakfast program. Annually, schools may apply to be recognized as Bronze, Silver, or Gold level winners. All schools that fall into the one of the three score categories will be awarded a Certificate of Excellence in front of their Board of Education for their district. In addition, schools that demonstrate an extra amount of motivation or success will be considered for a Distinction Award in their category. All schools are encouraged to apply, especially first-time applicants and schools with 40% or above free/reduced lunch eligibility.
