Verification Summary Report Due January 16, 2009

Verification is the confirmation of eligibility for free and reduced-price meals under the National School Lunch Program (NSLP) and School Breakfast Program (SBP). Annually, each local education agency (LEA) participating in NSLP and/or SBP must select and verify no later than November 15 a sample of household applications approved for benefits. LEAs must then electronically submit a Verification Summary Report (summarizing the results of verification efforts) to the Illinois State Board of Education by January 16, 2009. School Meals Initiative Reviews Update for School Year 2008–2009

A ll school food authorities (SFAs) participating in the National School Lunch Program must undergo a School Meals Initiative (SMI) Review at least once every five years—usually every three to five years in the state of

Illinois. The review is part of the United States
Department of Agriculture's (USDA's) strategy to ensure
school menus comply with the Dietary Guidelines for
Americans and certain nutrient standards when averaged
over a school week. The Illinois State Board of Education
(ISBE) continues to provide training on expectations and
documentation needed to conduct the required nutritional
analysis for SFAs in addition to training on how to
improve the nutritional integrity of school meals.

For the 2008–2009 school year, ISBE contracted with Southern Illinois University (SIU)-Carbondale to complete the SMI Reviews on its behalf. In addition, ISBE staff will conduct SMI Reviews throughout the state. Pertinent technical assistance documents related to SMI Reviews have been posted on the ISBE Nutrition Programs Division website including the listing of eligible sponsors for SMI Reviews for the 2008–2009 school year. Sponsors eligible for an SMI Review will be notified via mail at various times throughout the school year. Other technical assistance documents posted include a memorandum to sponsors, informational packets for food-based sponsors, and other necessary information about this review. All SFAs selected for an SMI Review will have the week of review identified by ISBE based on the mailing group. Reviews conducted by SIU-Carbondale will follow the list below:

- Group 1 mailed September 2008—Week of review is September 15–19, 2008
- Group 2 mailed October 2008—Week of review is October 20–24, 2008
- Group 3 mailed January 2009—Week of Review is January 12–16, 2009

Reviews conducted by ISBE will follow the list below:

- Group 1 mailed October 2008—Week of review is November 3-7, 2008
- Group 2 mailed February 2009—Week of review is March 2-6, 2009

Summer Meals Reminder

Summer Food Service Program's Public Act 095-0155 requires any public school with at least 50 percent of the children qualifying for free and reduced-price lunch AND conducting a summer school program to operate a summer meal program.

School districts that must implement a summer meal program need to be aware of the following critical dates:

To implement a summer meal program for the summer of 2009:

• February 15—Develop and implement a plan to operate a summer meal program.

To opt out of implementing a summer meal program for the summer of 2009 due to program costs:

- January 15—Petition Regional Superintendent for an exemption.
- March 1—Regional Superintendent to render a decision on exemption.
- April 1—State Superintendent of Education to render a decision on appeals.

The law outlines the following responsibilities for Regional Superintendents:

- Review petitions from required schools (must reach you by January 15) to determine if an exemption can be provided due to excessive program costs.
- Hold a public hearing.
- Render a decision to the required school by March 1.
- Send your listing of schools in your region requesting an exemption and your decision to Amy Bianco, Nutrition Programs Division, Illinois State Board of Education, 100 North First Street W270, Springfield, IL 62777-0001, or fax the report to Amy's attention at 217/524-6124.

Claim for Reimbursement Status in ACES



o you know what status your Claim for Reimbursement is in and what the status means? There are several different claim statuses for both the site claim and the sponsor claim. After completing the site claim, click on Submit for Consolidation at the bottom of the claim entry screen. If the site claim passes all the edit checks, it will go to Submitted status. After all your site claims are submitted, you must open the sponsor claim for that month, check all your figures, and if correct click Submit to ISBE at the bottom of the sponsor claim screen. If the sponsor claim submission is successful, the sponsor claim status will show as Approved. Once you complete and submit the sponsor claim, the site claim will switch to Consolidated status. The claims will NOT be paid until the sponsor claim is successfully submitted. After we voucher the claims for payment, the sponsor claim status will change to Processed.

You should periodically check the Application and Claim Entry System (ACES) to ensure your claims are in the correct status. If either a site or a sponsor claim status is *Not* Submitted, that means no claim has been submitted. If a site claim is in *Submitted* status, you need to ensure the sponsor claim is submitted as soon as possible. If the sponsor claim is in Approved or Processed status, the site claim should be in Consolidated status. The only exception would be if you revised the site claim. Then it will again be in Submitted status and you need to open the sponsor claim, click on Recalculate to update your figures and then resubmit the sponsor claim. If you notice a site claim in Submitted status when the sponsor claim is in Approved or Consolidated status and you have not changed any figures or do not intend to submit a revised claim, please contact Carol Curto or Gladys Rothenberg at 217/782-5256.

\$3,500 School Breakfast Program Start-Up Grants Available

Join the nearly twenty schools who have already taken advantage of the \$3,500 state-funded School Breakfast Program Start-Up Grant this year. Funds can be used towards any nonrecurring costs (costs related to the start-up of the program only), equipment (refrigeration equipment, serving equipment, warming trays, carts, menu boards, toasters, cereal dispensers, etc.), outreach and materials (conference attendance, brochures, flyers, menus, etc.). Any school that does not currently operate a School Breakfast Program, but agrees to operate a program for at least 20 serving days in the start-up year and three years beyond is eligible to apply.
