## ADMINISTRATIVE ALERTS Please Provide Requested Data on Claim for Reimbursement Reports



On your claim for reimbursement each month, the report asks for some data. In the statistics section we ask for

your enrollment by program that the site participates in (National School Lunch Program, School Breakfast Program, Afterschool Snacks, and Special Milk Program).

Please provide the enrollment of how many students have access to that program. For example, if the school building had a pre-k program that is half day and does not have access to the lunch program, do not include the pre-k in the enrollment for the lunch program. If however, that pre-k program does have access to the breakfast program then you would include them in the breakfast program enrollment.

## FY 17 Farm to School Grants Application Deadline is Dec. 8

On Sept. 13, the U.S. Department of Agriculture (USDA) announced that up to \$5 million in grant funds is available to help schools create or strengthen farm to school programs this school year. Administered by USDA's Food and Nutrition Service, these annual, competitive grants will help further USDA efforts to increase locally sourced foods in school meals.

The Farm to School Grant Program was authorized in the Healthy, Hunger-Free Kids Act of 2010. To date, the USDA has funded 300 projects in all 50 states; Washington, DC; and the U.S. Virgin Islands.

Since its inception in fiscal year 2013, more than \$20 million has been awarded through the Farm to School Grant Program.

This year, awards ranging from \$20,000 to \$100,000 will be distributed in four different grant categories: Planning, Implementation, Support Service, and Training.

## Illinois School Districts Receive Fuel Up to Play 60 School Nutrition Grants

On Oct. 27, representatives from the Illinois State Board of Education, Midwest Dairy Council, Aramark, and Community Unit School District 308

gathered at the CUSD administrative center in Oswego to present a check for more than \$93,000 to fund the expansion of



school breakfast programs across the state.

These funds were awarded to schools in Illinois as part of the 2016 Fuel Up to Play 60 School Nutrition Grant Program and were given in recognition of the state's efforts to ensure all students have access to more nutritious foods.

Illinois Dairy farmer Ethan Heinzmann presented the check for \$93,080 to two representatives from ISBE: Dr. Kate Anderson Foley, Assistant Superintendent of Specialized Instruction, Nutrition, and Wellness; and Mark Haller, Nutrition and Wellness Programs Division Administrator.

The grants were distributed to eight qualifying school districts throughout the state to fund innovative programs like Breakfast After the Bell or to add new school menu offerings, such as yogurtbased smoothies. Districts receiving the grants include:

The Illinois Commodity System (ICS) will be ready for you to place your SY 18 Annual USDA Foods Order from Jan. 5 to Feb. 20, 2017.

**PLEASE NOTE:** SCHOOLS THAT DIVERT TO PROCESSORS – All diversions must be placed by Feb. 5. The Diversion to Processor form will be "locked" from Feb. 6-10 while we compile the list of eligible processors for SY 18. The diversion screen will then be "unlocked" from Feb. 11-20 for

final adjustments if needed. Now would be a great time to take a look at your current balances on K12 Foodservice and ProcessorLink to start preparing!

The SY 18 USDA Foods Exhibit and Workshops are scheduled for Jan. 10 and 12. Food Distribution Program staff will be available to answer any questions you might have regarding the ICS and placing your annual order. Please see the message on the ICS message board for further details.

## Summer Meals Summits Held in Springfield, Marion, and Chicago

ISBE Summer Food Service Program staff hosted three summits around the state, including in

Springfield (Nov. 2), Marion (Nov. 10), and Chicago (Nov. 16). ISBE partnered with No Kid Hungry/Share Our Strength to coordinate and/or facilitate the events.

Sponsors and resource organizations came together to share challenges and successes from summer 2016. More importantly, they engaged in brainstorming with resource organizations on topics such as marketing, menu planning, and other challenges to help with participation for summer 2017.

Some ideas that came out of the sessions include:

- Speaking to community organizations (such as Chamber of Commerce, Rotary, Jaycees, churches, Boys & Girls Clubs, etc.) about summer meals and seeking partnerships.
- Reach out to Police Departments to visit programs or invite to meals.
- Invite media to see meals and kid's activities.
- Partner with other organizations (such as colleges, schools or other sponsors) to host a kick-off.
- Asking local utility to promote Summer Meals by inserting information in bills.
- Ask to put up posters in local businesses (including Laundromats).
- Sponsors sharing how they reached out to libraries, parks, and housing authorities in their areas.

Resource organizations participating in the summits included University of Illinois Extension Service; Women, Infant and Children (WIC) centers; Consortium to Lower Obesity in Chicago Children (CLOCC); Midwest Dairy Council; United Way; and the U.S. Department of Agriculture.

## Get the Scoop on Summer Meal Requirements for School Districts

Public Act 096-0734 (amends Public Act 095-0155), amends Section 20 of the Childhood Hunger Relief Act (105 ILCS 126/20). This amendment requires a school district to implement a summer breakfast and/or lunch program for the duration of the summer school program in all schools where 50 percent or more of the student population is eligible for free or reduced-price meals AND that have a summer school program. This amendment applies to all schools that meet the above criteria, including those schools not currently participating in any federal Child Nutrition Program. There is an opt-out clause in the legislation, but it must be completed by Jan. 15. The legislation along with question and answers are accessible at <u>www.isbe.net/nutrition</u> on the National School Lunch Program webpage under Public Act 096-0734 (which amends Public Act 095-0155) – Summer Food Service Program and on the Summer Food Service Program webpage under the Regulations and Policies link as Public Act 096-0734 – Summer Food Service Program.

#### **Important Dates to Remember**

#### Jan. 15

• Deadline to submit written Opt-Out Request to your regional superintendent of schools.

#### Feb. 15

- Deadline to develop and keep on file the district plan to conduct a summer lunch and/or breakfast program for each school where at least 50 percent of the students are eligible for free or reduced-price school meals AND that have a summer school program.
- Sign up for the Summer Food Service Program training if participating in the SFSP. For more information on SFSP, visit <u>http://www.isbe.net/nutrition/htmls/summer.</u> <u>htm</u>.

#### **Prior to March 1**

• Regional superintendent of schools must convene a public hearing to hear testimony from the school district and interested community members.

#### March 1

- Deadline for regional superintendent to:
  - Inform the school district, in writing, of his or her decision, along with the reasons why the exemption was granted or denied.
  - Provide a listing to the Nutrition Programs Division of all districts that applied to opt-out, along with the affected schools, whether the exemption was granted or denied, and the reasons for the action.

#### April 1

• Deadline for the Illinois State Superintendent of Education to hear appeals on the decisions of regional superintendents of schools.

#### SUCCESS SPOTLIGHT: Peoria Heights Grade School

Peoria Heights Grade School was having a difficult time getting students to behave & consume the healthy foods offered in the lunchroom.

Therefore, Suzanne Cranford, Food Service Director for Peoria Heights District #325, implemented the "Golden Spatula" incentive program. Now, the end of lunch is considered "quiet time," the lights are turned off, and students are encouraged to finish their meal. The two classes with the best behavior, clean trays, and a clean table receive the "golden spatula" for that day – which allows students to play on the playground with the best equipment, receive extra recess, or eat lunch with a celebrity guest(s), including the Illinois Central College Basketball team.

Lunchroom monitors, teachers, and food service staff have seen a vast improvement in the lunchroom, including a decrease in food waste and a positive lunchroom environment. The school plans to continue the program in the following years.
