VII. Illinois State Board of Education

- a. Legislation updates:
 - i. Public Act 103-0399 amends School Code 105 ILCS 5-22-81, also known as Louie's Law. It provides educational resources and a guide for schools in collaboration with the Illinois Department of Human Services.
 - ii. PA 103-0348 amends School Code 105 ILCS 5/22-30. It specifies that schools "shall" instead of "may" maintain a supply of opioid antagonist. Effective January 1, 2024. ISBE is collaborating with IDPH and Illinois Department of Human Services - Substance Use Prevention and Recovery pertaining to Overdose Education and Naloxone Distribution services and the Drug Overdose Prevention Program.

VIII. AWARE

- a. The Advancing Wellness and Resilience Education (AWARE) coalition met in October of 2023. The member who represents SHAC was unable to attend.
- b. ISBE has two Substance Abuse and Mental Health Services Administration (SAMHSA) grants for AWARE.
- c. ISBE has another SAMHSA grant for the Resilience Education to Advance Community Healing (REACH) Out Initiative.
