# II. Approval of Minutes from January 18, 2012 meeting

Mr. Aldridge showed and explained information available on this site that could possibly assist the task force. During discussions, the task force decided to create a Best Practices Sub-Committee to investigate current best practices in Illinois districts. Leslie Juby, Ava Carpenter-McPike, Christine Boyd, Cynthia Riseman, and Terry Solomon volunteered to participate as members of the sub-committee.

### IV. Legislative Update & Other Business

Copies of a few bill summaries, that are relevant to the task force, were included in packets for task force members to review.

During the January meeting, a discussion ensued regarding a resolution to extend the deadline for the School Success Task Force and adding a representative member from the Chicago Public School District. This resolution has been filed and is currently in the education committee.

Task Force members discussed the 2009 suspension and expulsion data that was reported to ISBE.

One member asked the committee if recommendations would be made by the committee that would help in the education of parents. Task force members noted that this could be included in the Task Force recommendations.
