# Dear Colleagues:

The 2022-23 Report Card shows that, statewide, chronic truancy rates dropped by 10% over the previous year. That's the good news! The bad news? **One in five** students across Illinois is still chronically truant. Absenteeism is associated with lower academic performance, increased likelihood of dropping out, and even higher rates of future incarceration. Improving attendance is foundational to moving the needle toward our academic goals.

Various sections of the School Code address truancy and attendance at the school, district, regional, and state levels. These laws help ensure that students receive evidence-based support and intervention from their very first absence to prevent one absence from becoming truancy and to prevent any student from falling through the cracks. ISBE held an hour-long webinar on Daily School Attendance and Truancy Laws (https://www.youtube.com/watch?v=oiMTgWOrUUs) in December that was very well attended, so we are hosting a second webinar

(https://register.gotowebinar.com/register/7014266695998651228) at **10 a.m. on Wednesday**, **Jan. 17**. You can preview the presentation  $\bigsqcup$  (/Documents/II-Truancy-Att-Laws.pdf).

The webinar will provide information on compulsory attendance, provisions in School Code for serving chronically absent and truant students, and simple tips and additional resources for supporting attendance.

One special area of focus will be a reminder about the data-sharing requirements set forth in 105 ILCS 5/26-3a (https://www.ilga.gov/legislation/ilcs/fulltext.asp?DocName=010500050K26-3a). This law requires school districts to report all students who have either left school or been removed from the enrollment roster (except due to transfer) to their regional superintendent or county/district truant officer *each quarter*, so that appropriate follow-up can be conducted with students and families.

We will prepare and share a comprehensive FAQ at the end of the month, but I did want to address now the questions we received during the first webinar about 105 ILCS 5/26-12a (https://www.ilga.gov/legislation/ilcs/fulltext.asp?

DocName=010500050K26-12), which provides that "a truant minor may not be expelled for nonattendance unless he or she has accrued 15 consecutive days of absences without valid cause and the student cannot be located by the school district or the school district has located the student but cannot, after exhausting all available supportive services, compel the student to return to school." We wish to emphasize that districts can only remove a student from the roster after 15 consecutive days of absence if either the student *cannot be located or* the student can be located but has been provided all available supportive services and still refuses to return to school. This means that districts cannot remove a student because their family has taken an extended trip, for example, to visit relatives in another country. The district's knowledge that the student is on a trip and plans to return means they do not meet the statutory qualifications to be removed.

A district that is concerned about the impact of absences in these circumstances can engage their families and communities on the importance and impacts of attendance or to explore other solutions that may meet the needs of their communities, but if a district knows where a student is and that they are returning, the district cannot drop them from the rolls.

A school board could adopt a remote educational program policy for individual students to participate in with the consent of their parent/guardian, per 105 ILCS 5/10-29 (https://ilga.gov/legislation/ilcs/documents/010500050K10-29.htm). Please note that statute requires that the criteria for determining that a remote educational program will best serve the student's individual learning needs must consider, at minimum, the student's prior attendance, disciplinary record, and academic history. Statute also requires that the remote instruction must be aligned to state learning standards, must be consistent with the instruction and educational experiences given to students at the same grade level in the district, and must be delivered by licensed teachers.

In the words of the great Stephen Hawking, "Half the battle is just showing up." We thank districts, regional superintendents, truancy interventionists, and educators for everything you do to partner with families to support all students in showing up for school every day.

## FROM RELIEF TO RESILIENCE: MOKENA SCHOOL DISTRICT 159'S STRATEGIC INVESTMENTS IN EDUCATION POST-PANDEMIC

Mokena School District 159, a PreK-8 district in a southern suburb of Chicago, initiated a strategic planning process in April 2021 at a crucial time in the pandemic. The district engaged diverse stakeholders — school board members, parents, the community, and staff — to set a course for the district's advancement over the next five years.

The district strategically aligned its Elementary and Secondary School Emergency Relief (ESSER) funds to support the implementation of the goals within the plan. The first goal concentrated on enhancing English language arts (ELA) education by procuring comprehensive instructional materials for kindergarten through fifth grade. This investment in foundational skills, reading and writing programs, classroom libraries, decodable readers, and more, significantly impacted student learning.

"We were able to utilize these funds to provide our students and teachers with high-quality instructional materials based on current research in the field of literacy. The impact of this will be felt for years to come in our community," said Mokena Assistant Superintendent of Instruction Dr. Kristin Johnson.

ESSER funds also enabled the introduction of a STEM course at the junior high school level, fulfilling the strategic goal of fostering exploration in technology and engineering. The investment facilitated engaging programs and materials, encouraging students' involvement in design, modeling, app creation, architecture, and computer science.

"The new programming has quickly become one of our middle school's most popular electives. It is exciting to see our students engaged in learning technology and engineering skills," said Mokena Superintendent Dr. Mark Cohen.

The federal pandemic relief funding also supported the district's goal to provide interventions to students not yet meeting standards by hiring a reading interventionist, offering a summer school program, and providing after-school tutoring. Finally, funds were used to support the district's goals to improve technology infrastructure via a one-to-one initiative and to offer high-quality, intentional professional development. Professional development activities included an instructional coaching program and training for teachers in foundational skills, advanced word study, comprehension, and writing across content areas. These efforts led to smoother implementation of high-quality instructional materials.

The strategic use of ESSER funds directly influenced student learning outcomes, leading to growth far above average in the 60th percentile in ELA and 58th percentile in math. These efforts, together with the strategic plan, are propelling the district forward from the pandemic's aftermath and reinforcing its commitment to continuous improvement.

#### REACH AND SEL HUBS PARTNER FOR TRAUMA-RESPONSIVE PRACTICES

The REACH initiative is joining forces this spring with Social-Emotional Learning Hubs to unite school staff statewide around trauma-responsive practices. Regional Communities of Practice (CoPs) will enable educators to engage in hybrid sessions, combining in-person and virtual meetings, offering participants a chance to "learn, share, and grow" their school's trauma-responsive practices.

These tailored CoPs provide a platform for educators to exchange insights, experiences, and best practices and nurture inclusive learning environments. Participants collaborate and work on individual transformation over a series of sessions to create collective impact for school communities.

Three regional, hybrid CoPs (https://drive.google.com/file/d/1kAOuAqwS3VPaGVED-PXD5c3-6Ypv8Xaj/view) will be offered from mid-February to late May:

- Area 2 (Northwestern Illinois) Developing a Trauma-Informed School Climate
- · Area 3 (Western Illinois) Cultivating Holistic Wellness for Educators
- Area 4 (Eastern Illinois) Balancing Act: Nurturing Well-Being in Education

One special area of focus will be the reporting requirements set forth in 105 ILCS 5/26-3a (https://www.ilga.gov/legislation/ilcs/fulltext.asp?DocName=010500050K26-3a), which requires school districts to report quarterly to the regional superintendent or county/district truant officer all students having left school or been removed from the enrollment roster (except due to transfer).

## 2023-24 5ESSENTIALS SURVEY

The 2023-24 5Essentials Survey window will run from **Jan. 23-March 29**. Participation in the 5Essentials Survey or an approved alternate survey is required annually, as they are part of the non-academic indicators for the summative designation for accountability. We have been working with UChicago Impact to get data ready for loading to the survey administration system. Emails will be sent to administrators the Friday before the survey opens to give them access to their survey accounts. You can also review the Survey Administration Technical Assistance Overview recorded webinar (https://www.youtube.com/watch?v=dGxhHSpaaFQ). Other resources will be made available over the next two weeks.

ISBE encourages administrators to work with school personnel to ensure that students accounted for on the roster take the 5Essentials Survey using their state student ID number to log in. Provisional surveys are only to be used for students and teachers who are not listed on district rosters. As a reminder, principals and survey coordinators should not ask for or require teachers to submit proof that they have completed a survey. Doing so is in violation of the Ethical Code of Conduct (/Documents/Survey-Admin-Ethical-Code-of-Conduct.pdf).

# School Food Authorities Invited to Buying Local Foods Event
