#### Dear Colleagues:

Illinois educators have a lot to be proud of. According to U.S. News & World Report, our state ranks (https://www.usnews.com/news/best-states/rankings/education) #6 in the nation for prek-12 education. Six Illinois districts are among the top 20 public school districts (https://patch.com/illinois/across-il/2-illinois-school-districts-are-americas-best-niche-rankings-reveal) in the nation, including claiming the top two spots. Last year, the National Assessment of Educational Progress (aka "The Nation's Report Card") showed that our students scored above the national average in both reading and math for Grades 4 and 8, while many other states saw declines. And we rank #11 for youth mental health.

So why does Illinois have an average proficiency rate of 30.1%? What does that mean?

Illinois has the most rigorous standards in the nation. Each state measures "proficiency" differently. It's like comparing homeruns across ballparks with vastly different outfields or comparing someone's mile time on a flat track versus mountain terrain.

Being "proficient" in Illinois requires much more than reading on grade level. Our standards include a depth and breadth of higher order language arts skills, including writing, logic, critical thinking, and analysis. Out of five levels, only the top two count as "proficient" in Illinois. These high standards guide us to ensure our students are truly ready for rigorous content at the next grade level.

School context also matters. National research shows that schools' proficiency rates strongly correlate to the income levels of the families they serve. The schools that serve historically under-resourced communities, students in alternative schools, and high numbers of English Learners (who take these federally required accountability assessments in English, even though they have not yet mastered the language) have a steeper hill to climb to reach "proficiency" but are often achieving incredible things, as measured by graduation rates, the Seal of Biliteracy, participation in Advanced Placement, and other indicators.

That does not mean each school does not have room to grow. And we are growing. During the pandemic, the starting line got moved back significantly, but last school year, Illinois schools experienced accelerated growth, meaning they learned more and faster than in a typical prepandemic year. They may not have crossed that "finish line" into proficiency, but they made enormous progress given where they started. As lawmakers are developing the fiscal year 2024 budget, we are advocating for funding to continue accelerating students' growth and closing gaps: funding to expand high-quality preschool programs, so all children have access to the opportunities they need to be prepared for kindergarten, investments in Evidence-Based Funding to address historic inequities, and grants for districts with chronic teacher shortages. We are administering high-impact tutoring statewide to get students back on track from the pandemic. And last but not least, we are supporting the educators who show up every day to help our students succeed.

I encourage all schools to take this opportunity to share your story behind the data. The people pushing a narrative of failure are not connected to the reality within our schools. We have the opportunity in sharing our stories to do what we do best – to educate.

#### **GUIDE TO BRAIDING AND BLENDING FEDERAL FUNDS**

ISBE is pleased to partner with the Region 9 Comprehensive Center and share a new resource to support school districts in delivering cohesive programming through the coordinated use of federal, state, and local funds: *Braiding and Blending Federal Funds: A Step-by-Step Guide for Illinois Schools (/Documents/Illinois-Braid-Blend-Guide-508.pdf)*. The guide includes an overview of braiding and blending concepts and provides state-specific guidelines, planning tools, and other helpful resources. In addition to scenarios provided by ISBE staff, the guide includes examples from three Illinois school districts. We are grateful to staff at Joliet Township High School District 204, Danville Community Consolidated School District 118, and Harvard Community Unit School District 50 for sharing strong examples that demonstrate the coordination of financial resources to support student programs. This guide can be used as districts prepare to fill out the fiscal year 2024 Consolidated District Plan and consider strategies for sustaining successful programs beyond the Elementary and Secondary School Emergency Relief (ESSER) funds obligation window.

The webinar will begin with an overview of the guide and include a panel discussion with staff from the three districts that provided examples. #### ROAD2RECOVERY CAMPAIGN PUTS A SPOTLIGHT ON TEACHER MENTORING

The *Road2Recovery* campaign, marking the second anniversary of the American Rescue Plan, continues to elevate the people participating in the state-led Learning Renewal initiatives. ISBE used federal relief funds to partner with the Illinois Education Association and the Illinois Federation of Teachers on the Illinois Virtual Instructional Coach and Building Mentor Program (/Pages/Illinois-Virtual-Instructional-Coach-Building-Mentor-Program.aspx). The program is currently pairing 1,365 first-, second-, and third-year teachers and clinicians with mentors in their building and virtual instructional coaches to help guide them through these unique years of teaching. #### MINDFULNESS MONDAYS ARE ONE OF MANY WAYS AREA 5 SEL HUB IS SUPPORTING SCHOOLS

Many schools that have completed a trauma needs assessment are identifying the need to strengthen staff self-care. That's where the Area 5 Social-Emotional Learning (SEL) Hub comes in. Matt Weld, the SEL coach for the region, offers Mindfulness Mondays, where educators are invited to learn and practice self-care strategies, including breathwork, meditation, mindfulness, intention, and yoga. The series provides educators with space and time to learn strategies and skills that can help them not only better manage stress but also translate into the classroom as strategies to support students. Mindfulness Mondays are just one of many ways that the hub is supporting educators.

The hub offers frequent professional learning opportunities — over 600 workshops attended by over 6,800 people in just the last six months — on topics covering physical self-care practice, psychological practice, time management, stress management, what SEL is and how to interweave it into lessons at school, and trauma-informed basics. The hub supports the Teachers' Classroom podcast (https://www.teachillinois.com/podcast), which has dedicated its third season to conversations pertaining to mental health, equity, and trauma. Last month, the hub brought in some big-name presenters for a conference dubbed PEP Con (https://docs.google.com/forms/d/e/1FAIpQLSd7PZT-qVgbMn\_u\_udMf2UXH9-VN94Oc5x-

z1NyySfjlXINmw/viewform), or the Positivity, Energy, Purpose Conference. PEP Con is a good example of the way that the hub is cultivating a supportive and inviting climate and culture. This June the hub is hosting their next SEL-focused conference, Directions 2023: SEL, Trauma, & School (https://newdirectionseducation.weebly.com/).

#### NEW ISBE MAP SHOWS PARTICIPATION IN INITIATIVES DESIGNED TO SUPPORT PANDEMIC RECOVERY

ISBE has published a map showing participation across 11 initiatives designed to support the academic and social-emotional recovery of students. Illinois received nearly \$8 billion in federal relief funding, with 90% of funds flowing directly to districts. Ten percent of funds, totaling \$748.5 million, were allocated to ISBE for state-led initiatives. The map shows district or entity participation rates and can be filtered by program, entity, or geographical region. The demographic data of each district is shown on the second page of the map. #### FUTURE ENERGY JOBS ACT: MULTICULTURAL JOBS PROGRAM GRANT

The Illinois Department of Commerce and Economic Opportunity (DCEO) has released a Notice of Funding Opportunity (https://www.illinoisworknet.com/DownloadPrint/FEJA%20Multi-Cultural%20Jobs%20Program%20NOFO%202023%20-%20NOFO%20ID\_2875-2485.pdf) (NOFO) for the Future Energy Jobs Act Multicultural Jobs Program grant.

This program is designed to stimulate job growth in the clean energy economy. The goal of the NOFO is to provide training for clean energy-related occupations for diverse low-income or economically disadvantaged populations, including people who face barriers to employment (such as foster care system graduates or current enrollees, displaced energy workers, residents from Environmental Justice Communities, and people with low educational attainment or a criminal record).

Each grant is \$500,000.

DCEO will prioritize geographic diversity across Economic Development Regions and proximity to a Clean Jobs Workforce Network Program Hub Site. (See 20 ILCS 730/5-20.) Applications received from organizations located in or near the following areas that have been designated as locations for Clean Jobs Workforce Network Program Hub Sites will be prioritized as long as they meet all other eligibility and scoring criteria: Alton/East St. Louis, Carbondale, Champaign/Danville, Decatur, Peoria, and Rockford.

The application due date is **5 p.m. April 23**. The required forms and attachments, along with other useful state workforce resources for completing competitive applications, are posted on the Illinois WorkNet Center website (https://www.illinoisworknet.com/fejamulticulturaljobsnofo2023).

#### SECONDARY PERKINS PERFORMANCE INDICATORS NOW OPEN FOR PUBLIC COMMENT

The federal reauthorization of the Carl D. Perkins Career and Technical Education Act (also known as Perkins V) was signed into law on July 31, 2018. The purpose of this Act is to more fully develop the academic knowledge and technical and employability skills of secondary and postsecondary education students who elect to enroll in CTE programs. Perkins V requires secondary, postsecondary, and business/industry to work together to strengthen Career and Technical Education for students. The public comment period is open for the proposed revised State-Determined Level of Performance (SDLP) secondary performance indicators for 2S1, 2S2, 4S1 and 5S3. Section X – Accountability for Results in the approved Illinois Perkins V State Plan 🎽 (/Documents/Perkins-Plan.pdf) is being proposed for revision. Subsection a., which pertains to Secondary State-Determined Levels of Performance, runs from pages 84-88.

### NATIONAL SCHOOL LUNCH PROGRAM SURVEY

The U.S. Department of Agriculture has made funding available for schools in the National School Lunch Program to purchase local foods from August 2023 through December 2024. We need to hear from you to help us gauge interest, find out what schools are already doing, and develop resources to assist schools throughout Illinois!

We anticipate the survey could take as few as three to five minutes to complete. If your School Food Authority is already doing a variety of farm-toschool activities, it may take up to 10 minutes. We know your time may be limited but please know that your feedback will help food service programs throughout the state of Illinois and is extremely valuable. Here are a few pieces of information that you may want to look up or have handy when completing the survey:

- Your RCDT (Region County District Type) or Agreement number: This is a 13-digit number (XX-XXX-XXX) specific to each school district or School Food Authority. It can be found at the top of the screen in the Web-based Illinois Nutrition System (WINS) if you are unsure.
- If you do purchase any local foods currently: What types of foods and where do you get your local foods from (name of farmer, distributor, processor, co-op, etc.)?

- If you do NOT currently purchase any local foods: Provide us with feedback on what resources, training, etc. would assist you in purchasing local foods.
- We would like to know whether you would be interested if funds become available to purchase local foods. This is not a commitment; we are just gathering information to gauge interest.

### WHAT DOES THE END OF THE STATE'S PUBLIC HEALTH EMERGENCY MEAN FOR EDUCATORS?

Governor JB Pritzker announced (https://www.illinois.gov/news/press-release.25998.html/) that the state's public health emergency will end on May 11, aligning the state with the federal government's decision to end the national public health emergency. ISBE adopted rules (see Sections 25.25, 25.720, and 25.1015 of the Illinois Administrative Code) that waived or reduced professional educator license requirements during the public health emergency. The rules also provided a grace period that would extend beyond the lifting of the disaster proclamation before regular licensure requirements would resume. The governor's announcement has several implications for individuals seeking educator licensure in Illinois.

- The edTPA will be required again starting Jan. 1, 2024.
- Licensure content tests will be required prior to student teaching and prior to entering an alternative preparation program starting **Jan. 1**, **2024**.
- Candidates must pass any coursework started on or after May 12, 2023, and used toward licensure, with at least a C- (or equivalent).
- The application fee for a short-term substitute teaching license will be \$25 beginning **May 12, 2023**. The application was free during the time the disaster proclamation was in effect.
- Short-term substitute teachers assigned to teach in place of a licensed teacher under contract on or after **May 12, 2023**, can only teach for five consecutive days, rather than 15 consecutive days (which was allowed during the time the disaster proclamation was in effect).

The goal of FGSN is to connect first-generation college students with one another so they can support each other through this network, and for FGSN students to receive additional support year-round from our ISACorps of near-peer mentors. #### **MIGRANT STUDENT RECORDS EXCHANGE**

The Migrant Student Records Exchange Initiative (https://www2.ed.gov/admins/lead/account/recordstransfer.html) is a federal database, which was established under Title I, Part C of the Every Student Succeeds Act. The mission of the Migrant Student Records Exchange (MSIX) is to ensure the appropriate enrollment, placement, and accrual of credits for children of migrant agricultural workers nationwide. MSIX allows states to share educational and health information of migrant children who travel from state to state and who, as a result, have student records in multiple states' information systems. It works in concert with the existing migrant student information systems that states use to manage their migrant data.

The ISBE Multilingual Department manages access to MSIX in Illinois. If your district enrolls children of migrant agricultural workers and you would like more information about MSIX, please contact migrant@isbe.net (mailto:migrant@isbe.net).
