### Dear Colleagues:

Almost a decade ago, the Illinois State Board of Education adopted the Next Generation Science Standards (https://www.nextgenscience.org/) as the Illinois Learning Standards in Science (/Documents/II-Learning-Standards-Science.pdf). These standards articulate a transformational shift -- away from the traditional classroom experience that relies on students methodically reading a textbook, taking notes, and studying for an exam, and toward conducting investigations, gathering data, discussing open-ended questions and solving problems, while the teacher acts as their "quide

on the side." This strategy, designed to help students develop a deeper understanding of science beyond memorizing facts, is based on the Framework for K-12 Science Education developed by the National Research Council, and it has been dubbed "three-dimensional (https://www.nextgenscience.org/three-dimensional-learning)" science.

That doesn't mean making models of the solar system out of various playground balls. It means students learn to integrate three concepts: science and engineering practices (like asking questions, planning investigations, and analyzing data) with disciplinary content and crosscutting concepts. This overview for principals (https://www.nextgenscience.org/sites/default/files/resource/files/NGSS%20Overview%20for%20Principals\_0.pdf) helps explain what you will see when you stroll down the science wing in your school.

To support science educators in their efforts to achieve this shift, we have partnered with Southern Illinois University Carbondale (https://siu.edu/), the Illinois Science Teaching Association (https://ilscience.org/), and the National Science Teaching Association (https://www.nsta.org/) to create professional learning opportunities. Customized packages will be tailored for each of the seven ISTA regions. True to the three-dimensional science model, our team has launched this inquiry by asking questions and gathering data in the form of a needs-assessment survey (https://docs.google.com/forms/d/e/1FAIpQLSePQ5JUYUy-YMnw2xdJB\_21strE8rvrYRNrL4BbRnnpPhIjSw/viewform). We're asking all science teachers and administrators that oversee science curriculum to complete the survey to help design the professional learning package offered for your region.

This shift is important. Data from the Illinois Science Assessment shows that more than half of all Illinois students have not yet met our rigorous learning standards in science, and students of color are disproportionately identified as emerging or developing in proficiency when compared to their white peers. This data, sadly, is not surprising. National research (https://www.ecs.org/wp-content/uploads/CTE STEM-Desert-Brief FINAL.pdf) shows that students who attend the highest-poverty schools are least likely to have access to science, technology, engineering, arts, and math (STEAM) resources, experiences, and classes.

However, there's also good news all around us. Last weekend, Rochester 3A hosted a regional STEM Fair that included Springfield District 186's E-Sports League, where one athlete has earned a \$5,000 scholarship; Pleasant Plains CUSD 8, where elementary students learn to design, prototype, and refine tools using CAD, robots and 3D printing; and Rochester students demonstrating drones and robots navigating obstacle courses. In Lockport Township High School District 205, two of the district's Robotics Club teams have qualified for the VEX Robotics World Championship scheduled for Dallas later this month.

Science can be the spark that gets students excited about school and learning. We stand ready to help science educators develop new skills to help ignite curiosity. ### CPS SEL HUB USES HEALING-CENTERED FRAMEWORK TO ADVANCE SOCIAL-EMOTIONAL SUPPORT

The Chicago Public Schools (CPS) Social-Emotional Learning Hub is integrated into the CPS Office of Social-Emotional Learning, enabling the office to expand the breadth of support offered to the more than 600 schools in the city of Chicago.

The district is focused on a healing-centered framework (https://www.cps.edu/strategic-initiatives/healing-centered/) that emphasizes a whole child approach. Traumatic experiences can disrupt a student's ability to learn. The framework is designed to develop protective measures that can help mitigate the negative effects of trauma. Protective measures like healthy adult-child relationships, safe and supportive school environments, and targeted resources are all part of a system to invest in the wellness of students.

"We are doing this by making sure every school has tiered systems of support that integrate SEL practices throughout the school community. For example, all schools have access to mindfulness activities and techniques that they can use in the classroom, in small groups, and targeted individual sessions by teachers and counselors," said SEL Hub Director Adam King.

### ROAD2RECOVERY CAMPAIGN FEATURES ILLINOIS AFFINITY GROUPS

The Road2Recovery campaign is wrapping up with a look at the Illinois Affinity Group Network, led in partnership with Teach Plus Illinois. There are 44 affinity groups that bring together educators with common backgrounds to connect, learn, and discuss teacher retention. The data show that Illinois schools retain teachers of color at lower rates than their white counterparts, but those numbers are improving. The affinity groups for teachers of color discuss what can be done to better support and retain them because one of the best ways to meet the high demand for teachers in Illinois is to do a better job of keeping the teachers we already have.

Teach Plus Illinois is looking ahead to the next school year to build upon this network. ### **FUNDING & DISBURSEMENTS**

### FINAL FY 2023 STATE AND FEDERAL GRANT AMENDMENTS AND EXTENSIONS

Many state and federal grant projects are approaching a **June 30** end date for obligating fiscal year 2023 grant funds. All state and federal project end date extension requests and final budget amendments must be received by ISBE no later than 30 calendar days prior to the end date of the project.

#### As a reminder:

- An end date extension past June 30 is not needed for regular term staff salaries paid on a 12-month salary schedule.
- An end date extension past June 30 is not needed to pay obligations (e.g., purchase order for supplies) incurred June 30 or prior.
- An end date extension past June 30 is needed for new activities and obligations incurred July 1 or later (e.g., summer school, professional development).

Final amendments for state and federal grants with a project end date of June 30, 2023, must be received by ISBE no later than May 31.

Amendments for grants with a project end date of August 31, 2023, must be submitted by **August 1**. However, budget increases for FY 2023 state-funded grant projects must be received by June 30, even if the project end date has been extended. The deadline for grant applications in the electronic Grants Management System is also referenced on the Program Overview page under Amendment Due Date.

#### 2021-22 KIDS STATE REPORT

The 2021-22 Kindergarten Individual Development Survey (KIDS) state report is now available on the ISBE KIDS: Data & Reports webpage (/Pages/KIDS-Data.aspx). The report highlights results from the fall 2021 survey ratings. This year, the report includes enrollment data for prekindergarten and kindergarten students to provide a more complete picture of how the pandemic impacted kindergarten readiness.

Overall, Illinois saw a 1 percentage point decline in readiness from fall 2019 but still had an overall 4 percentage point increase from fall 2017. We continue to see the strongest readiness rates in social-emotional development, followed by language and literacy, then math. We look forward to continuing to discuss the results and to learning even more upon the release of the fall 2022 data in the coming months.

### PHYSICAL RESTRAINT, TIME OUT AND ISOLATED TIME OUT IMPORTANT DATES AND DEADLINES

The Student Care Department has updated its template for Physical Restraint, Time Out, and Isolated Time Out (RTO) Reduction Plans for the 2023-24 school year (/Documents/RTO-Reduction-Template.pdf). Each school board must create an oversight team, which is required to include teachers, paraprofessionals, school service personnel, and administrators. Such a team will develop school-specific plans for reducing and eventually eliminating the use of RTO, in accordance with ISBE goals and benchmarks, and procedures to implement the plan. This updated template includes a section that allows districts to complete the required progress reports for school year 2022-23 RTO Reduction Plans. Both RTO Reduction Plans for SY 2023-24 and progress reports for SY 2022-23 are due by **July 1**. The RTO Reduction Plan directions and checklist

(/Documents/RTO-Reduction-Plan.pdf) have also been updated. Please note the newly updated goals for SY 2023-24 are included in both the directions and template documents. RTO Reduction Plans and progress reports should be submitted to rtoreductionplan@isbe.net (mailto:rtoreductionplan@isbe.net).

Additionally, an alternative RTO reduction goal application (/Documents/Alternative-RTO-Reduction-Goal-Application.pdf) has been added. Any district that wishes to apply for an alternative RTO reduction goal must do so by **April 15**.

### SPECIAL EDUCATION

### **IDEA PART B STATE APPLICATION**

The federal fiscal year 2023 Individuals with Disabilities Education Act (IDEA) Part B annual state application is posted the ISBE Special Education webpage (/Pages/IDEA-Part-B-Grant-Program-Information.aspx). All states making application for funds under Part B of IDEA are required to make available for public review and comment the application packet for those federal funds. These are the funds that support provision of special education services to children ages 3-21 in Illinois. ISBE has developed the draft application packet for IDEA Part B funds and by this notice is making the application available for review and comment by Local Education Agencies, stakeholders, and the general public.

The application packet, developed by the U.S. Department of Education Office of Special Education Programs (OSEP), includes a summary of the assurances, certifications, and IDEA use of fund descriptions that the state will use to implement Part B of IDEA. Upon OSEP's approval of Illinois' Part B application, the state will receive a federal grant award under Part B of the IDEA for the period of July 1, 2023, through June 30, 2024.

As you review the application, please note the following:

- The application is in a format required by OSEP.
- Illinois is providing general assurances to OSEP that the state will be implementing the provisions of state and federal regulations for Part B of IDEA 2004.
- The dollar amounts listed in Section III, Use of Funds, are for State-Level Administration and Targeted Initiatives, not the cost of serving students with disabilities or the total cost of special education services in Illinois.
- The amounts for State-Level Administration and Targeted Initiatives are based upon the previous year (FFY 2022) allocation and will be
  updated when the FFY 2023 allocation is available.

The application is available for review on our website (/Pages/IDEA-Part-B-Grant-Program-Information.aspx) through May 20 for the required 60-day timeline. Written public comments on the draft Part B application packet may be submitted from April 20 until the close of business on May 20 for the required 30-day timeline. - · Identification of energy efficiency project incentives and third-party funding sources

Completing the PSCFA can also help with grant qualification. For instance, to qualify for a grant under Section 5-40 of the School Construction Law, a public school district must submit a copy of a PSCFA report (if a PSCFA has been performed) or request the PSCFA and submit a copy as soon as it becomes available. ComEd will file the PSCFA report on your behalf.
