### Dear Colleagues:

Literacy is a fundamental right, the key that unlocks the door to active participation in 21st century life. Last week, ISBE released the first draft of the Illinois Literacy Plan (/Documents/Illinois-State-Literacy-Plan-Draft.pdf), which puts forth the necessary components of an effective literacy education system for our state.

Our goal is to enter 2024 with a final literacy plan. First, we need your feedback. We are conducting a statewide listening tour (https://isbe.net/Pages/Illinois-Literacy-Plan.aspx), starting tomorrow in Springfield, followed by stops in Chicago, Rockford, and Mount Vernon, and a virtual event, to gather feedback on the

plan. We encourage you to attend or to provide input through our online comment form (https://forms.office.com/r/Sv0KxXF8KA). We will incorporate your feedback into a second draft and then conduct another listening tour in the fall.

Why do we need a literacy plan? Unlike language development, literacy is not hard-wired into a child's brain. Developing literacy requires direct and purposeful instruction. It is not a natural process. Likewise, ensuring all children have access to effective literacy instruction requires direct and purposeful action by policymakers, educator preparation programs, school and district leaders, teachers, and families. There is no cure-all, one-and-done professional development course that will transform literacy instruction in Illinois. Our current outcomes show that we need coordinated action at every level to reshape how we prepare and support educators to teach literacy.

ISBE began developing the Illinois Literacy Plan this past fall by convening dozens of experts from across the country and the state to explore evidence-based instructional practices in literacy. More than 60 individuals from school districts, higher education, advocacy groups, and state professional associations participated in our literacy summit (https://isbe.net/Documents/102522LiteracySummitSummary.pdf). The resulting Illinois Literacy Plan draft assembles the best thinking from experts, educators, and advocates across the state to align on a unified vision for literacy instruction in Illinois.

Literacy is more than just the ability to read. It's the ability to understand, critically evaluate, and communicate about complex texts in diverse settings – it's the ship we sail in to navigate the world of ideas around us. I invite you to join us in strengthening the Illinois Literacy Plan by giving us your feedback. We owe the children of Illinois the opportunity to develop a literacy skillset that will empower them to traverse waters of all depths.

#### AFFINITY GROUP NETWORK SERVES OVER 550 EDUCATORS IN INAUGURAL YEAR

As the 2022-23 school year wrapped up, so did the first year of the Illinois Affinity Group Facilitator Network. The network, in partnership with Teach Plus Illinois (https://teachplus.org/il/), was designed to bring together groups of teachers of color to identify ways to better retain educators of color. Forty-two affinity groups formed during the inaugural year. They served more than 550 educators of color from over 60 school districts.

Why do affinity groups matter? Facilitator Dr. Tracee Wells, a learning loss instructional support specialist in East St. Louis School District 189, has some thoughts:

"It has been my honor to serve as an affinity group facilitator to novice and experienced teachers. The daily stress, trauma, and racial battle fatigue that educators feel are real. Our affinity spaces are sources of strength, advocacy, and healing where educators come to relax, rejuvenate, and receive support and tools to navigate responsibly in their buildings and classrooms. This work is necessary. Teach Plus Illinois has prepared me to lead this work in Southwest Illinois with grace and humility, helping our educators build collective power. Teachers of color no longer have to just press through. They can move through with support and confidence together with other educators of color, as we work through the challenges of teaching today."

# **ILLINOIS REPORT CARD**

## KICKING OFF REPORT CARD 2023: PROCESS AND TIMELINE OVERVIEW

### STUDENT DISCIPLINE DATA REPORTING

Starting this year, there will be a section on the Illinois Report Card regarding student discipline. Additionally, ISBE publishes a list of the top 20 percent for exclusionary discipline (suspensions, expulsions, and racial disproportionality) on Oct. 31 of each year. Districts identified in the top 20 percent are required to submit a discipline improvement plan each year they are identified. It is imperative that all districts submit their discipline data each year to ensure that the top 20 percent list is equitable and accurate. Please submit your district discipline data to the Student Information System by **July 31**. ## FY 2023 EL-EBF EXPENDITURE REPORTING NOW AVAILABLE IN IWAS

Districts may now report their total FY 2023 English learner (EL)-Evidence-Based Funding (EBF) expenditures in IWAS. All districts should report direct costs from July 1, 2022, through June 30, 2023.

The FY 2023 EL-EBF expenditure reporting shows where EBF funds attributable to ELs were ultimately spent within each district. Only districts that received \$5,000 or more in total FY 2023 EL funds are required to submit an expenditure report through the period ending June 30. Any FY 2022 EL-EBF funds not expended in FY 2022 will appear in the FY 2023 expenditure report. # SAFE & HEALTHY CLIMATE

### MENTAL AND BEHAVIORAL HEALTH SCREENING LISTENING SESSIONS

ISBE is administering a one-time landscape scan of all school districts in Illinois regarding mental and behavioral health screening of students, pursuant to Recommendation 9 in the February 2023 Blueprint for Transformation: A Vision for Improved Behavioral Healthcare for Illinois Children (https://www2.illinois.gov/sites/gov/Documents/childrens-health-web-021523.pdf) report and in accordance with Senate Bill 724. The landscape scan consists of a listening tour and an online feedback form.

ISBE is also collecting feedback through an online survey. The feedback form is short - 14 questions if a district already administers some form of screening and three questions if a district currently does no form of mental health screening. The survey is available to all districts and Regional Offices of Education and Intermediate Service Centers in the IWAS system listing under "surveys" and will remain open until early September.

#### FAITH'S LAW RESOURCES

Faith's Law was passed by the 102nd General Assembly as two separate pieces of legislation. The first piece of legislation, Public Act 102-0676 (https://www.ilga.gov/legislation/publicacts/102/102-0676.htm), took effect on Dec. 3, 2021. The second, PA 102-0702 (https://www.ilga.gov/legislation/publicacts/102/102-0702.htm), will take effect on **July 1, 2023**. Both public acts created new requirements that take effect at different dates.

#### SEXUAL HEALTH EDUCATION SURVEY

Public Act 102-0522 requires ISBE to survey all public school districts on comprehensive personal health and safety and comprehensive sexual health instruction annually for five years. The survey for school year 2022-23 has been released to all districts in IWAS under "System Listing." The "Surveys" category will remain open until **July 21**. The survey is titled "PA102-0522 Sexual Health Education Survey." All districts must complete

this short survey, even if they are opting not to provide sexual health instruction. Please ensure the survey is completed by the person in your district who oversees sexual health education instruction.

# **EARLY CHILDHOOD**

#### FY 2024 EARLY CHILDHOOD BLOCK GRANT

The fiscal year 2024 Early Childhood Block Grant application deadline has been extended to **4 p.m. June 30**. The FY 2024 state budget includes an additional \$75 million to expand access to preschool across the state. The application prioritizes providers in identified preschool deserts (/Pages/ECBG-Preschool-Deserts.aspx) where low-income children lack sufficient access to publicly funded preschool. Access the application, technical assistance webinars, and other resources on the ISBE website (https://isbe.net/preschool). A wide range of providers -- from school districts, to child care centers, to community-based organizations -- are eligible to apply. Help ISBE spread the word about these available funds for preschool by utilizing the communications toolkit (/Pages/ECBG-Communications-Toolkit.aspx).

Providers that need assistance meeting the program requirements for licensed staff can learn more about the Early Childhood Access Consortium for Equity Scholarship Program (https://www.isac.org/ECACEscholarship). Scholarships are available for undergraduate and graduate study. Eligible applicants are individuals currently working or who have worked in the early childhood field, including in home-based or center-based child care; who have obtained membership with the Illinois Gateways to Opportunity Registry (https://www.ilgateways.com/credentials); and who are enrolled or accepted to enroll in an eligible program at a participating institution in pursuit of an associate, bachelor's, or master's degree in early childhood or an additional license or endorsement in the field.

ISBE also offers temporary licenses called short-term approvals (https://isbe.net/Pages/educator-licensure-approvals.aspx) for qualified individuals to start teaching immediately while working toward permanent licensure.

# **TFACHING & I FARNING**

### TEACHER VACANCY GRANT PILOT PROGRAM

The Teacher Vacancy Grant pilot program provides the state's most understaffed districts with resources to attract, hire, support, and retain teachers. The grant allows districts maximum flexibility to use allocated funds in innovative, creative, and evidenced-based ways. This may include signing bonuses, housing stipends, down payment assistance, or loan repayments; tuition and fees or funds for residencies or apprenticeships; or materials, supplies, coaching, and school culture supports to sustain employment of current teachers.

ISBE has identified 170 school districts in Evidence-Based Funding Tiers 1, 2, and 3 (as calculated for FY 2023) as eligible to receive awards, based on the highest counts of unfilled teaching (not administrative or school support) positions and to ensure that 60 percent of awards go to rural districts and 40 percent to urban districts. Eligible districts (/Documents/TVG-Methodology-District-List.pdf) have received direct communication from ISBE. Districts in Tier 4 and those that reported having no unfilled teaching positions at the beginning of the 2022-23 school year are ineligible for this program.
