Dear Colleagues:

Illinois' new Learning Standards (/sexualhealth) for Comprehensive Personal Health and Safety and Sexual Health Education aim to empower students in all grades with the information they need to recognize abuse, make empowered choices, and form healthy relationships.

While some of these topics may be new for the instructional context, we know they are not new to our students. Even when we were in school, misinformation about these topics was rampant and harmful. Today, with almost universal access to the internet and cell phones at all ages, our students need access to this information from trusted and reliable sources now more than ever.

School districts are **not** required to teach sex education. For districts that choose to teach these topics, Illinois' updated standards provide a guide for age-appropriate, inclusive, and medically accurate instruction in all grades.

The standards are developmentally appropriate. Just like in math, what students learn in kindergarten is very different from what students learn in high school.

Children are most vulnerable to abuse between ages of 7 to 13. In elementary school, the standards set a foundation for safety by teaching about consent, boundaries, and healthy relationships. In middle school, the standards address dating violence prevention, which evidence shows contributes to reduced sexual harassment among peers. In high school, the standards help students gain skills and tools to make the right choices for themselves about relationships, pregnancy, and sexual health. Research demonstrates that comprehensive personal health and safety instruction for students in all grades promotes self-confidence and prevents health problems, unintended pregnancy, and many forms of abuse and violence.

School districts continue to have local control over curriculum, including how much time they spend on different topics and what instructional materials they use. This flexibility allows every district to address these topics in ways that are appropriate for their specific community context, while still being inclusive, age-appropriate and medically accurate. We collaborated with a working group to provide a wealth of resources (/Pages/Sexual-Health-Resources.aspx) on the ISBE website to support school districts in adapting their curriculum to the new standards.

Parents are looped in every step of the way, first and foremost by having the ability to opt their student out of instruction. The law (https://www.ilga.gov/legislation/fulltext.asp?

DocName=&SessionId=110&GA=102&DocTypeId=SB&DocNum=818&GAID=16&LegID=&SpecSess=&Session=) that required ISBE to adopt the new standards also added new layers of transparency for parents, requiring school districts to publish the name of the curricula they're using, notify families of the scope and sequence of instruction, and provide information on how to opt their student out. ISBE has developed a one-pager in multiple languages that districts can distribute to families to help describe the importance of sexual health education:

Please note that the standards are required for any district that chooses to teach comprehensive sexual health education. For districts that elect not to teach sex education, topics that fall under separate instructional mandates 4 (/Documents/IL-Mandated-Units-of-Study.pdf) must continue to be taught.

We understand that there will be a transition period as school districts review the standards and engage their local communities. Ultimately, the goal of the standards is to empower all students with the information they need to safeguard their personal health. UPDATED COVID-19 GUIDANCE AND DECISION TREE

The Illinois Department of Public Health (IDPH) and ISBE have updated the Joint Guidance for COVID-19 Prevention in Schools (https://dph.illinois.gov/covid19/community-guidance/school-guidance.html), fully adopting the Centers for Disease Control and Prevention Operational Guidance for K-12 Schools and Early Care and Education Programs to Support Safe In-Person Learning (https://www.cdc.gov/coronavirus/2019-ncov/community/schools-childcare/k-12-childcare-guidance.html? CDC_AA_refVal=https://www.cdc.gov/coronavirus/2019-ncov/community/schools-childcare/k-12-guidance.html) (updated as of Aug. 11). This updated guidance supersedes all prior COVID-19 school guidance documents and applies to public and nonpublic schools that serve students in prekindergarten through Grade 12. The Decision Tree Recommendations for Evaluating Symptomatic Individuals from Pre-K, K-12 Schools, and Day Care Programs (https://dph.illinois.gov/covid19/community-guidance/school-guidance/covid-19-interim-exclusion-guidance-for-schools.html) has also been updated.

CAHOKIA UNIT SCHOOL DISTRICT 187 STUDENTS RECEIVED A JUMP START HEADING INTO A NEW SCHOOL YEAR

Students at Cahokia Unit School District 187 were not immune to the effects of the pandemic. District staff noted that while all students were academically and socially impacted by the pandemic, their youngest learners experienced the greatest setbacks. That's where Jump Start, funded with federal pandemic relief funds, came in. The goals of the district's Jump Start program were to increase academic instruction time to help decrease learning loss and mitigate the typical summer slump; continue to develop the social emotional skills critical to early childhood development; and provide enrichment opportunities for students to apply academic and social skills in an interactive, hands-on setting. The academic focus for the summer program aligned to the district's kindergarten exit criteria. The participating pre-K students worked hard on writing their names, often a skill mastered by most youngsters in early to mid-year kindergarten. Staff reported that all but one student was able to write his/her first name from memory. In addition, all but three wrote their first and last name from memory. District staff noted that while one may deem this a small success, these students gained a valuable skill that boosted their confidence, self-esteem, and writing skills moving forward to next school year. State Jump Start grants have closed, but school districts can use their federal pandemic relief funds for Jump Start programs to prepare students for a successful kindergarten experience.

REACH STATEWIDE INITIATIVE SEEKING FACILITATORS FOR TRAUMA-RESPONSIVE COMMUNITIES OF PRACTICE

As part of the REACH Statewide Initiative (https://childhoodresilience.org/reach), the REACH Communities of Practice are seeking mental health professionals and educational consultants to apply as facilitators to support both the live, virtual activities and the management of the online community. The Communities of Practice (https://childhoodresilience.org/communities-of-practice), led by Partnership for Resilience in collaboration with Lurie Children's Center for Childhood Resilience, are groups of school community members from across the state who share a common interest in a topic related to trauma-responsive practices in schools and come together regularly to fulfill individual and group goals related to trauma-responsive practices. NATIONAL BOARD CERTIFICATION STATE FALL SUBSIDY WINDOW OPENS SEPT. 1

Would you like to begin your journey to becoming a National Board Certified Teacher? The state fall subsidy

(https://nbrc.illinoisstate.edu/firsttime/index.php) window is open **Sept. 1-Oct. 11**. This subsidy pays for all fees related to the process. There is a \$75 nonrefundable registration fee. This is the only cost a teacher or school counselor will incur.

Free support is available throughout the certification process, and support sessions are anticipated to begin in this fall.

EDUCATOR EVALUATION FLEXIBILITY

Per Public Act 102-0729 (https://ilga.gov/legislation/publicacts/fulltext.asp?Name=102-0729) – for the 2022-23 school year only – if the Governor has declared a disaster due to a public health emergency pursuant to Section 7 of the Illinois Emergency Management Act, districts may waive the evaluation requirement of all teachers in contractual continued service whose performances were rated as either "excellent" or "proficient" during the last school year in which the teachers were evaluated. The legislation does not specify when the disaster declaration must be in place to allow for this flexibility, but ISBE has interpreted that it applies as long as a disaster declaration due to a public health emergency is in place at the start of – or issued at any point during – the 2022-23 school year. The most recent disaster proclamation was issued Aug. 19.

To the extent possible, we encourage school districts to continue the practice of summative evaluations as a means of recognizing and improving the performance of educators by identifying areas of strength and support. Teacher evaluations provide an opportunity for administrators to observe teachers and to ensure they are providing high-quality, rigorous instruction and meaningful feedback to their students. These observations inform how administrators support teachers who are struggling with the ongoing challenges of the pandemic.
