Dear Colleagues:

I would like to honor the memory of former State Board of Education member and vice chair Dr. Christopher J. Ward. He served as the longtime superintendent of Lockport Township High School District 205 in the southwest suburbs of Chicago. His leadership had a remarkable impact on the school community. He was a friend, mentor, and role model to many. The state of Illinois owes him a debt of gratitude for his service. He will be missed.

Today's message is really a save-the-date: On Oct. 4, 6, and 24, ISBE will host hearings to receive

input from educators, parents, students, and community organizations on state funding priorities for public education. You are invited to participate. You are the ones who know what your districts and schools need; your information and requests will help guide the Board's advocacy for equitable funding for all students in fiscal year 2024.

Testimony at past hearings has led to increased investments in parent mentoring, after-school programs, the Early Childhood Block Grant, and Evidence-Based Funding. Now more than ever, we want our school leaders, classroom teachers, caregivers, and community advocates to tell us what investments would have the most positive impact in the lives of their students.

If you would like to submit a funding request, your first step is to fill out a budget request funding form (/budgetrequestform) online. We have simplified this form since last year thanks to your feedback. All requests must be submitted in writing through this form. You do not have to speak at a hearing, and I assure you that we give equal weight to all written and oral testimony. However, if you would like to speak at one of the three hearings, you can register in advance for either of the virtual hearings Oct. 4 and Oct. 24 or attend in-person the hearing in Springfield Oct. 6.

All three hearings are scheduled during "after-school" time, 4-7 p.m. We have detailed instructions for submitting the budget requests available on the ISBE website (/budget).

It is our responsibility to advocate for every child across the state of Illinois, and we take that duty seriously. Your input can help us make a persuasive argument to lawmakers and state officials about the specific needs of our students and educators. I look forward to reading your requests and seeing you at these hearings.

ESSER FUNDS: STAYING THE COURSE WITH IMPLEMENTING RULER DISTRICTWIDE

Before the COVID-19 pandemic hit, Arlington Heights School District 25 had a plan in place. It intended to implement a new social-emotional learning (SEL) curriculum (https://www.sd25.org/Page/1622), RULER, with staff in the fall of 2020, with students in the fall of 2021, and finally with the full community in the fall of 2022.

RULER is an acronym for five skills of emotional intelligence: Recognizing, Understanding, Labeling, Expressing, and Regulating. When the pandemic closed school buildings in March of 2020, district leaders asked themselves, "Should we push it off? Do teachers and staff have too much to worry about right now? Will RULER work remotely?"

"Once the pandemic hit, we knew the community would crave the tools and teachings that RULER has to offer," Assistant Superintendent of Student Learning Dr. Becky FitzPatrick said. "Rather than veer off course, we realized this curriculum was needed now more than ever."

So, the district administration prioritized RULER by creating SEL facilitator positions at each building. Their job was to learn the RULER curriculum and help support its implementation for the next three years. These SEL facilitators were paid a stipend and were filled by a variety of staff from across the buildings.

"In addition to supporting the core subject areas with our ESSER funds, like reading, math, science, and social studies, we wanted to focus on the social-emotional support for our community," FitzPatrick said. "We knew, long term, this would also be a perfect and justified use of some of our ESSER funds."

Last school year, District 25 successfully began rolling out the RULER curriculum to its families on time and with heavy impact. It has been a welcomed exhale in the midst of the COVID-19 pandemic.

GET READY FOR THE 2022 ILLINOIS REPORT CARD

Get ready for the 2022 Illinois Report Card! The Illinois Report Card is released annually by the Illinois State Board of Education and offers a snapshot of school performance in order to inform and empower educators, families, and communities as they support their students.

The Illinois Report Card will be published at www.illinoisreportcard.com 9 a.m. Oct. 27. All public schools will receive a new summative designation on the 2022 Illinois Report Card for the first time since 2019, identifying some schools to start school improvement support through IL-EMPOWER. The 2022 Illinois Report Card will also feature a new informational data element called the Equity Journey Continuum. Stay tuned for more information about the 2022 Illinois Report Card, what's new this year, how to prepare, and opportunities to tell your school's story beyond the data.

ISBE RELEASES ACCELERATED PLACEMENT SUPPORTS

Did you know that recent changes to the School Code require districts to update their acceleration policy before the 2023-24 school year? Are you looking for guidance related to that requirement? ISBE has worked with a group of educators, administrators, and the Advisory Council on the Education of Gifted and Talented Children (/Pages/Advisory-Council-Education-Gifted-Talented-Children.aspx) to develop support documents.

Public Act 101-0654 (https://www.ilga.gov/legislation/publicacts/101/101-0654.htm), enacted in spring 2021, amended Article 14A of the School Code (https://www.ilga.gov/legislation/ilcs/ilcs4.asp?

DocName=010500050HArt.+14A&ActID=1005&ChapterID=17&SeqStart=120637500&SeqEnd=123000000). It specifies that, by no later than the beginning of the 2023-24 school year, a school district's accelerated placement policy shall allow for the automatic enrollment in the following school term of a student into the next most rigorous level of advanced coursework if the student meets or exceeds state standards in English language arts, mathematics, or science on a state assessment. This amendment applies to K-12 grade levels.

The newly released Accelerated Placement Guidance (/Documents/Accelerated_Placement_Act_Guidance.pdf) provides guidance for schools as they update their accelerated placement policy.
