Last week, I had the honor of visiting Huntley Community School District 158 (https://huntley158.org/) – one of two Illinois school districts that earned a 2022-23 Green Ribbon award from the U.S. Department of Education. This week, you have the chance to apply for the 2023-24 Illinois Green Ribbon Schools Award (https://www2.ed.gov/programs/green-ribbon-schools/index.html) to share your great work. This initiative is designed to recognize and celebrate the unwavering commitment of our schools, districts, and institutions of higher education to environmental education and sustainability.

In Brief

Huntley 158 and Prairie Trails School (https://www.rtsd26.org/schools/pt) of Mount Prospect were selected as 2022-23 Green Ribbon winners for their comprehensive approach to environmental education and management. Schools dedicated to green initiatives play a major role in molding our students into responsible stewards of our planet. We take pride in acknowledging schools that have made remarkable strides in reducing their environmental impact, promoting health and wellness, and offering sustainability education.

Hosting the Illinois Green Ribbon Schools program is just one way we can celebrate green initiatives across the state. We also celebrate green initiatives through curriculum. As a state with local control, each school district's board has the responsibility to choose the curriculum and instruction that best suit the needs of its student population and community, and to offer courses that meet Illinois' graduation requirements. The Illinois Science Learning Standards 🚰 (/Documents/II-Learning-Standards-Science.pdf) align with green initiatives by addressing climate change, the functioning and resilience of ecosystem dynamics, and the value of biodiversity. These standards complement the existing instructional mandate that all schools in Illinois must include instruction, study and discussion of current problems and needs in the conservation of natural resources, including pollution, waste reduction and recycling, the effects of excessive use of pesticides, preservation of wilderness areas, forest management, protection of wildlife and humane care of domestic animals.

Huntley was recognized for its water waste reduction, investment in solar energy, community health initiatives, and opportunities for students to explore the impact of sustainability. The district has cut its energy costs by more than 50 percent since 2009, thanks largely to operational changes in equipment and equipment programming, upgrading lighting and HVAC and then tying it to occupancy sensors. In the fall of 2020, Huntley "flipped the switch" on the largest solar energy installation on school district property in Illinois, with three large solar installations totaling 15,100 panels across three campuses, offsetting some 12.3 million pounds of carbon emissions annually.

If your campus can't match that kind of effort right now, don't give up. Huntley also uses an assortment of much smaller efforts, like barrels to collect rainwater, a Food Sharing Table where students can leave lunch items they know they won't eat (saving on waste while reducing food insecurity), "dump and recycle" stations where students can empty their drink containers and send them to recycling, and bulk condiment stations in lunchrooms, to avoid throwing 2,400 little ketchup, mayo, mustard and ranch packages into landfills. As Huntley school officials wrote in their Green Ribbon application: "The first step toward a greener future, where energy bills are smaller and tax dollars can be saved, is to simply start somewhere."

We can all start where we are and choose the path that leads toward a healthier environment. It's important to do whatever we can to invest in our students' future.

### UNLOCKING ACADEMIC SUCCESS: THE ILLINOIS TUTORING INITIATIVE'S COLLABORATIVE APPROACH SHINES

The Illinois Tutoring Initiative exemplifies the power of collaborative partnerships among state agencies, higher education institutions, and K-12 priority school districts in their collective mission to support student learning in reading and math. This comprehensive effort spans Grades 3 to 8, extending support to high school math tutoring as well.

Early research 🛁 (https://illinoistutoringinitiative.org/wp-content/uploads/Student-and-Tutor-Outcomes-Report-AY-2022-23-Final-8.18.23-1.pdf) indicates that this approach is working in partnership with institutions of higher education across the state, including Governors State University; Northern Illinois University, Illinois Central College, Illinois State University, Southern Illinois University Edwardsville, Southern Illinois University Carbondale, and Southeastern Illinois College. These institutions hire, train, and oversee tutors in their region. ISU also provides overall project management for the initiative, including tutor training and development, tutor matching and scheduling, data collection, and research.

A focus on relationships and connection to the local curriculum are key features of high-impact tutoring. The approach offers adults the time and resources to understand students, consider their needs, and provide the support for them to be able to truly succeed in school and beyond. Pairing students with an adult who understands their community and shares similar lived experiences can significantly benefit student development (https://studentvoiceforum.org/students-stand-to-benefit-from-diverse-teachers-e1fff085ad3e) and learning and deepen relationships. Sessions include instruction and guided practice directly connected to what students are learning in their classrooms, providing added benefit.

Angie Saldana served as tutor during the 2022-23 school year. Ms. Saldana, a teacher education candidate at Northern Illinois University, shared her experience in the program, stating, "For all my students I have tutored I've seen that at first, they are very shy and quiet. They don't like to talk, but they are willing to work on the problems and activities I have provided. This changes over time as they start to open up and get out of their comfort zone. Some other changes I notice are their improvement in the subject I am tutoring, and they tell me how happy they understand the material."

The initiative used the National Student Support Accelerator's Tutoring Quality Improvement Scale

(https://studentsupportaccelerator.com/tqis/quality-standards) during the design phase to ensure strong alignment to all of these research-based strategies and features. School districts interested in high-impact tutoring still have time to leverage Elementary and Secondary School Emergency Relief funding to implement programming at the local level. The National Student Support Accelerator offers a District Playbook (https://studentsupportaccelerator.com/district-playbook) to develop and implement high-impact tutoring programs with quality.

### STRONG TUTOR-STUDENT RELATIONSHIPS AND ENHANCED TUTOR EFFICACY DRIVE SUCCESS WITH THE ILLINOIS TUTORING INITIATIVE

The Illinois Tutoring Initiative recently released a report 🛁 (https://illinoistutoringinitiative.org/wp-content/uploads/Student-and-Tutor-Outcomes-Report-AY-2022-23-Final-8.18.23-1.pdf) on its high-impact tutoring program, revealing that more than 70% of tutored students exhibited expected or better growth in reading and math. High-impact tutoring is deliberately designed with several crucial components, and research (https://eleducation.org/resources/relational-trust-in-schools) consistently shows that positive student-teacher relationships significantly boost academic success. To achieve this, the initiative prioritized providing well-trained tutors who engage students individually or in small groups at least three times a week for a minimum of 30 minutes, focusing on building strong connections. The program places a strong emphasis on tutor training, ensuring tutors have the necessary resources and support. Tutors saw substantial improvements in their confidence and effectiveness as they assisted students during the 2022-23 academic year. Training covered critical thinking, assessment of student comprehension, and diverse teaching methods. This boost in self-efficacy is crucial for tutors as it positively impacts their ability to set goals and excel in their work with students.

#### National Board First Time Candidate Fee Subsidy

The National Board Resource Center (NBRC) at Illinois State University (https://nbrc.illinoisstate.edu/) invites state educators and school counselors to take advantage of first-time applicant funding. Funds will cover the cost of components while pursuing National Board Certification. In addition, NBRC offers support options throughout the process.

Current Illinois full-time educators and school counselors who teach in a public school and who have not previously taken advantage of the firsttime state subsidy are eligible to apply. The subsidy application is available through **Oct. 11**.

#### National Board Certified Teacher Intent to Mentor

National Board Certified Teachers (NBCTs), National Board Certified retired educators, and National Board Certified school counselors are invited to apply as a mentor (https://nbrc.illinoisstate.edu/mentor/) to support candidates pursuing National Board certification. Eligible educators, retirees, and counselors are eligible to clock up to 45 hours of mentoring and/or professional development. The application is available through **Feb. 23**, **2024**.

#### Illinois National Board Maintenance of Certification Fee Subsidy

NBRC invites National Board Certified teachers/counselors, pending renewal, to take advantage of the Maintenance of Certification Fee Subsidy. Renewal of National Board certification enables NBCTs to demonstrate that their professional practice remains consistent with the high and rigorous standards of their subject area. The certification fee of \$495 will be paid to NBCTS after determining eligibility. The subsidy window is open through **Jan. 19, 2024**. #### Illinois National Board Retake Candidate Fee Subsidy

NBRC offers a retake subsidy for National Board candidates who plan to resubmit a component. If you are a candidate who has completed all four components and received scores for each, you are eligible to apply for funding (https://nbrc.illinoisstate.edu/candidates/retake/). The application is available through **Jan. 19, 2024**.
