Dear Colleagues:

We publish the Illinois Report Card at the end of October. School districts have had since the summer to review and, if necessary, correct their data. However, several school districts recently identified inaccuracies in the attendance data they submitted related to the appropriate coding of students receiving remote instruction. ISBE is statutorily obligated to publish the Illinois Report Card by the end of October. To meet that deadline while also ensuring maximum data integrity and accuracy, ISBE will provide a one-time, final 48-hour opportunity for school districts to provide corrections to school year

2021-22 attendance data only in the Student Information System. There will be no changes to 2021-22 school year student enrollment data.

Please ensure your attendance data is correct for the 2021-22 school year in the Student Information System by the end of the day on Friday, Oct. 14. Changes that we receive during this window may impact the preliminary school summative designations that have been available in Educator Preview since Oct. 3. As always, please keep in mind that all Report Card data is preliminary and subject to change until it is officially published on www.illinoisreportcard.com (http://www.illinoisreportcard.com/). Please see below for more information on this topic and thank you for your cooperation.

October is also Bullying Prevention Month and an opportunity to reinforce the importance of creating welcoming, inclusive learning environments. Bullying doesn't affect just the student being targeted; the effects spread through the classroom and hallways. Just witnessing bullying, and realizing that it's tolerated, undermines children's sense of safety, sense of belonging, feelings of value, and ability to learn.

In 2019, the National Center for Educational Statistics issued a report (https://nces.ed.gov/pubs2019/2019054.pdf) that shows one out of every five students reported being bullied – and most students do not notify an adult at school. That means it's on us as educators to pick up on cues and provide support. Another study (https://njbullying.org/documents/YVPMarch2010.pdf) asked students what teachers can do to help, and students said the most helpful things we can do are to listen to them, check in with them afterwards to see if the bullying stopped, and give them advice. Students said the worst things teachers can do are to tell them to solve the problem themselves, that the bullying wouldn't happen if they acted differently, or to tell them to stop tattling.

National Coming Out Day is celebrated on Oct. 11. Our LGBTQ youth (https://www.hrc.org/news/new-cdc-data-shows-lgbtq-youth-are-more-likely-to-be-bullied-than-straight-cisgender-youth) are even more likely to experience bullying than their straight, cisgender peers. Students who are bullied out of bias – for their race, disability, sexual orientation, or other attributes – can experience severe emotional and physical health effects, putting them at increased risk for depression, anxiety, sleep difficulties, lower academic achievement, and dropping out of school.

Researchers have found that students who experience bullying find peer actions most helpful. There are many ways to cultivate a culture of caring and inclusivity in our schools:

- An organization called PACER, formed in the 1970s by parents of children with disabilities, offers a full range of anti-bullying resources on its website (https://www.pacer.org/bullying/es/), including bullying prevention resources in Spanish (https://www.pacer.org/bullying/es/), and a Q&A column (https://pacerkidsagainstbullying.org/what-is-bullying/carmens-advice/) where kids can seek advice.
- The Cyberbullying Research Center (https://cyberbullying.org/resources/educators) has resources for educators, parents, and teens to address bullying online.

As a reminder, Illinois law requires all school districts, charter schools, and nonpublic nonsectarian elementary and secondary schools to create and implement bullying prevention policies (/Pages/Bullying-Prevention.aspx) and to file the policy with ISBE every two years.

Join me this October in taking steps to stop bullying and foster a culture that practices empathy, kindness, and care. And don't forget to take a final look at last year's attendance data in the Student Information System by this Friday.

FINAL OPPORTUNITY TO REVIEW AND CORRECT SY 2021-2022 ATTENDANCE DATA

ISBE will publish the Illinois Report Card at the end of October. School districts have had since the summer to review and correct, if necessary, their data in the Student Information System (SIS) and supporting systems like the Data Review and Verification Tool (DRVT). However, several school districts recently identified inaccuracies in the attendance data they submitted related to the appropriate coding of students excluded from school and receiving remote instruction.

ISBE is statutorily obligated to publish the Illinois Report Card by the end of October. To meet that deadline while also ensuring maximum data integrity and accuracy for the upcoming SY2021-2022 Report Card, **ISBE will provide a one-time final 48-hour opportunity** for school districts to **provide corrections to SY 2021-2022 attendance data only** in the Student Information System. No other changes made to SY 2021-22 SIS data will be recorded – including no changes to SY 2021-2022 student enrollment data. Only attendance data for student enrollments previously finalized for SY2021-2022 will be updated during this one-time opportunity.

Please ensure your attendance data is correct for the 2021-22 school year in the Student Information System by the end of the day on Friday, Oct. 14 in order for those changes to be included in the Student Attendance Rate, Chronic Absenteeism, and Chronic Truancy metrics for the upcoming SY 2021-2022 Report Card.

Changes that ISBE receives during this window may impact the preliminary school summative designations that have been available in Educator Preview since Oct. 3. As always, and as noted in prior communications (/Documents/RCRundown-Sept22.pdf) to the field, please keep in mind that all Report Card data is preliminary and subject to change until it is officially published on www.illinoisreportcard.com (http://www.illinoisreportcard.com/). SAFE AND HEALTHY CLIMATE

FREE ONLINE RESTRAINT AND TIME OUT TRAINING AVAILABLE

ISBE and the Center for Intensive Behavioral Supports at Illinois State University are excited to announce the availability of free online professional training to support a reduction in the need to use physical restraint, time out, and/or isolated time out (RTO).

Illinois Administrative Code 1.285 requires that any adult who is supervising a student in time out or isolated time out, or who is involved in a physical restraint, shall receive at least eight hours of developmentally appropriate training annually. Online training may be utilized for all the following required training areas: A) crisis de-escalation, B) restorative practices, C) identifying signs of distress during physical restraint and time out, D) trauma-informed practices, and E) behavior management practices. **Online training may not be used for training pertaining to physical restraint**.

All Illinois teachers are eligible to register (https://www.behavioralsupportsil.org/) for the free online training series that fulfills this requirement. Any teacher who teaches an Illinois student, regardless of location of educational entity, is eligible to register for a free account. Additional training topics will be added over time.

BULLYING POLICY SUBMISSION

Bullying Prevention Policies must be filed with ISBE by **Sept. 30** every two years. Policies must be reviewed and reevaluated every two years and be updated to reflect any necessary and appropriate revisions. Districts and schools should check the date of their last local review to determine if their policy is now due to ISBE. Entities should complete the IWAS Bullying Policy Submission, upload a PDF version of the policy, and include the website link, as applicable. We are aware that there was an issue with IWAS and some entities were unable to submit policies by the due date. Please note that entities will not be penalized for late submissions.

DEADLINE REMINDERS FOR FINANCIAL DOCUMENTS

School District Budget – Oct. 31

School districts should have adopted their FY 2023 budget no later than Sept. 30. The School District Budget Form (ISBE 50-36), in Excel format, must be submitted to ISBE no later than **Oct. 31** via the Attachment Manager (https://sec1.isbe.net/attachmgr/default.aspx), choosing "School Financial Reports" as the receiver. Additional information can be found on the ISBE School District Budget webpage (/Pages/School-District-Joint-Agreement.aspx).

Annual Financial Report – Nov. 15

School districts and joint agreements must have their Annual Financial Report (ISBE 50-35/50-60) (AFR) completed, signed, and submitted to the Regional Office of Education (ROE) or the Intermediate Service Center (ISC), as applicable, by Oct. 15. The ROE/ISC must sign the AFR and remit to ISBE no later than **Nov. 15**. The school district or joint agreement's auditor must also submit the AFR, in Excel format, no later than Nov. 15 via IWAS (https://sec1.isbe.net/iwas/asp/login.asp?js=true). The ROE/ISC may grant an extension to these deadlines, not to extend past Dec. 15. Additional information can be found on the ISBE Annual Financial Report webpage (/Pages/Annual-Financial-Report.aspx).

Limitation of Administrative Cost Worksheets – Nov. 15

Section 17-1.5 of the School Code requires school districts to limit the growth of certain administrative expenditures to a maximum of 5 percent from one fiscal year to the next. School districts must file the Limitation of Administrative Costs Worksheet with ISBE's School Business Services Department by **Nov. 15**. A blank Limitation of Administrative Costs Worksheet, quartile rankings for all school districts, and a sample waiver resolution for qualifying districts can be found on the ISBE Limitation of Administrative Costs webpage (/Pages/Limitation-of-Administrative-Costs aspx). The Limitation of Administrative Costs Worksheet is included within the AFR, and the

worksheet may be submitted to ISBE in conjunction with the AFR. Alternatively, the completed and signed worksheet may be sent as an email attachment to finance1@isbe.net (mailto:finance1@isbe.net).

- Annual Statement of Affairs Dec. 15
 - School districts and joint agreements must complete an Annual Statement of Affairs (ASA) and publish an ASA summary in a newspaper of general circulation no later than Dec. 1. School districts and joint agreements must also submit the entire Annual Statement of Affairs (ISBE 50-37) electronically to ISBE by **Dec. 15** annually. The ASA, in Excel format, should be submitted to ISBE via the Attachment Manager (https://sec1.isbe.net/attachmgr/default.aspx), choosing "School Financial Reports" as the receiver. Copies of the ASA should be retained in the school district or joint agreement administrative office. The ASA form and instructions, along with additional publishing and submission information, can be found on the ISBE Annual Statement of Affairs webpage (/Pages/Annual-Statement-of-Affairs.aspx).
- Certificate of Tax Levy Dec. 27
 School districts must submit a certified Certificate of Tax Levy (ISBE 50-02) to their county clerk(s) on or before the last Tuesday in
 December. Do not submit the Certificate of Tax Levy to ISBE. The Certificate of Tax Levy form can be found on the ISBE Certificate of Tax Levy webpage (/Pages/Certificate-of-Tax-Levy.aspx).

The Illinois Arts Council Agency has released a Request for Proposals (RFP) to solicit proposals from eligible applicants that are seeking resources to introduce or expand instruction in the arts or foreign language, as applicable, and for developing means of perpetuating the funded program with local resources after the conclusion of the anticipated three-year grant cycle. Annual grant awards will not exceed \$100,000 depending on the programmatic needs, size of district, and level of implementation proposed. Proposals are due **Nov. 17**.

OCTOBER IS COLLEGE CHANGES EVERYTHING MONTH

October is College Changes Everything® (CCE) Month in Illinois.
