## KEEPING STUDENTS ENGAGED IN LEARNING OVER THE SUMMER THROUGH THE ILLINOIS TUTORING INITIATIVE

Schools across the country continue to leverage pandemic recovery resources to give their students every opportunity to address missed learning during the pandemic. Jonesboro Elementary School did not hesitate at the chance to provide students with a fun and engaging summer learning experience through the Illinois Tutoring Initiative.

"This is the first time that my fellow tutors and I have had the opportunity to tutor our students during the summer," said Susan Ramsey, a classroom teacher at Jonesboro and tutor in the program. "For the past two summers, our district offered summer school to help fill the learning gaps caused during closures throughout the pandemic. With those resources ending, the availability of the Illinois Tutoring Initiative came at the perfect time in our quest to help students continue to achieve their personal best academic achievements."

Ramsey and her colleagues recognized the need to make this summer both enjoyable and educational for their students. In order to achieve this, they incorporated hands-on activities, games, and real-world experiences into their lessons enabled these educators to keep their students actively engaged in learning throughout the summer months. This approach not only reinforced core academic concepts but also allowed students to see the practical applications of what they were learning.

The teacher recalls, "We made math and language arts lessons while making pancakes, playing board games, making science experiments, doing puzzles, hatching sea monkeys (tiny shrimp), peeling mandarin oranges, and the list goes on!"

## **EDUCATOR EFFECTIVENESS**

### EARLY CHILDHOOD TEACHER PREPARATION CONTENT TEST

This information will address issues, concerns, and questions that were raised during public comment at the September Board meeting pertaining to the early childhood teacher preparation content test.

Each content test is developed from a test blueprint that is derived from the content standards for the specific endorsement area. The blueprint guides the development of test framework (subareas and questions within each subarea), which is vetted by Illinois educators and faculty at institutions of higher education. This work occurs in multiple iterations to ensure alignment to the blueprint and minimize bias. Once completed, a recommended cut score is identified. These recommendations are shared with the State Educator Preparation and Licensure Board and approved by the State Board of Education.

Candidates may download the test framework (https://www.il.nesinc.com/PageView.aspx?f=GEN\_PreparationMaterials.html) and study guides and can purchase practice materials at any time prior to registering or completing a content test. (Note: At this time, a free content test is available to registrants for the early childhood content test.) Upon completion of the test, the candidate is notified as to whether or not they passed. Candidates and institutions of higher education also receive information on their performance in each subarea.

ISBE continues to work with stakeholders to improve and enhance our processes. We appreciate the feedback and will continue to work with stakeholders regarding this matter. We will share any updates with the field as soon as possible.



### **FINANCE**

#### DEADLINE REMINDERS FOR FINANCIAL DOCUMENTS

## School District Budget - Oct. 31

School districts should have adopted their fiscal year 2024 budget no later than **Sept. 30**. The School District Budget Form (ISBE 50-36), in Excel format, must be submitted to ISBE no later than **Oct. 31** through IWAS (https://apps.isbe.net/iwas/asp/login.asp?js=true) - School District Financial Reports found under Reporting - Annual. A training video (https://register.gotowebinar.com/recording/3685366595336690435) is available to assist with this new system. Additional information can be found on the ISBE School District Budget webpage (/Pages/School-District-Joint-Agreement.aspx).

## Annual Financial Report - Nov. 15

School districts and joint agreements must have their Annual Financial Report (AFR) completed, signed, and submitted to the ROE or ISC, as applicable, by **Oct. 15**. The ROE/ISC must sign the AFR (ISBE 50-35/50-60) and remit it to ISBE no later than **Nov. 15**. The school district or joint agreement's auditor must also submit the AFR, in Excel format, no later than **Nov. 15** through IWAS (https://sec1.isbe.net/iwas/asp/login.asp?js=true). The ROE/ISC may grant an extension to these deadlines, not to extend past **Dec. 15**. Additional information can be found on the ISBE Annual Financial Report page (/Pages/Annual-Financial-Report.aspx).

#### Limitation of Administrative Cost Worksheets - Nov. 15

Section 17-1.5 of the School Code requires school districts to limit the growth of certain administrative expenditures to a maximum of 5 percent from one fiscal year to the next. School districts must file the Limitation of Administrative Costs Worksheet with ISBE's School Business Services Department by **Nov. 15**. A blank Limitation of Administrative Costs Worksheet, quartile rankings for all school districts, and a sample waiver resolution for qualifying districts can be found on the ISBE Limitation of Administrative Costs page (/Pages/Limitation-of-Administrative-Costs.aspx). The Limitation of Administrative Costs Worksheet is included within AFR, and the worksheet may be submitted to ISBE in conjunction with the AFR. Alternatively, the completed and signed worksheet may be sent as an attachment to finance1@isbe.net (mailto:finance1@isbe.net).

### Annual Statement of Affairs - Dec. 15

School districts and joint agreements must complete an Annual Statement of Affairs (ASA) and publish an ASA summary in a newspaper of general circulation no later than **Dec. 1**. School districts and joint agreements must also submit the entire Annual Statement of Affairs (ISBE 50-37) electronically to ISBE by **Dec. 15**, annually. The ASA, in Excel format, should be submitted to ISBE through the Attachment Manager (https://sec1.isbe.net/attachmgr/default.aspx), choosing "School Financial Reports" as the receiver. Copies of the ASA should be retained in the school district or joint agreement administrative office. The ASA form and instructions, along with additional publishing and submission information, can be found on the ISBE Annual Statement of Affairs page (/Pages/Annual-Statement-of-Affairs.aspx).

#### Certificate of Tax Levy - Dec. 26

School districts must submit a certified Certificate of Tax Levy (ISBE 50-02) to their county clerk(s) on or before **the last Tuesday in December**. Do not submit the Certificate of Tax Levy to ISBE. The Certificate of Tax Levy form can be found on the ISBE Certificate of Tax Levy page (/Pages/Certificate-of-Tax-Levy.aspx). #### **FY 2025 BUDGET HEARINGS**

ISBE invites educators, parents, students, and community organizations to give their input on state funding for public education at three budget hearings, which are scheduled for **Oct. 3, 5, and 30**. The input ISBE receives will inform the Board's advocacy for equitable funding for all students in fiscal year 2025 and provide the basis for ISBE's budget recommendation to Governor JB Pritzker and the General Assembly in January 2024.

Testimony at past hearings has led to increased investments in Evidence-Based Funding, early childhood education, and Career and Technical Education programs. Now more than ever, ISBE wants our school leaders, classroom teachers, parents, and community advocates to tell us what investments would make the biggest difference for their students.

Please fill out this form (/budgetrequestform) to register to attend or speak at one of the hearings or make a budget funding request. Funding requests must be submitted by **Oct. 31**. Please note ISBE will give equal consideration to all written and oral testimony.

### FY 2024 SCHOOL DISTRICT REORGANIZATION FEASIBILITY STUDIES

ISBE is now accepting agreements for FY 2024 School District Reorganization Feasibility Studies. Feasibility studies can be used to investigate the advantages and/or disadvantages of reorganization options. The school board of each district involved in a feasibility study must approve a resolution to initiate a study. The districts involved should submit a proposed agreement with an independent contractor(s) to their ROE or Intermediate Service Center (ISC). The ROE/ISC will then submit the agreement to ISBE for approval.

The state allotment amount for FY 2024 studies will be the cost of the study, up to a maximum of \$15,125. Any study cost above the state funding will be the responsibility of the participating districts. Studies are funded on a first-come, first-served basis. Studies must be completed and submitted to the ROE/ISC and ISBE no later than **May 31**. ROE/ISC approval or denial of the study must be submitted to ISBE no later than **June 30**. ## LOCAL FOOD FOR SCHOOLS FUNDING AVAILABLE NOW

Illinois is participating in the U.S. Department of Agriculture's Local Food for Schools Cooperative Agreement Program. This new program will provide \$7.3 million to ISBE to distribute to eligible schools to purchase local unprocessed and minimally processed foods to be served as part of the National School Lunch and/or School Breakfast Programs between August 2023 and January 2025. ## SAFE & HEALTHY CLIMATE

### **COVID-19 GUIDANCE FOR SCHOOLS**

The Illinois Department of Public Health (IDPH) and ISBE Joint Guidance for COVID-19 Prevention in Schools (https://dph.illinois.gov/covid19/community-guidance/school-guidance.html) was updated in June 2023. The major change was discontinuing use of the COVID-19-specific Decision Tree for managing persons with confirmed or suspected COVID-19. Instead, the Communicable Disease School Guidance (https://dph.illinois.gov/topics-services/diseases-and-conditions/infectious-diseases/cd-school-nurse-guidance.html) was updated to include COVID-19, along with the other communicable diseases schools typically encounter, and includes recommendations for isolation (https://www.cdc.gov/coronavirus/2019-ncov/your-health/isolation.html) that have not changed for COVID-19.

Guidance on COVID-19 Outbreak Reporting for Non-High-Risk Settings, including K-12 Schools, Day Cares, Workplaces, Colleges, and Businesses (/Documents/COVID-19-Surveillance-Outbreak-Reporting.pdf) was released in December of 2022 to identify shifts in reporting COVID-19 cases and outbreaks in schools. IDPH clarified in this document that COVID-19 cases and outbreaks are no longer reportable unless directed by your local health department or when severe outcomes occur. The document provides guidance for schools to manage varying sizes of outbreaks independently but encourages schools to reach out to their local health departments whenever they have questions about managing communicable diseases in schools or need assistance.
