Dear Colleagues,

I want to extend my deepest sympathies to the family of 6-year-old Wadea Al-Fayoume, who was murdered in Plainfield in a horrific act of hate.

With all that's going on in our world, I want you to know that we support the work of educators, mental health professionals, and administrators, as you work to sustain students processing war, conflict, and tragedy around the globe. To that end, we wanted to share a few resources that might offer helpful guidance:

 The National Association of School Psychologists (https://www.nasponline.org/) has a downloadable flyer called Talking to Children About Violence: Tips for Families and Educators

(https://www.nasponline.org/resources-and-publications/resources-and-podcasts/school-safety-and-crisis/school-violence-resources/talking-to-children-about-violence-tips-for-families-and-educators), strategies for each grade level, and suggested talking points.

- From Common Sense Media (https://www.commonsense.org/20-years-of-impact/), an article called How do I talk to my kids about violence in the news? (https://www.commonsensemedia.org/articles/how-do-i-talk-to-my-kids-about-violence-in-thenews) reminds us to get a sense of what children know before launching into an explanation, by using open-ended questions, like "What did you hear?" or "What do you know?" and "What do you think about it?"
- UNICEF (https://www.unicef.org/) offers How to talk to your children about conflict and war: 8 tips to support and comfort your children (https://www.unicef.org/parenting/how-talk-your-children-about-conflict-and-war). One of the tips is to keep the conversation calm and age-appropriate and to focus on the people who are helping.
- Learning for Justice (https://learningforjustice.org/) has published Discussing War and Conflict: Resources for educators, parents and caregivers (https://www.learningforjustice.org/discussing-war-and-conflict-resources-for-educators-parents-and-caregivers), that provides a list of articles full of advice.
- For older students, Facing History offers lesson plans on Fostering Civil Discourse: How Do We Talk About Issues That Matter? (https://www.facinghistory.org/resource-library/fostering-civil-discourse-how-do-we-talk-about-issues-matter? check_logged_in=1) to help students engage in reflective conversations.

As uncomfortable as it may be to touch such sensitive topics, these topics are consuming many of our students' social media feeds. As the authors of Handle With Care: Supporting Young People During Crises

(https://www.learningforjustice.org/magazine/handle-with-care-supporting-young-people-during-crises) point out: "When something bad happens, it's of immediate importance to young people to share their feelings or thoughts, so it will occupy their minds whether you discuss it or not. Hold space for conversations and do not dismiss their questions, concerns or comments. Encourage young people to journal and draw to share their thoughts, or allow them privacy if they choose not to express their feelings at the moment."

One tip emphasized in many of these resources is that children will feel better if they have some opportunity to help, no matter how small. Allow them to write a poem, draw a poster, compose a song, send a card – do anything to send positive energy into the world. I'm realizing this tip isn't only for children. In the days and weeks ahead, please take good care of your students, yourselves, and each other.

DECATUR PUBLIC SCHOOL DISTRICT EXTENDED DAY PROGRAM SUPPORTS PANDEMIC RECOVERY

Decatur Public Schools (DPS) District 61 utilized federal pandemic relief funds to offer a free Extended Day program with the goal of bolstering students' academic success and well-being. The DPS Extended Day program has yielded remarkable results, including higher attendance, improved reading scores, and reduced disciplinary issues. Available at 13 site locations throughout the district, the program is a lifeline for both students and their families. The Extended Day program operates from 6 a.m. until the start of the school day and resumes after school until 5:30 p.m., including early release days.

One of the program's primary aims is to provide a safe, secure, and supportive environment for students before and after school hours. Academic assistance is a core component, with dedicated time for homework support or skill-based work. The Extended Day program also offers enrichment and physical fitness opportunities, encompassing a diverse array of services and activities, such as service/project-based learning, art, music, physical fitness, and STEM activities. This invaluable resource is offered free to parents, removing barriers for those who may not have access to alternative care options.

Districts across the state and country are looking at how to sustain effective programs that were established or expanded with pandemic relief funding. DPS is exploring alternative funding sources and grants to ensure that the positive impact on students' education and the community can continue. USDA FARM TO SCHOOL GRANTS

The U.S. Department of Agriculture (USDA) announced the official release of the fiscal year 2024 Farm to School Grant Program Request for Applications (https://www.fns.usda.gov/f2s/farm-school-grant-program) (RFA). The USDA will award up to \$12 million in competitive grants to eligible entities through the grant program this fiscal year. Each grant will help implement farm to school programming that increases access to local food in eligible schools, connects children with agriculture for better health, and inspires youth to consider careers in agriculture.

A wide variety of entities are eligible to compete for funding through this grant opportunity, including schools and other institutions operating the National School Lunch Program, School Breakfast Program, Child and Adult Care Food Program, and/or Summer Food Service Program.

CELEBRATING THE 2023 ISBE SCHOOL NUTRITION CHAMPION

Representatives from ISBE and USDA visited Shawnee Community Unit School District 84 in Wolf Lake to present Katie Ford with the 2023 ISBE School Nutrition Champion Award on Oct. 11.

Mrs. Katie, as the students call her, is the head cook for the district, which has one kitchen that serves three schools – Shawnee Elementary School, Shawnee Jr. High School, and Shawnee High School.

Katie was nominated by Shawnee CUSD 84 Superintendent Shelly Clover-Hill. In her nominating submission, she wrote:

"When Katie took over as head cook in 2020, she made it her mission to improve our school meals and that is still true today. She actively seeks the input of the students and staff in the development of the menus Katie takes great pride in offering meals that will be eaten and not thrown in the garbage. She is also a master at getting the students to try new foods and adds those menu items when the vast majority of students ask for it again."

The award presentation coincided with National School Lunch Week (Oct. 9-13). The nominees and award-winner were announced in May. FY 2024 AFTER SCHOOL PROGRAMS - NON-SCHOOL DISTRICTS GRANT RFP DEADLINE EXTENDED

ISBE has extended the deadline for FY 2024 After School Programs Request for Proposals (/Pages/After-School-Programs.aspx) to **4 p.m. Oct. 20**. The purpose of the grant is to provide opportunities outside of the school day to improve academic outcomes for students; to provide opportunities for enrichment activities in a safe and healthy environment; and/or to provide opportunities to strengthen public, private, and philanthropic partnerships so that quality support services are more durable for students facing the greatest challenges.

ROEs/ISCs, community-based organizations, and Indian tribes or tribal organizations (as defined in the federal Indian Self-Determination and Education Assistance Act) are eligible to apply. School districts and Local Education Agencies are **not** eligible to apply.

Please note that the recorded webinar located on the After School Program webpage still states a due date of **Sept. 29**. As noted above, the due date has been extended to **4 p.m. Oct. 20**.

NURSES EXPANDING THEIR SPECIAL EDUCATION ROLE

Who performs the medical review for your special education students? ISBE is sponsoring an online course **Oct. 25-Dec. 12**, "RNs in Schools – Expanding Your Special Education Role," for nurses who meet the minimum education requirements (bachelor's degree in nursing, education, or a related field).

Districts and special education cooperatives may request a non-PEL RN to complete this course to comply with special education rule 226.160. To meet compliance with this rule, complete the Non-PEL IEP Designee Administrator Checklist (/Documents/Non-PEL-IEP-Designee-Admin-Checklist.pdf) and retain it at the local level.

Nurses who have worked with a district before September of 2023 may coordinate with district administrators or special education cooperatives to request participation in the course. Administrators or their support staff should complete the Request for IEP Designation form (https://forms.office.com/r/m9bieHMRfd).

The asynchronous course will be offered twice in the spring semester and a limited number of seats are available. Participation is best for individuals who have worked in a school setting for less than a year. Previous participants report allowing 10-12 hours per week for all course commitments with being online every one or two days. LITERACY PLAN LISTENING TOUR 2.0

ISBE is gearing up for another Listening Tour to get feedback on the second draft of the Illinois Comprehensive Literacy Plan. The tour kicks off **Oct. 24** in Springfield. We recognize that providing multiple opportunities for input – and your expertise – is crucial in developing a plan that provides guidance to support the assets each child brings into the classroom. The revised Illinois Comprehensive Literacy Plan will be presented to members of the Illinois State Board of Education on **Oct. 18**. Following that presentation, the revised plan will be released on our website (/literacyplan). Participation in the Listening Tour will require a careful reading of the revised Illinois Comprehensive Literacy Plan and the completion of a feedback form prior to attending.

FY 2024 ARTS AND FOREIGN LANGUAGE EDUCATION PLANNING ASSISTANCE GRANT AVAILABLE

The Illinois Arts Council Agency and ISBE are pleased to announce funding is available for school districts and other eligible applicants for the FY 2024 Arts and Foreign Language Education Planning Assistance Grant (https://arts.illinois.gov/afl).

The Illinois Arts Council Agency has released a Request for Proposals to solicit proposals from eligible applicants that seek resources to develop district-based plans for initiating, strengthening, or expanding instruction in the arts or foreign languages. Annual grant awards will not exceed \$40,000 depending on programmatic needs, size of district, and level of planning to take place. Proposals are due **Dec. 5**.

EVIDENCE-BASED FUNDING PROPERTY TAX RELIEF GRANT APPLICATIONS OPEN

The fiscal year 2024 Evidence-Based Funding Property Tax Relief Grant application period is now open to interested districts. ISBE will provide up to \$49.3 million in property tax relief grants to eligible school districts. Districts are ranked by their Adjusted Operating Tax Rate divided by the Average Operating Tax Rate by organization type. Grants will be awarded to applicant districts in the order of that ranking. Eligible districts must agree to abate a portion of taxes, up to a statutory limit, in the coming two tax cycles. In return, qualifying districts will receive a state grant in an amount that is a proportion of the tax relief provided.

Ag Biology Pilot Phase Two: Schools and Teachers Needed

Innovative schools and educators are being sought for phase two of the Agriculture Biology Curriculum Development Project Pilot, a collaboration of Illinois Science Teaching Association and Illinois Association of Vocational Agriculture Teachers. The course utilizes storylining to help students identify phenomena and solve problems (https://www.nextgenstorylines.org/what-are-storylines). The course is aligned with the Illinois Science Assessment and explicitly linked to the Next Generation Science Standards

Writing teams have already developed a semester of storylines that are being piloted currently in 10 Illinois high schools (phase one). The teams continue to work on the second set of storylines to complete the course. Schools and teachers joining for phase two of the pilot will receive access to the curriculum, professional development, and grant funds for implementation of the material.

The expectation is to engage in the professional development, collaborate with the writing teams, and work with the research team to explore the effectiveness of the curriculum. Energetic and forward-thinking schools and teachers will engage in a professional learning community to build capacities using storylining to explore biology in the context of agriculture

National Center for Research on Gifted Education Acceleration Study

The National Center for Research on Gifted Education is conducting a study to document and disseminate information on how school districts implement subject acceleration (i.e., advancing students in one or more subject areas without whole-grade accelerating the student; may exist in combination with whole-grade acceleration procedures). The center is seeking responses from school districts who have systematic procedures in place for subject acceleration. The study goal is to describe common procedures in place in districts across the country as guidance for districts considering how to approach this practice.

Participation in the study will involve an online interview of a knowledgeable member of the district staff (e.g., gifted program coordinator, director of advanced academics) with the study team. The center expects the interview to last approximately one hour. Participants will receive questions in advance and will also have the option of submitting responses in writing.
