#### Dear Colleagues,

ISBE released the 2023 Illinois Report Card (/ilreportcard) Monday. We are moving fast toward recovery, but still have a significant distance to travel.

The Report Card highlights the strong progress we have made toward recovery from the pandemic, including all-time high graduation and teacher retention rates, increases in proficiency, and more students than ever enrolling in advanced coursework and Career and Technical Education. However, persistently high chronic absenteeism and the fact that our proficiency rates in math and English language arts are still not up to pre-pandemic levels also highlight ongoing challenges. I know each of our school and district leaders will examine

and reflect on what the data tells us. I also encourage you to use the data as an opportunity to engage your staff, families, and communities.

Our guide (https://isbe.net/Documents/How-to-Tell-Your-Summative-Designation.pdf) on how to tell your Report Card story also has suggestions for sharing information with school communities and engaging your stakeholders in dialogue about strengths and opportunities for growth. Each of our stakeholders – from parents/guardians, to board members, to teachers – has different and valuable insight to share.

One of my takeaways in reviewing the data is that since the state enacted Evidence-Based Funding and increased education funding by \$2.38 billion, we have seen year-over-year increases in the graduation rate, and these increases have been driven by gains for our Black and Hispanic students. Over the past six years, schools have had more resources to hire staff and implement programming to identify and intervene with students who are not on track to graduate.

We have also seen more and more of our high school students taking advanced coursework and enrolling in Career and Technical Education all across the state. Increasing the rigor and relevance of high school is bearing fruit. Students are not just graduating, but graduating in career pathways with a clearer vision for what they *want to do* after high school and what they *need to do* to get there.

The third and final round of federal pandemic relief funds will expire on Sept. 30, 2024. Two places stand out to me as calls to action for investment: our slower recovery in math and our chronic absenteeism rates. I encourage you to explore evidence-based strategies for increasing support and intervention in these areas.

On the topic of chronic absenteeism, it's important to understand that chronic absenteeism differs from truancy (https://www.attendanceworks.org/whats-the-difference-between-chronic-absence-and-truancy/). When we think of truancy, we think of students skipping school with no valid excuse and often respond with punitive consequences. Whereas, chronic absenteeism is a symptom of deeper issues. Treating it requires us to understand and address its root causes. Why are students absent? Reasons can include homelessness/unstable housing, unreliable transportation, medical issues, experiencing or witnessing trauma, suspensions, mental health, bullying, fear of violence at or getting to school, needing to work – the list goes on. In the Learning Renewal section below, we share an example from the North Cook Regional Office of Education of a successful intervention with a chronically absent student. The key interventions in this case were ongoing and intensive case management that included numerous home visits and communication with the student and parent, building a positive relationship with the student and family, connecting the student to a mentor in school, and educating the family on the importance of school attendance.

I want to thank each and every one of you for your incredible work to support students' recovery from the pandemic and your unwavering commitment to our shared goal of providing a high-quality and equitable education for all students in Illinois.

## **LEARNING RENEWAL**

### NORTH COOK ROE'S SUCCESSFUL INTERVENTION WITH A CHRONICALLY ABSENT STUDENT

A chronically absent student was referred to the attendance support program at the North Cook ROE in November 2022. The student was immediately matched with a Student Attendance Liaison who met with the family for an assessment. The liaison quickly learned the student's parent felt overwhelmed with three children who all had a history of poor attendance. The liaison connected with the student and discussed their challenges with school. The student shared that they had missed so much school already that they felt like they could never catch up. The liaison worked with the student to create a student attendance success plan with goals around attendance incentives if the goals were met, but the student felt so overwhelmed with the workload and how far behind they were in school.

When the liaison was able to get the student to attend school, the student was going inside the school building but was skipping classes, which meant their attendance to school improved, but not their attendance in class. The liaison continued to check in with the student over the summer to encourage attendance for the new school year and remind them this would be considered a fresh start. The liaison used every opportunity when connecting with the student's parent to educate them on the importance of school attendance and the negative effects absenteeism has in the long run for students, so the parent could encourage attendance at home as well. At the start of the new school year, the liaison referred the student to the new Student Advocacy Alternative Learning Opportunities Program (ALOP) at school where they were connected to a student advocate. The liaison knew having a mentor in the building who could connect with the student on a daily basis would be beneficial to their overall growth.

With all the support and interventions put in place, North Cook ROE can happily say the student improved their attendance tremendously

- School year 2022-2023 quarter 1 attendance was 44%.
- Current school year 2023-2024 quarter 1 attendance is 96%.

The key interventions in this case were ongoing intensive case management that included numerous home visits and communication with the student and parent, building a positive relationship with the student and family, connecting the student to a mentor in school, and educating the family on the importance of school attendance.

### ILLINOIS AFFINITY GROUPS BUILD ON SUCCESSFUL FIRST YEAR

After a successful inaugural year, the Illinois Affinity Group Network (https://teachplus.org/illinois-affinity-groups/) is reaching new corners of the state, offering educators of color the opportunity to connect, be heard, and stand together. Affinity groups for educators of color create a space where teachers and staff from diverse racial and ethnic backgrounds can share experiences and perspectives, promote inclusivity within a school district, and foster a sense of belonging for educators who may otherwise feel isolated.

Participants from the first year reported that 85% of them felt an increase in the sense of belonging and over 94% felt that their affinity group provided a safe space for discussing challenging issues within their district. The network is maintaining this momentum with 39 affinity groups available this school year, including a virtual group (https://docs.google.com/forms/d/e/1FAIpQLSdW3tLr\_layEu8Eqn3oTB\_05tNQPY8J1QDz2pJ-NT4Nss-JzQ/viewform) open to educators anywhere in the state.

The network is a collaborative effort between Teach Plus Illinois and Regional Office of Education 51. Facilitators who lead the groups receive training and support from Teach Plus. Their testimonials speak volumes about the significance of these groups:

Affinity groups meet monthly, and participants become part of a network that nurtures inclusivity, collaboration, and collective healing.

## NEW INCENTIVE FOR NATIONAL BOARD CERTIFIED TEACHERS

The National Board Resource Center (NBRC) at Illinois State University is inviting eligible Illinois National Board Certified Teachers (NBCTs) from "hard-to-staff" schools to apply for a \$4,000 per year retention incentive, which may be received for two consecutive years.

Public Act 103-0207 defines a "hard-to-staff" school as a public school in which no less than 30% of student enrollment is considered low-income as reported on the Report Card.

The window to apply for the incentive will open **Jan. 20, 2024**, and close on March 29, 2024. It will be funded on a first-come, first-served basis. Not all NBCTs who apply and are eligible may be awarded this year.

### ANNUAL VERIFICATION PROCESS UNDER WAY

Many School Food Authorities (SFAs) should have started the required verification process earlier this month. The U.S. Department of Agriculture (USDA) requires all School Nutrition Program (SNP) sponsors that received and approved Household Eligibility Applications (HEAs) between July 1 and Oct. 1 to conduct verification for school year 2023-24. For assistance, please review the Oct. 2 email 🎽 (/Documents/100223-verification.pdf), which includes links to a recorded training, the SNP Administrative Handbook, and necessary verification documents. (Sponsors participating in the districtwide Community Eligibility Provision do not need to do verification since they do not collect HEAs for the meal programs.)
