Dear Colleagues:

I hope you are all looking forward to spending quality time with your loved ones during the upcoming holidays. As you may have heard, I will soon be spending more time with my own. For the last 40 years, I have been blessed to serve the students in Illinois. If anyone knows me, they know equity is my passion. I've been referred to as an "equity warrior." I have been fortunate to be the "first" in several leadership opportunities: the first woman, the first Latina, the first modern-day state superintendent to lead through a global pandemic. But now it is time to enjoy and spend time with my family, so last week

at the ISBE Board meeting, I announced my retirement beginning Feb. 1.

In the spirit of Thanksgiving, I want to express my most sincere and heartfelt gratitude to each one of you: to the district superintendents and administrators, to the teachers, to the school support personnel, to the bus drivers, to principals, to the advocates, to the Board members. Over the past four years, you have helped ISBE accomplish great things. Together, we:

- Developed this agency's first Strategic Plan, laying out a clear roadmap for increasing student learning, improving learning conditions, and elevating educators;
- Adopted Culturally Responsive Teaching and Leading Standards for Illinois educator preparation programs to prepare new teachers to engage with all students;
- · Launched affinity groups to help sustain and retain our teachers of color;
- Narrowed gaps in access to computer science, dual credit, Career and Technical Education, and Advanced Placement courses to boost students' readiness for college and career;
- Adopted new learning standards for social science, computer science, and Spanish language arts to further elevate the rigor and inclusiveness of instruction for all students;
- · Saved lives during the COVID-19 pandemic;
- Grew the teacher pipeline and added more and more teachers of color every year, bucking national teacher shortage trends;
- · Expanded access to trauma-informed practices; and
- Achieved the highest high school graduation rate in over a decade, driven by improved graduation rates for Black and Hispanic students.

Each year, the Simon Wiesenthal Center, a Jewish human rights organization, recognizes three women with their Woman of Valor Award. Last week, I very humbly accepted this award and reflected on the meaning of valor: "strength of mind or spirit that enables a person to encounter danger with firmness; personal bravery."

Equity works takes courage - it takes valor.

One of my proudest accomplishments is the creation of the Equity Journey Continuum -- a tool that we included in the ISBE Strategic Plan and that launched last month on the Illinois Report Card. It organizes the data that ISBE already collects from school districts to highlight small, moderate, or large gaps between students. I hope the Equity Journey Continuum will support school districts and communities in advancing equity with courage, with valor, for many years to come.

None of these accomplishments would have made it past the drawing board without you – my colleagues across the state who generously shared your expertise on countless advisory committees, surveys, and pilot programs as we crafted and refined our ideas.

We are only and always at our best when we band together to serve the children of Illinois. Thank you for taking this journey with me.

HIGH-IMPACT TUTORING GRANT FUNDS AVAILABLE TO SELECT DISTRICTS

ISBE invites select districts to apply for a funding opportunity to support a district-led high-impact tutoring program during the spring and/or summer of 2023. There are 28 districts currently participating in the program and they are designing and offering a structured, consistent, relationship-based, standards-aligned tutoring opportunity to students. Invited districts must submit an intent to apply, using the form that was emailed to them, **by 6 p.m. Nov. 30** to be considered for this opportunity. Responses will be reviewed, and available funding will be distributed based on need. Programs identified to receive a grant will be required to submit an application to ISBE for approval. Participants in the Illinois Tutoring Initiative (/Pages/ILTutoringInitiative.aspx) will complete a brief training to support effective tutoring. "Highimpact tutoring is not what most people think of when they think of tutoring. It is built on research that focuses on a relationship with a consistent tutor, committed time each week, direct connection to the school curriculum, and close monitoring of student knowledge and skills," said Dr. Christy Borders, director of the Illinois Tutoring Initiative. "It is not homework help or 'on the fly' addressing of questions. High-impact tutoring is intentional and needs-driven."

WEBINAR SERIES SUPPORTS SCHOOLS' PLANS FOR SUSTAINABLE USE OF ESSER FUNDS FOR AFTER-SCHOOL PROGRAMMING

ACT Now is hosting the fourth webinar in the School Partnerships series at **10 a.m. Nov. 30**. The webinar, Sustainability Planning for After ESSER Funding (https://metrofamily.zoom.us/meeting/register/tJwqc-uvpzgsHdCz75VrPqRj-v7zAVqDuu1Y), will discuss how to plan for the continuation of newly established programs after Elementary and Secondary School Emergency Relief (ESSER) funds are no longer available. This webinar will be co-facilitated by Ramona Dixon, director of grants, accountability, and assessments at Rock Island-Milan School District 41, and will outline the most important steps to plan for the sustainable use of grant funds. Additionally, attendees will have access to an established sustainability plan. Rock Island-Milan School District 41 in northwestern Illinois is situated on the Mississippi River and serves over 6,000 students. The school boundaries include economically and culturally diverse communities, with pockets of Rock Island having a significantly high rate of poverty as well as a rapidly increasing English Learner population.

The after-school model at Rock Island-Milan School District stems from the foundational components of 21st Century Community Learning Centers and has been funded primarily through use of these dollars.

"Since receiving ARP funds, we have been able to implement soft pilots of various out-of-school time programs over intersession and during summer," shared Dixon. "We know sustainability is the key to success; therefore, we are deeply immersed and invested in building a more sustainable model for after school that embraces the building of strong community partnerships."

Public Act 102-0917 (https://ilga.gov/legislation/publicacts/fulltext.asp?name=102-

0917&GA=102&SessionId=84&DocTypeId=HB&DocNum=3296&GAID=11&SpecSess=&Session=), which passed this past spring requires districts to offer high school students the opportunity of earning a College and Career Pathway Endorsement no later than July 1, 2025, or to opt out. This new law has dramatically increased the number of school districts working with College and Career Pathways. These factors, coupled with ISBE's internal work to develop more efficient solutions for data submission and record keeping by school districts, have prompted the need for this webinar, which will provide timely information to all districts currently engaged with the College and Career Pathway Endorsements.

ISBE Board Chair Dr. Steven Isoye presented Meeks with the award on Nov. 20 at the 2022 Joint Annual Conference, also known as Triple I.

DRAFT EXIT CRITERIA AND STATE-DETERMINED ACTION FOR COMPREHENSIVE SCHOOLS THAT DO NOT EXIT STATUS

Earlier, a preliminary draft of the exit criteria and state-determined action for Comprehensive schools that do not exit status was posted for feedback. There was some confusion over the use of the term "public comment" to describe a process of seeking feedback on a preliminary draft. ISBE welcomes feedback at this time but has determined that a series of sessions targeted at the district and school administrators, educators, and stakeholders who have experienced Comprehensive support the past four or five years is a better way to seek feedback on this preliminary draft. A final version of the work will be posted for formal public comment after Board members discuss the topic in December.

SAFE AND HEALTHY CLIMATE

NO-COST PUBLIC SCHOOLS CARBON-FREE ASSESSMENT

ComEd is offering free assessments designed to help make a significant impact on public schools' environments. The Public Schools Carbon-Free Assessment (PSCFA) helps public schools by assisting in energy cost-savings and carbon reduction strategies. This program is a result of Section 8-402.2 of the Illinois Climate and Equitable Jobs Act that states that each electric utility serving over 500,000 retail customers in the state of Illinois shall implement a Public Schools Carbon-Free Assessment program.

Completing the PSCFA can also help with grant qualification. For instance, to qualify for a grant under Section 5-40 of the School Construction Law, a public school district must submit a copy of a PSCFA report (if a PSCFA has been performed) or request the PSCFA and submit a copy as soon as it becomes available. ComEd will file the PSCFA report on your behalf.

SPECIAL EDUCATION

SEEKING PUBLIC COMMENT ON WAIVER REQUEST TO EXCEED 1% OF STUDENTS TAKING ALTERNATE ASSESSMENT

Title I of the Elementary and Secondary Education Act (ESEA) of 1965, as amended by the Every Student Succeeds Act (ESSA) of 2015 [ESEA §111(b)(2)(D) and 34 CFR 200.6(c) and (d)], modifies the provision that students with the most significant cognitive disabilities may participate in alternate assessments based on alternate academic achievement standards (alternate assessments). ESSA places a 1 percent threshold on the number of students who may participate in alternate assessments. States that anticipate exceeding the 1 percent threshold must submit a waiver request to the U.S. Department of Education.

ISBE anticipates exceeding the 1 percent threshold for participation in the alternate assessment for school year 2022-23 and plans to submit a waiver request to the U.S. Department of Education. ISBE is seeking public comment on the draft waiver (/Pages/Special-Education-Exception-cap.aspx) request until **Nov. 29**.
