#### Dear Colleagues:

This week, Dec. 5-11, is national Computer Science (CS) Education Week (https://www.csedweek.org/). The theme of the week is "CS Heroes #CelebratingProgress," which highlights the strides made to advance computer science education over the last decade. I am proud of Illinois' efforts to ensure all students participate in computer science courses and vital opportunities to develop the skills they need to gain access to careers driving today's economy.

Illinois' current class of high school freshmen may not realize it, but they represent a new chapter in the educational landscape of our state. Thanks to legislative efforts

(https://www.ilga.gov/legislation/publicacts/101/101-0654.htm), this year's ninth graders will all take at least one year of a course that includes intensive instruction in computer literacy sometime during their high school careers. Next year's ninth graders will be the first class to universally have the opportunity to take at least one computer science course during high school.

We know that, in the 21st century, computer science is a foundational subject. It engages students academically; fosters critical thinking and problem-solving skills; and offers pathways to in-demand, high-wage careers in every sector. Yet fewer than half of Illinois schools currently offer foundational computer science courses, and the courses that are offered often do not connect with historically underserved student populations. Among young women in high school, only 32 percent participate in computer science; among Black students, participation is just 6 percent. Those numbers reveal a deep inequity that Illinois is taking steps to address and heal.

Here at ISBE, we recently adopted a rigorous K-12 computer science knowledge and skill continuum 🛁 (/Documents/Illinois-Computer-Science-Standards.pdf) to support students in progressively developing computational skills to prepare for success in today's data-rich and interconnected world. The Learning Technology Center of Illinois also created a Computer Science Resource Database (https://ltcillinois.org/services/csresources/) to highlight CS resources.

Millions of students across the world will also participate this week in the Hour of Code (https://hourofcode.com/us). Hundreds of one-hour activities in over 48 languages for kindergarten and up are available to expose students and adults to basic coding concepts.

We hope that Computer Science Education Week (https://www.illinois.gov/news/press-release.25760.html) will inspire students and educators to learn and teach these computer science competencies that hold the keys to a successful future.

### PRINCIPAL MENTORING SUPPORTS A DIVERSE LEADERSHIP PIPELINE IN ILLINOIS

Illinois is focusing on building school leader capacity and fostering a robust leadership pipeline. In Illinois, the numbers of people completing all requirements to become a principal dropped more than 75 percent between 2011 and 2020, from 2,637 to 626. The Illinois School Leader Pipeline Program was established through a partnership with the Illinois Principals Association (IPA) to recruit candidates but also to diversify the pool of school leaders. The program is currently supporting 100 aspiring leaders who receive tuition support and mentoring from experienced school leaders. They also can participate in school-based leadership activities and connect to a network of school leaders in the state of Illinois.

"This type of commitment from the state is what's going to get us back to where we need to be with the number of school leaders who are highly prepared and ready to take on the challenges and opportunities of school leadership in our state's schools," said IPA Executive Director Jason Leahy (https://www.nassp.org/publication/principal-leadership/volume-22-2021-2022/principal-leadership-december-2022/strengthening-and-diversifying-the-pipeline/).

## **EVIDENCE-BASED FUNDING**

### **EBF PROPERTY TAX RELIEF GRANT**

The Evidence-Based Funding (EBF) Property Tax Relief Grant (PTRG) application period is open to interested districts. ISBE will provide up to \$49.7 million in property tax relief grants to eligible school districts in fiscal year 2023.

Districts are ranked by their Operating Tax Rate divided by the Average Operating Tax Rate by organization type. Grants will be awarded to applicant districts in the order of that ranking. Eligible districts must agree to abate a portion of taxes, up to a statutory limit, in the coming two tax cycles. In return, qualifying districts will receive a state grant in an amount that is a proportion of the tax relief provided.

## **SAFE & HEALTHY CLIMATE**

#### RENEW AMERICA'S SCHOOLS GRANT PROGRAM

The U.S. Department of Energy (DOE) has announced that applications are open (https://eere-

exchange.energy.gov/Default.aspx#Foald06985843-f32c-494e-880a-cb5db6d787a4) for the Renew America's Schools grant program (https://www.energy.gov/clean-energy-infrastructure/grants-energy-improvements-public-school-facilities). This initial funding round will award up to \$80 million of the \$500 million program and is available to public schools to perform energy improvements in the highest-need K-12 districts across the country. The deadline for applicant concept papers is **Jan. 26**, and full applications are due **April 21**.

#### **ENERGY CLASS PRIZE**

In tandem with the Renew America's Schools grant program, DOE launched a \$4.5 million prize program, Energy Champions Leading the Advancement of Sustainable Schools (https://www.energy.gov/clean-energy-infrastructure/grants-energy-improvements-public-school-facilities) (Energy CLASS Prize). This competitive program will support up to 25 high-need Local Education Agencies by providing a \$100,000 cash award to winners for the purpose of building the workforce through training and the staffing of energy management positions. Through the Energy CLASS Prize, energy managers will learn to identify, implement, and maintain projects that will improve health and efficiency in their districts. At the conclusion of the first year of the program, participating LEAs can submit a progress report and – based on performance – may qualify for an additional \$50,000.
