#### Dear Colleagues:

Governor JB Pritzker announced today that Illinois is on track to enter Phase 4, as the result of the effective social distancing measures implemented across the state. I am excited to be able to welcome students back to classrooms this fall. Schools will look a bit differently this fall than we are accustomed to, but our focus remains the same: ensuring each and every child receives the high-quality education they deserve.

The Illinois State Board of Education and the Illinois Department of Public Health have worked together to develop requirements and recommendations for schools to resume in-person learning this fall, while keeping students, staff, and loved ones safe and healthy. We are creating signs and posters to display in school buildings to help students and staff understand the health and safety requirements and developing additional family-focused resources. We will share those on the COVID-19 webpage as soon as they are available.

The physical classroom offers rich opportunities for academic and social and emotional learning, where children can receive the supports and resources they need – without the distractions of pets and family members; without jockeying for bandwidth or quiet time to focus; and with the face-to-face care and attention of their friends and teachers, who can notice in real-time if they need extra help or someone to talk to.

Our mission of equity compels us to ensure that all students can attend school in-person this fall to the greatest extent possible. This may require some creative scheduling, but we know our incredible teachers and school leaders are up to the task, and we are here to help them work through any challenges they may face.

To develop the guidance that we released today, we engaged an advisory group of 56 educators, administrators, nurses, social workers, parents, and students to ensure our guidance reflected the incredible diversity of Illinois' 852 school districts. As much as possible, we have provided common and clear requirements, while preserving the flexibility of each school and district to implement a reopening plan that meets the needs of the community and the children they serve.

The minimum public health requirements that all public and nonpublic schools must meet as they create local reopening plans in Phase 4 are to:

- Require use of appropriate personal protective equipment (PPE), including face coverings;
- Prohibit more than 50 individuals from gathering in one space;
- Require social distancing be observed as much as possible;
- Require that schools conduct symptom screenings and temperature checks or require that individuals self-certify that they are free of symptoms before entering school buildings; and
- · Require an increase in schoolwide cleaning and disinfection.

These measures are proven and necessary to prevent the spread of COVID-19.

The Governor also announced today that the State will make 2.5 million masks available for free for students and staff in all K-12 public school districts. A representative from each K-12 public school district, state-authorized charter school, special education cooperative, lab school, vocational center, and regional office operating an alternative program should complete this short survey to help ISBE and the Illinois Emergency Management Agency coordinate delivery:

Additionally, the Department of Central Management Services has master contracts available for school districts to purchase PPE and cleaning supplies without having to engage in the competitive bidding process. The contracts, vendor contact information, and item inventory lists are available at <a href="https://www.isbe.net/covid19">www.isbe.net/covid19</a> (http://www.isbe.net/covid19) under the "PPE & Cleaning Supplies Master Contracts" section. The State's Chief Procurement Officer is finalizing additional joint purchasing contracts, and ISBE will add those options to the website as soon as they become available.

This fall will not be business as usual, and we will update our guidance as needed in response to changing public health conditions. All schools and districts must be prepared to return to remote learning if the virus surges again. Please continue to submit your federal CARES Act funding applications and direct funds toward closing the digital divide.

As part of our recovery efforts grounded in equity, ISBE will offer the SAT this fall to all 12<sup>th</sup> grade students who were required to take the SAT this past spring but did not have the opportunity to due to the pandemic. Please find additional information below.

ISBE will continue to engage in open dialogue, as we have done from the onset of this pandemic, to give students the greatest opportunity to recover, re-engage, and grow. I look forward to answering some of your questions during our webinars tomorrow and Thursday. Thank you for your partnership and your ongoing diligence in caring for Illinois students.

# **ASSESSMENT**

#### ISBE-PROVIDED FALL 2020 SAT WITH ESSAY FOR 12TH-GRADE STUDENTS

The Illinois School Code (http://www.ilga.gov/legislation/ilcs/ilcs4.asp?

DocName=010500050HArt.+2&ActID=1005&ChapterID=17&SeqStart=14200000&SeqEnd=36700000) and ISBE Rule

(/Documents/ONEARK.pdf) require that public school students take the state's final accountability assessment (currently SAT with Essay) or its approved alternate assessment (currently Dynamic Learning Maps Alternate Assessment [DLM-AA]) in order to receive a regular high school diploma, unless exempt.

Students classified as grade 12 in fall 2020 who were required to participate in the state's final accountability assessments in spring 2020 may choose to participate in the ISBE-provided fall 2020 SAT with Essay to meet the diploma requirement and have the opportunity to receive a timely college- and scholarship-reportable score. Grade 12 students who choose to participate in the ISBE-provided fall 2020 SAT with Essay will **not** be required or allowed to participate in the state's final accountability assessment in spring 2021. Students classified as grade 11 in fall 2020 are **not** permitted to participate in the ISBE-provided fall 2020 SAT with Essay and are instead required to participate in the state's final accountability assessment or its approved alternate assessment, as appropriate, in spring 2021.

Students who were required to participate in the state's final accountability assessments in spring 2020 and choose not to participate in the ISBE-provided fall 2020 SAT with Essay are required to participate in the spring 2021 administration of SAT with Essay or DLM-AA, as applicable, to meet the diploma requirement.

## Test Dates for the ISBE-Provided Fall 2020 SAT with Essay for Grade 12 Students:

• Primary Test Date: Wednesday, Oct. 14, 2020

• Makeup Test Date: Wednesday, Oct. 28, 2020

• Accommodations Test Window: Oct. 14-27, 2020

**IMPORTANT**: Schools that were scheduled to participate in spring 2020 (/Documents/SAT-PSAT-Test-Sites-2020.pdf) are required to offer the ISBE-provided fall 2020 SAT with Essay to their grade 12 students who choose to participate.

More details, including ordering processes and deadlines, about the ISBE-provided fall 2020 SAT with Essay will be available on the ISBE SAT webpage (http://www.isbe.net/Pages/sat-psat.aspx). A frequently asked questions document (http://www.isbe.net/Documents/Fall-SAT-Essay-FAQ.pdf) is now available.

ISBE will not provide any fall 2020 testing for PSAT-related assessments (i.e., PSAT 8/9 and PSAT/NMSQT). However, ISBE will provide PSAT 8/9 for grade 9 and PSAT 10 for grade 10 in spring 2021, as previously communicated in the State Assessment Dates 2020-21 document (http://www.isbe.net/Documents/State-Assessment-Dates-2020-21.pdf).

#### UPCOMING WEBINAR: THE KIDS ASSESSMENT POST-COVID-19 - LOCAL PERSPECTIVES

Children beginning kindergarten this fall will have experienced varying degrees of disruption, differing access to technology, and increased levels of stress and trauma due to the COVID-19 pandemic. High-quality early childhood experiences help children build the foundational skills needed to enter school ready to learn; however, this year's incoming kindergarteners will have been away from their teachers and peers for over five months when school begins. Identifying children's social-emotional needs and skills when they return to school will be essential.

The Kindergarten Individual Development Survey (KIDS) is an observationally based assessment that allows teachers to document student's abilities across multiple areas of growth, defined by the state's learning standards. KIDS helps teachers and families understand where gaps exist, and what supports or resources are needed to support each child based on individual strengths and challenges.

Please join the Ounce of Prevention Fund, ISBE, the McCormick Foundation, the Stone Foundation, and Advance Illinois for a virtual discussion exploring the benefits of KIDS for strengthening kindergarten entry this year. #### REMINDER: CTE LOCAL NEEDS ASSESSMENT DEADLINES

Now that we are in Phase 3 of the Governor's Restore Illinois plan, school districts with career and technical education (CTE) programs and Education for Employment (EFE) system directors may proceed with the Local and Comprehensive Local Needs Assessments (CLNA). ISBE strongly recommends virtual meetings, as opposed to in-person, to complete the requirements of the CLNA process.

We know it has been a busy and tumultuous three months since we last engaged in this work, so if you need a refresher on the expectations for the needs assessment, please see this recorded CLNA webinar (https://attendee.gotowebinar.com/recording/2814776558860474370).

School districts must complete their program data review and finalize their Local Needs Assessment by July 15 at the latest.

Once school districts have completed their needs assessment, the **EFE system** CLNA should be finalized by **Aug. 15 at the latest**. EFEs must submit the Consolidated Application Assurance Document (/Documents/Sec-Postsec-CLNA-Assurance-Form-24-38.pdf) in the CTE Consolidated Application.

The Local and Comprehensive Local Needs Assessments must be completed prior to submitting your CTE Consolidated Application (local application).

# **EVIDENCE-BASED FUNDING**

### FY 2021 EBF APPROPRIATIONS UPDATE

Governor Pritzker signed Public Act 101 – 0637 into law on June 10, 2020. This public act appropriates school funding for fiscal year 2021. There is no new tier funding provided for FY 2021. All organizational units and specially funded units will receive their Base Funding Minimum, which is equal to their FY 2020 EBF distribution. #### FY 2020 ENGLISH LEARNER EBF EXPENDITURE REPORTING

The EBF law passed on Aug. 31, 2017, requires the Illinois State Board of Education to notify school districts of the total English Learner (EL) funding generated by each district's students. This composite amount of funds includes any EL funds generated under the Base Funding Minimum and Tier Funding. It does not include funding generated by the core investment cost factors of the EBF formula, the money from which also benefits ELs. View the listing of the FY 2020 EL funding totals per district (/\_layouts/Download.aspx? SourceUrl=/Documents/FY2020-Stud-Pop-Fund-Alloc-Full-Calculation.xlsx). Districts were reminded that state funding attributable to ELs was

to be spent on EL services per the requirements of Article 14C of the School Code (http://ilga.gov/legislation/ilcs/ilcs4.asp?

DocName=010500050HArt.+14C&ActID=1005&ChapterID=17&SeqStart=119100000&SeqEnd=120600000). Article 14C also requires that at least 60 percent of EL funds must be spent on instructional costs of ELs (Function 1000).

The FY 2020 EL-EBF expenditure reporting shows where EBF funds attributable to ELs were ultimately spent within each district. The Illinois Advisory Council on Bilingual Education has recommended that *only districts that received \$5,000 or more* in total FY 2020 EL funds be required to submit an expenditure report through the period ending June 30, 2020. Any FY 2019 EL-EBF funds not expended in FY 2019 will appear in the FY 2020 expenditure report.

### **Expenditure Reporting Instructions:**

Districts may now report their total FY 2020 EL-EBF expenditures by logging into the IWAS portal and selecting the Electronic Expenditure Reporting System. Choose Start New Expenditure Report and select 3305 Bilingual Ed – TPI & TBE program from the drop-down list. Select June 30, 2020, on the left side of the screen and click Continue to begin reporting. The Current Year Allotment will reflect the total amount of FY 2020 EL-EBF funding for the district (consisting of EBF Base Funding Minimum attributable to ELs and Tier Funding attributable to ELs) as well as funds not reported not expended from FY 2019.

All districts should report <u>direct costs from July 1, 2019, through June 30, 2020</u>. All FY 2020 EL-EBF expenditure reports are due to ISBE by **July 20**.

# STATE AND FEDERAL JUNE 30 EXPENDITURE REPORTS DUE JULY 20

State and federal expenditure reports for the period ending June 30 are due on or before **July 20**. As you complete these reports, please keep in mind the following:

- Reports must be year-to-date that reflect expenditures from the start date of the project through June 30;
- Expenditures must be reconciled to the general ledger and align to the approved budget;
- Any amount reported in an expenditure account (cell) not budgeted or not within the acceptable expenditure variance will not be accepted.
  - ISBE allows a variance of 10 percent or \$1,000 per an object total, whichever is greater without going over the total budget

#### **Outstanding Obligations**

• An outstanding obligation is any liability for which funds are committed prior to the end of the reporting period (i.e., June 30) for services, contracts, and subawards made that is expected to be paid, usually within 90 days.

**IMPORTANT**: Do not enter a value in Outstanding Obligations on Line 34 of the expenditure report unless it is supported by a purchase order, payroll records, etc., such as:

- July and August payroll costs for teachers and staff on a 12-month payment schedule,
- · Purchase orders for equipment or supplies,
- Personal and contractual services for which final invoice is pending payment./li>

### APPLY FOR EMERGENCY MEAL DISTRIBUTION EQUIPMENT GRANTS

Action For Healthy Kids (https://www.actionforhealthykids.org/) (AFHK) announced the availability of Emergency Meal Distribution Equipment Grants to assist with grab-and-go curbside meal pickups, hot and cold food storage containers, grab-and-go packaging materials, and mobile distribution to families in outlying or rural communities.

The grants are sponsored by ALDI and Cargill. AFHK is working with equipment vendor Hubert to provide selected school districts with equipment credits for \$1,000-\$2,000 per site to purchase equipment to be used now and into the fall.

School districts providing meals during school closures because of the COVID-19 pandemic may apply for as many sites/schools that can use equipment. AFHK will fund as many within a district as possible.

- Applications will be reviewed and awarded on a rolling basis: Applications submitted by Friday of each week will be reviewed and awarded by the following Friday.
- Awarded districts will receive a letter detailing their award with a purchasing code for their Hubert orders, and awarded districts will work with Hubert customer service to order the items needed.
- Deadline: Rolling deadline until all funds are awarded.

The grants have been approved, and the funds are being released. All recipients approved for the FY 2020 Round 1 School Maintenance Project Grants are required to submit a June 30 Quarterly Expenditure Report to comply with GATA requirements. Please note: If your district has not yet started the approved school maintenance project(s) and/or has not expended any funds, please insert \$0.00 to report accordingly.
